WHEREAS The Government of Canada through CIDA provides funding to the Organization in support of the "*Electoral Observation Missions and Policy Reform in the Americas*" project at an estimated cost of five hundred thousand Canadian dollars (Cdn\$500,000), is hereby amended.

Amendment: This amendment no.1 increases the total CIDA contribution by one hundred thousand Canadian dollars (Cdn\$100,000).

Therefore the parties hereto agree on the following:

1. In the **Articles of Arrangement**, in **ARTICLE 2. The Contribution**, under sub-article **2.1**, to REPLACE "five hundred thousand Canadian dollars (CAN\$500,000.00)" WITH "six hundred thousand Canadian dollars (CDN\$600,000.00)".
2. In **ANNEX B - TERMS OF PAYMENT**, under sub-article **1.1 Amount of the Contribution**, to REPLACE "five hundred thousand Canadian dollars (CDN\$500,000.00)" WITH "six hundred thousand Canadian dollars (CDN\$600,000.00)".
3. To REPLACE **ANNEX C - BUDGETARY ESTIMATES** in its entirety WITH the updated **ANNEX C - BUDGETARY ESTIMATES** attached hereto.



The effective date of this amendment will be the most recent of the two dates upon which it was signed on behalf of Her Majesty and the Organization.




