1. Venue and date of the meeting

The International Conference of Ministers of Foreign Affairs and Heads of Specialized National Agencies against the World Drug Problem will be held on Monday 25th and Tuesday 26th June, 2012 at the premises of The Hotel Swissotel, located in the District of San Isidro, Lima, Republic of Peru.

3. Accomodation¹

The Government of Peru shall bear the cost of accommodation for the Ministers of Foreign Affairs and Heads of Specialized National Agencies against the World Drug Problem or the Minister of State in charge of the subject, for the nights of 24th and 25th June, 2012.

In the case of the Ministers of Foreign Affairs and Heads of National Specialized Agencies against World Drug Problem, or the Minister of State in charge of the subject who will participate in the meeting of Informal Consultations on the Drug Problem entrusted to the Organization of American States (OAS) in the framework of the VI Summit of the Americas. that took place in Cartagena, to be held in the afternoon of June 26th, at the Hotel Meliá Lima, the Government of Peru shall also bear the costs of accommodation for that night.

Foreign passengers who do not reside in Peru are exempt of 18% VAT only in accommodation and food according to Law, with the presentation of their passport and an official identification document issued by the country of courrent residence, which verifies their residence outside Peru (Alien Registration Card or Resident Visa), accompanied by their migration card. Should passengers fail to file required documents, they shall assume the payment of 18% VAT.

4. Registration:

With the data provided, a registration card will be issued and delivered to delegates along with the material of the meeting during **registration of participants** on Sunday June 24th between 16.00 and 21.00 hours, and on Monday June 25th between 07.00 hours until 08.00 hours in the premises of the Hotel Swissotel. For security reasons, delegates should carry this identification throughout the event.

5. Useful infomation

a) Requirements for entry into the country

Delegates requiring visas to enter Peru, according to the list of visa information presented in Appendix 2, shall apply at the Embassy or Consulate of Peru in their country or place of residence.

The Government of Peru shall extend a visa at entering the country ONLY for those delegates from countries where there is no Embassy or Consulate of Peru. In such case, we will appreciate to send the following information to these e-mails: cportillo@rree.gob.pe and cdelascasasc@rree.gob.pe

- Delegate full name.
- -Number and type of passport.
- Passport issue and expiration date.
- Arrival date and flight.
- Hotel where delegate will be staying at during conference days.
- Number of days that the delegate will stay in Peru.
- In case the delegate wants to visits other cities besides Lima, please indicate them.

b) Weather

The temperature in June ranges between 13°C and 19°C and relative humidity is about 90%.

c) Transportation

In order to facilitate the transfer of delegates, the Government of Peru will provide transportation from Jorge Chávez International Airport in Lima to their respective hotels. For that reason, it is necessary to forward **the registration form (Appendix 1)**, duly filled to the e-mail addresses listed in it.

In case there are changes in the arrival schedule once the registration has been made, we will appreciate to communicate it to the following e-mail addresses: jdelpozo@devida.gob.pe and jdelpozo@devida.gob.pe.

If delegates choose to be transferred alone, it is advisable to use only authorized taxi services from Jorge Chávez International Airport in Lima that are located at the exit of the international area within the premises of the airport.

For transfers to the venue of the Conference, delegates who choose to stay in hotels indicated in section 3 of this bulletin different from the Hotel Swissotel, will have a shuttle bus to transport them.

In case delegates require to go downtown, for security reasons, it is advisable to use only authorized radio taxi services, which can be contacted at the reception of the hotel.

d) Official airport arrivals

In case Ministers, Heads of National Specialized Agencies against the World Drug Problem or the Minister of State in charge of the subject and their delegations arrive to Peru using their government official aircraft, it will be necessary to require authorization through diplomatic channel, by diplomatic Note addressed to the Directorate for Air and Space Affairs of the Ministry of Foreign Affairs of Peru.

e) Electricity

Electrical current in Peru is 220 volts.

f) Currency

The currency of Peru is the *Nuevo Sol*, whose exchange rate fluctuates between about 2.5 and 2.6 *Nuevos Soles* per U.S. dollar. Credit cards of international circulation are accepted in most commercial establishments.

g) Security

1. The Government of Peru will provide all necessary security measures to delegates attending the Conference, both in the venue and the places of accommodation indicated in section 3.

If Ministers of Foreign Affairs, Heads of National Specialized Agencies against the World Drug Problem or the Minister of State in charge of the subject travel with security officers carrying weapons, they require a special authorization for its temporary entry. Such authorization is granted by the General Directorate for Security Services Control, Control of Arms, Ammunition and Explosives for Civil Use, for which the corresponding request should be made through diplomatic channel, by diplomatic Note addressed to addressed to the Directorate for Drug Control of the Ministry of Foreign Affairs of Peru, stating:

- Name and title of the person carrying the weapon.
- Type of weapon.
- Trademark.
- Serial Number.
- Caliber.
- Number of ammunitions to enter.
- As a basic security measure, unauthorized taxis should be avoided.
