BIDAL Project

- CICAD's Hemispheric Drug Strategy, principle 45: National entities responsible for the management and disposition of assets seized and/or forfeited in cases of illicit drug trafficking, money laundering, and other related crimes should be established or strengthened, as appropriate.
- BIDAL Project: Since 2008 improves and develops National Agencies for Asset Investigations, Asset Management and Sharing of seized and forfeited assets in the participating countries, through legislative proposals and regulations necessary for the development of these systems through the establishment of standards of good governance and administrative transparency.
