# Implementation of the Drug Treatment Court Pilot Project – Trinidad and Tobago

- CICAD Regular Sessions:
  - CICAD 46 Trinidad and Tobago delegation viewed the operation of the Dade County Miami Drug Treatment Court
  - CICAD 48 Trinidad and Tobago delegation expressed interest in participating in the Drug Treatment Courts In the Americas project
    - Also supported by the CARICOM Secretariat and delegations of Jamaica, Barbados and the Bahamas.
  - CICAD 50 Trinidad and Tobago delegation supported the position of the panel for ongoing development of DTC's in the Caribbean

## October 2011 DTC Workshop

- DTC Workshop hosted in Port of Spain –
   Participants from Jamaica and Bahamas
- Important outcomes
  - Learn from the Jamaican experience
  - Sensitization to a wide cross section of partner agencies
  - Media exposure of the concept
  - Commitment to establish a Steering Committee
  - Commitment by the OAS / CICAD and the Canadian DTC training team to assist

#### Work of the Committee

- Development of a policy document that addressed:
  - The appropriate court for DTCs
  - Charges to be considered
  - Process for operation of the court
  - Composition and identification of the DTC team
  - Location of the DTC pilot sites
  - Development of testing protocols
  - Development of the Juvenile component
  - Cost of establishment and operations of the court
  - Identification of support services
  - Drafting of legislation to create DTCs

#### **Additional Considerations**

The Committee considered how to resource the DTC: Decisions:

- Redeployment of existing resources
  - Identification of a court room
  - Utilization of existing staff from stakeholder agencies
  - Utilization of existing services from stakeholder agencies
- DTC to proceed on a pilot basis without legislation
  - Existing legislation to provide statutory basis for the DTC pilot
  - Existing criminal practice and procedure to provide the basis for the DTC pilot

# Launch of the DTC - September 11, 2012







