Objective:

Address some of the key elements found in the Hemispheric Drug Strategy and the recent OAS Report on the Drug Problem in the Americas. The Hemispheric Strategy introduced the need to respect human rights as the basis of any policy or action related to drugs, as well as the need to consider the social integration process as a necessary part in the recovery of a drug-dependent individual. Furthermore, the recent OAS Drug Report, particularly its study on Drugs and Development, reminds us that "a vicious circle in regard to exclusion hampers the prospects of resilience and social reintegration. The stigma of drug addiction or a criminal record for drug-related offenses negatively impacts access to employment, social and public benefits.

Questions:

- a. Given these two references, what are member states are doing to improve social integration options of individuals?
- b. From the point of view of the laws of the countries, to what extent do legal frameworks allow this integration?
- c. What can we do to ensure that social integration (for drug dependent offenders and drug law offenders) is a real part (i.e. properly funded) of the drug strategy of countries? What resistance could be encountered?

<u>Objective</u>: Identify the possibility of effective and sustainable alternatives that are being implemented or could be implemented in member countries to prevent the arrest and detention and reduce the number of individuals that end up in prison for drug-related offenses.

Questions:

- a. Bearing in mind the different trends in drug laws, do you consider that your country is ready to take on the institutional and legal changes, to differentiate among different scenarios relevant to crimes associated with drug trafficking?
- b. Is it possible to have the judicial system recognize that the non-problematic use should not be penalized or judged? At the same time can national treatment systems treat users who suffer from drug dependency?
- c. Bearing in mind that in many countries there is a large number of arrests and incarcerations associated with micro traffic or low level dealing. Is it possible to provide alternatives to incarceration for micro traffickers or low level dealers?
- d. To what extend are our member states exploring different alternatives to incarceration for drug dependent offenders?
