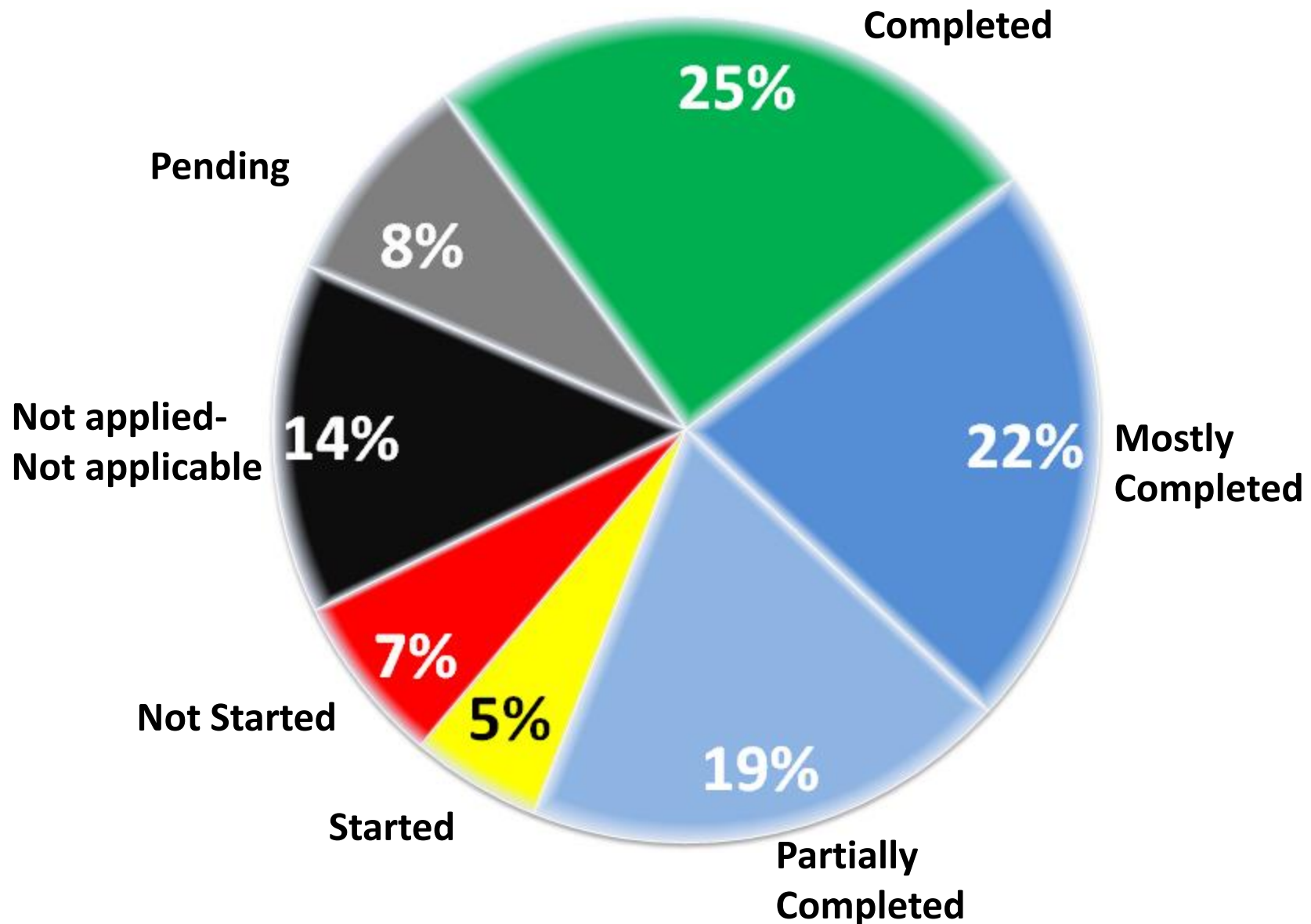

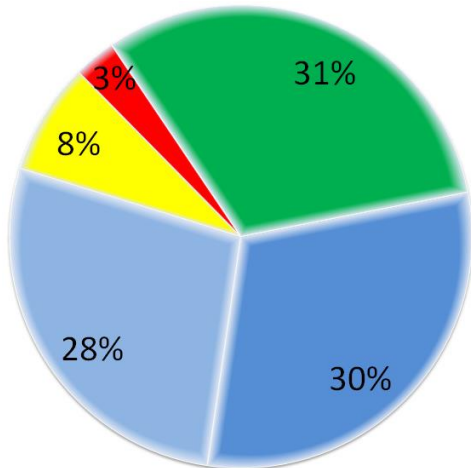

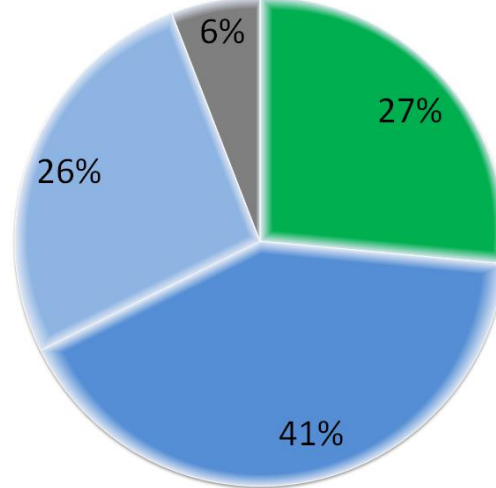

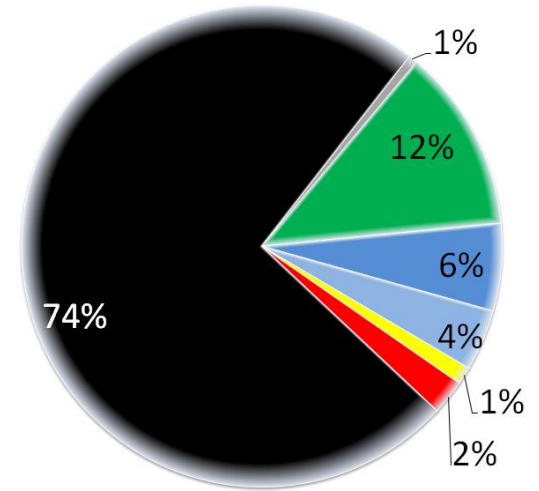

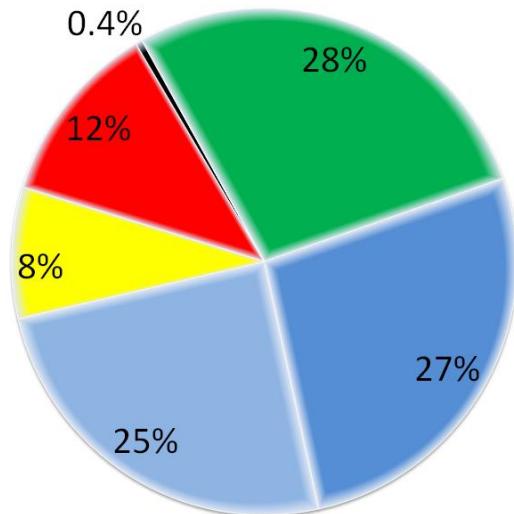

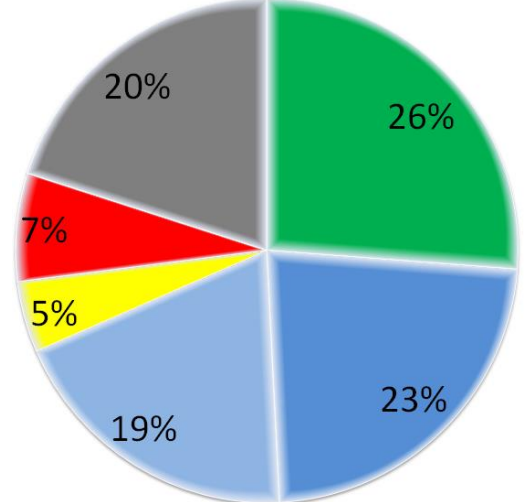
**Supply Reduction**

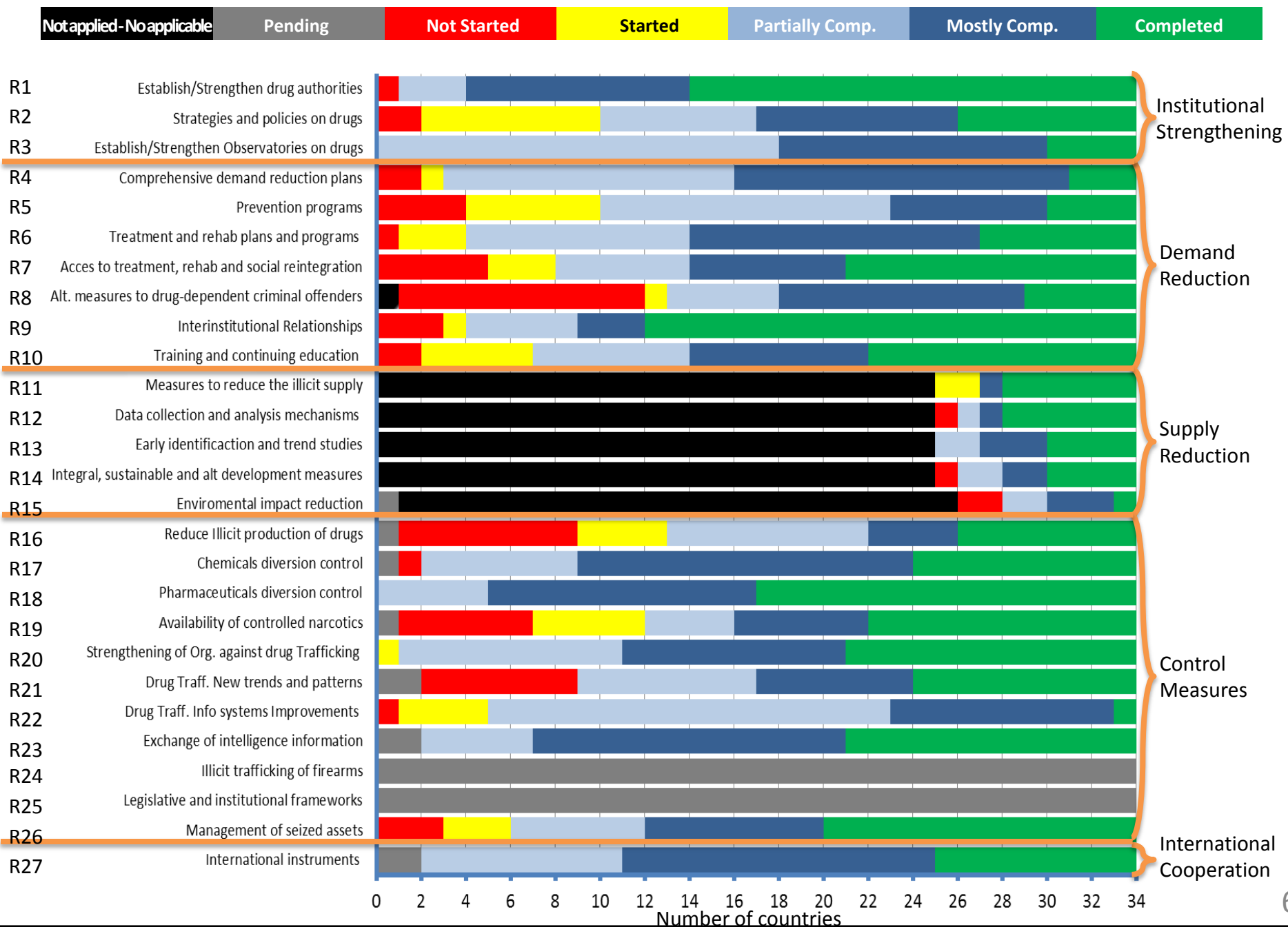

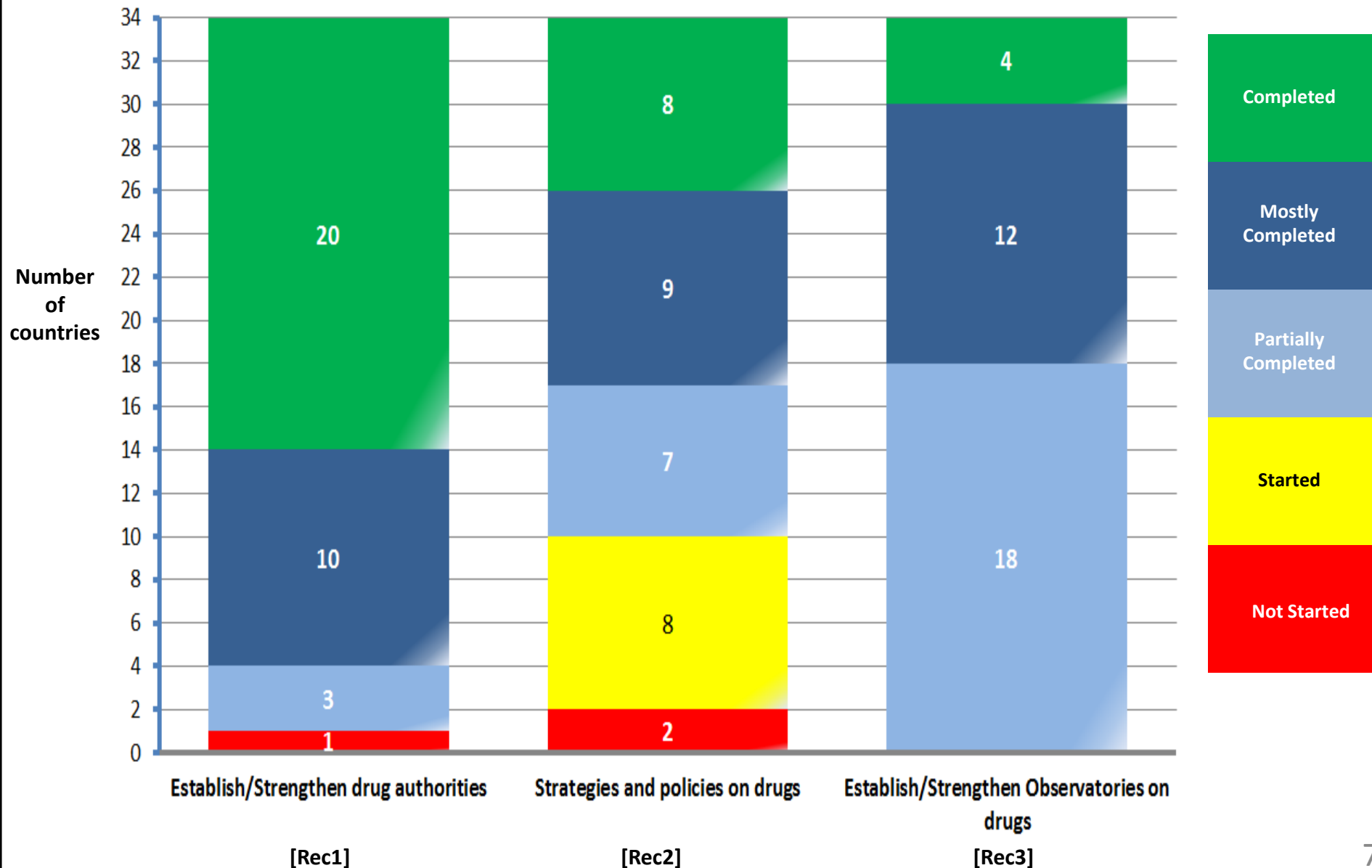

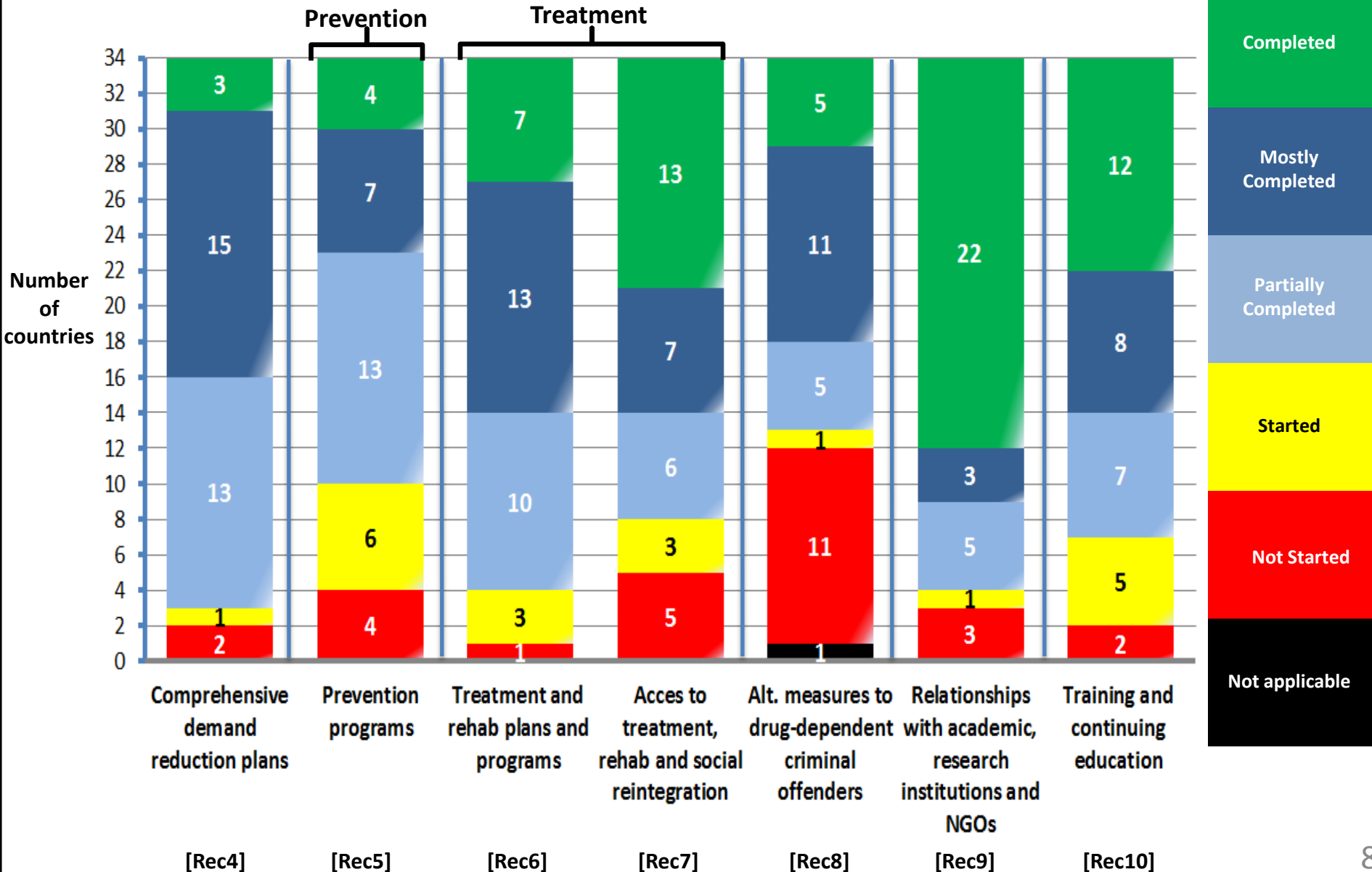

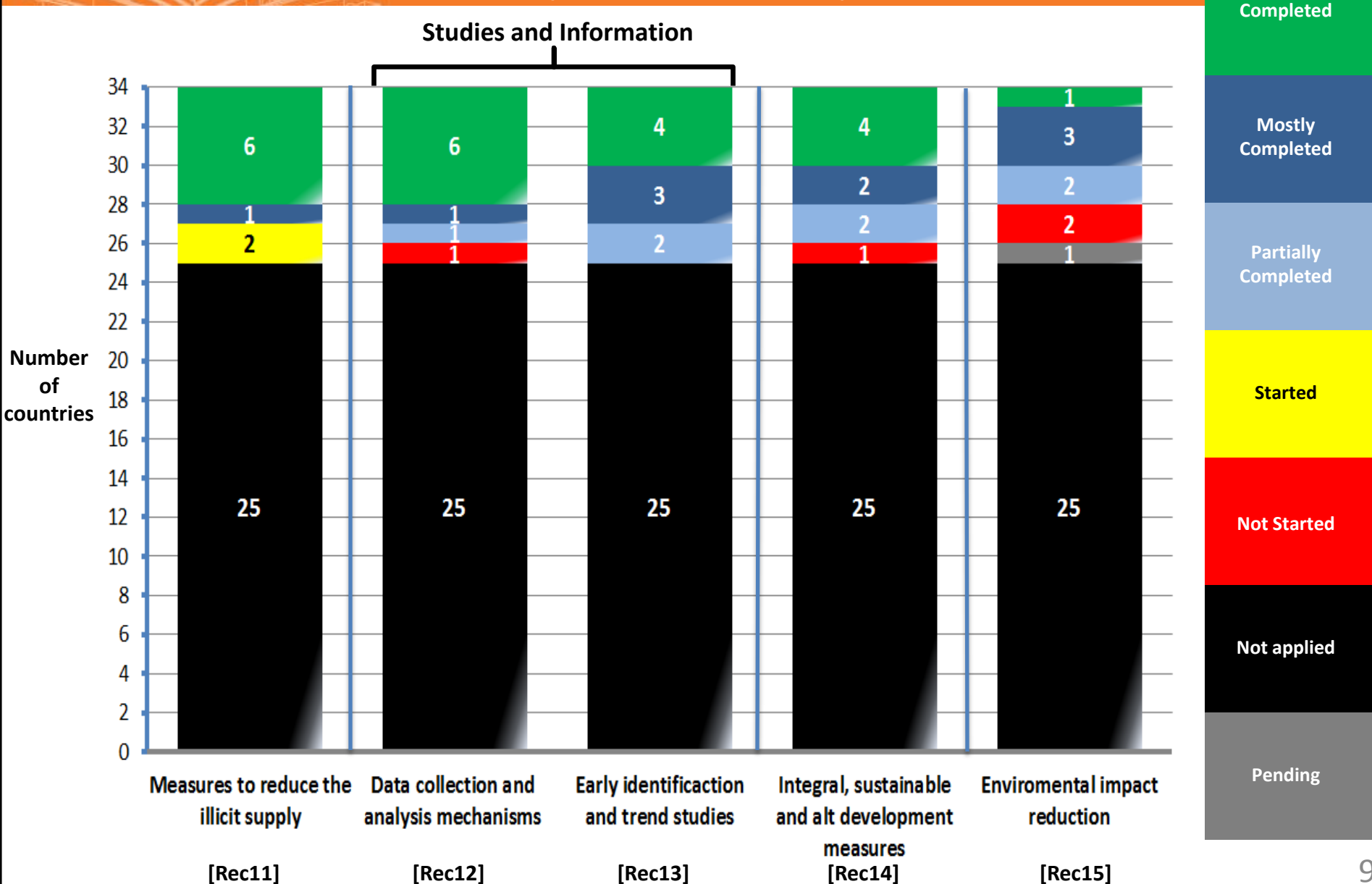

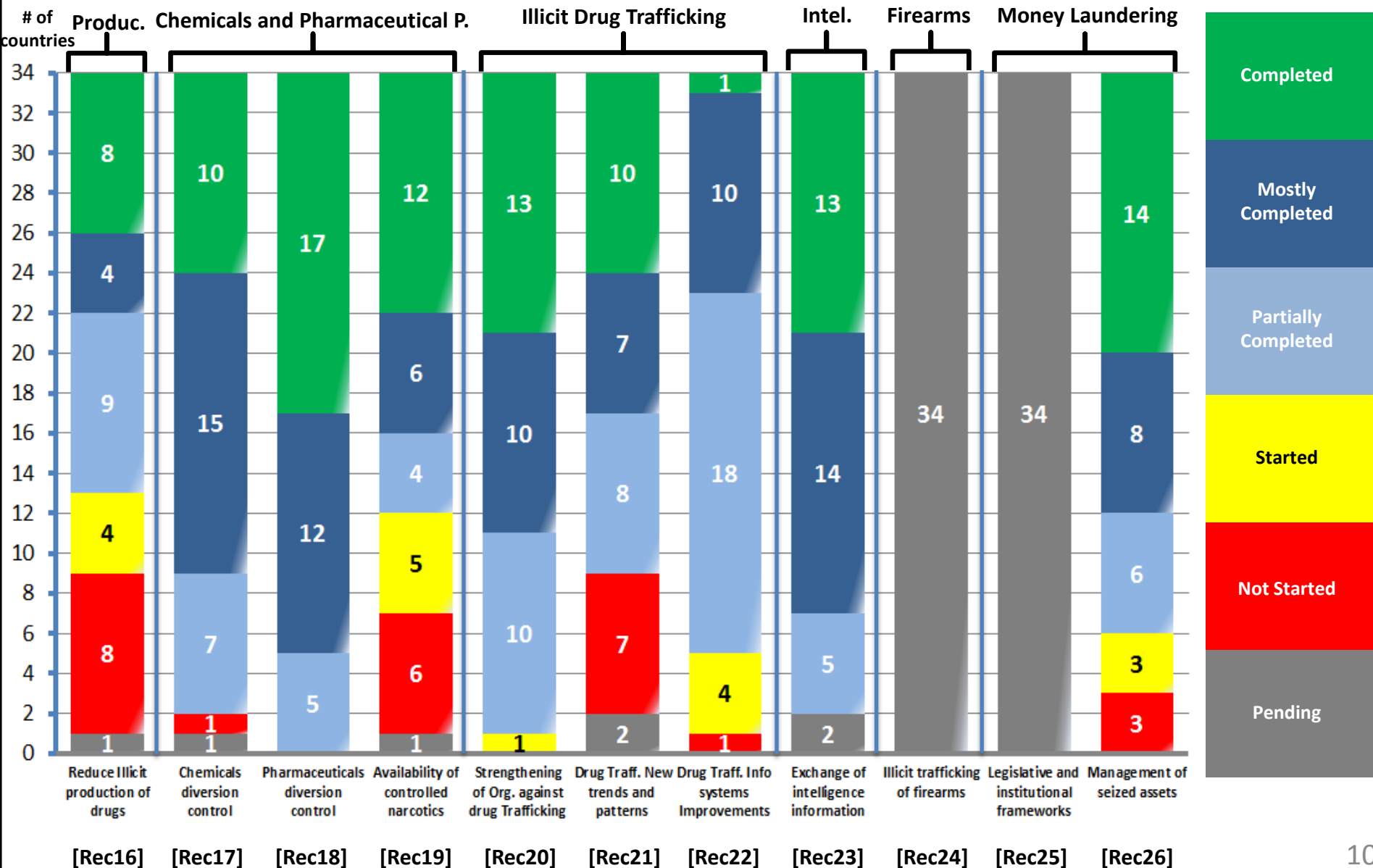

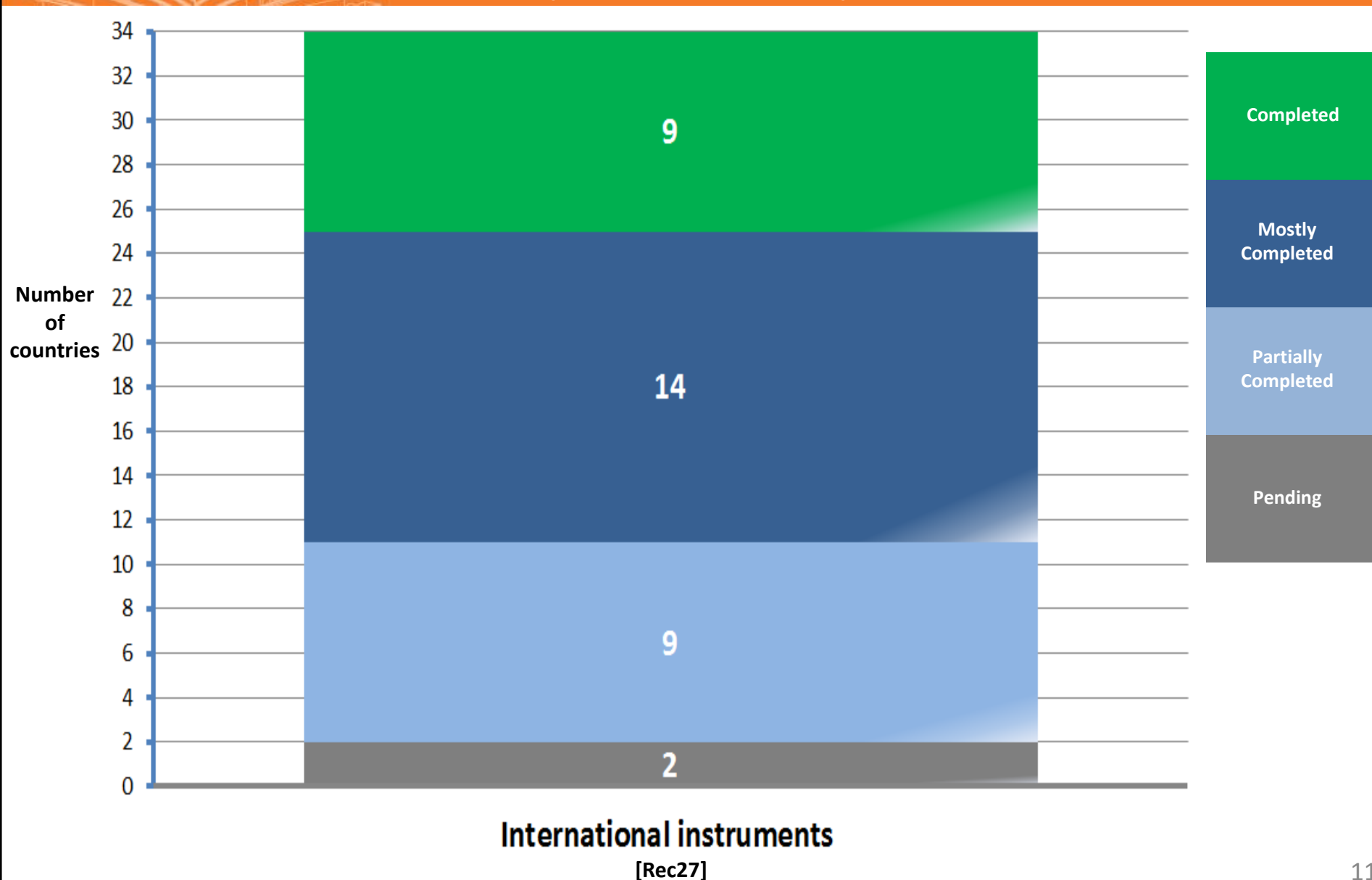

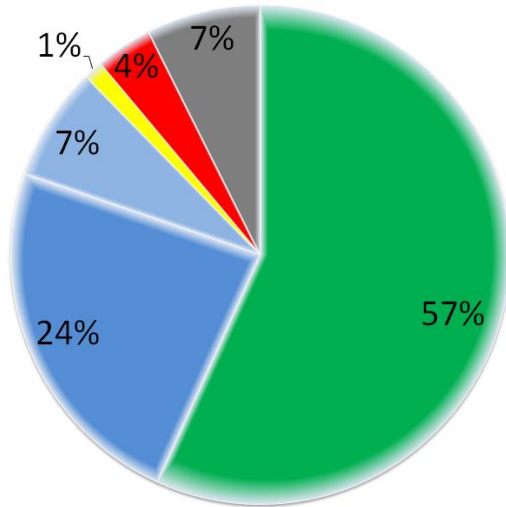

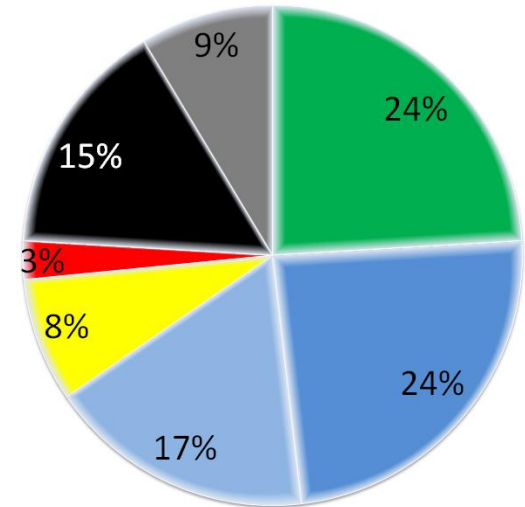

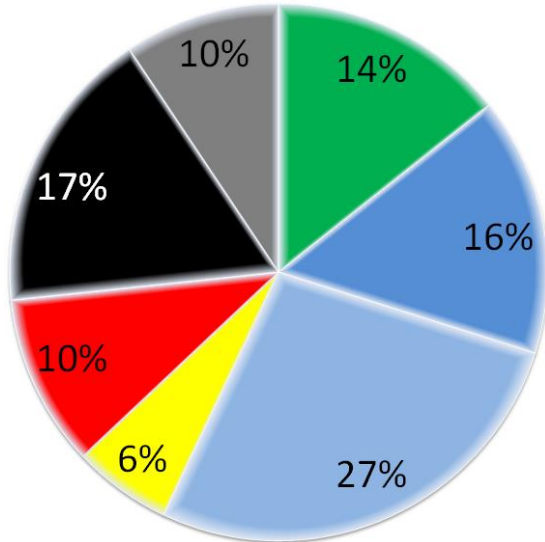

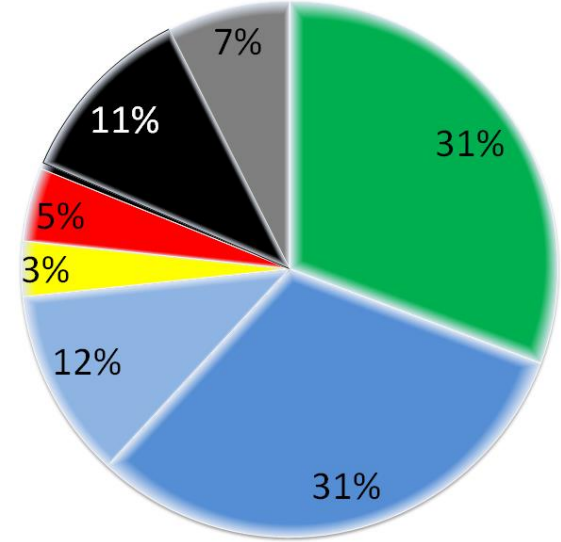

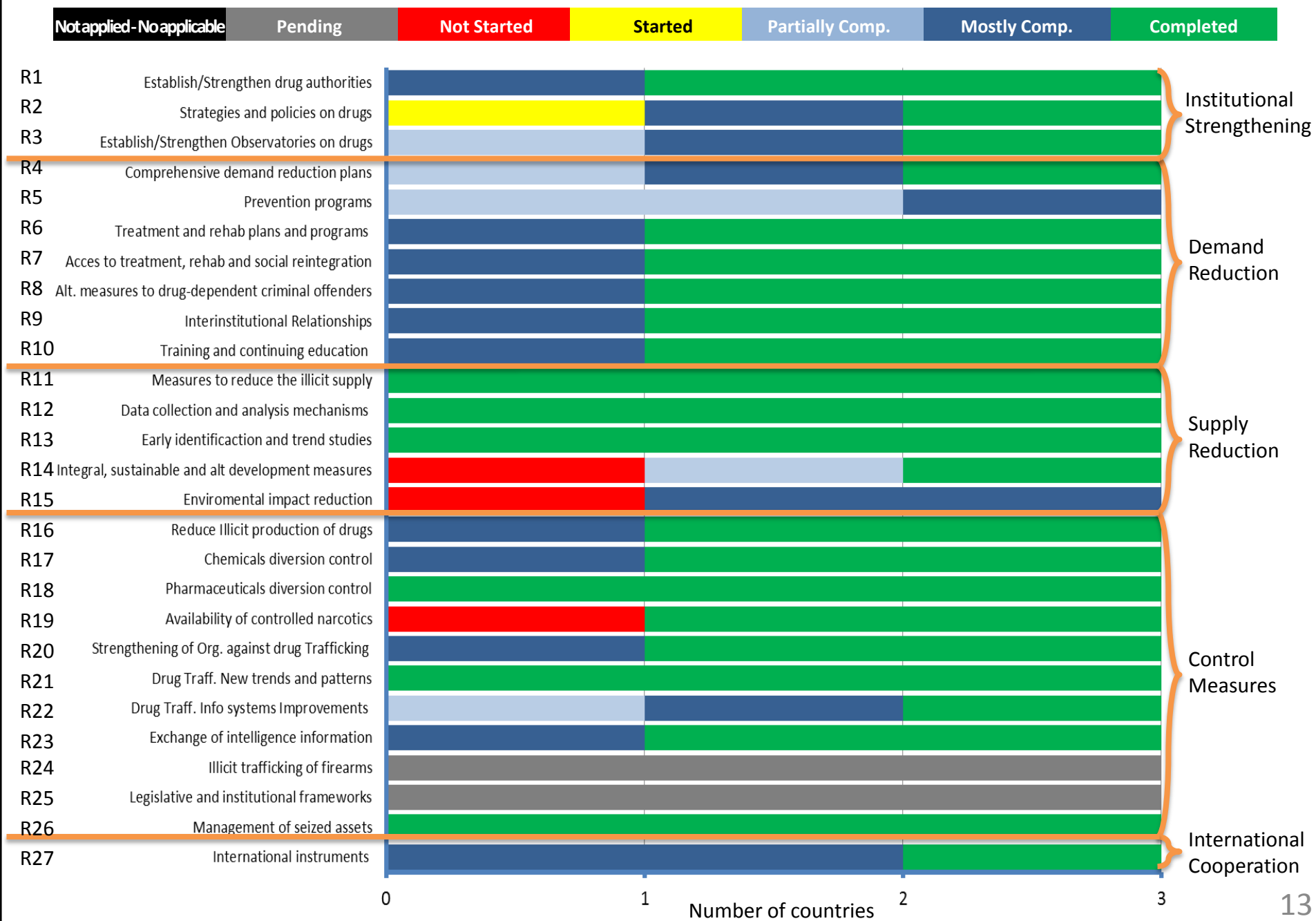

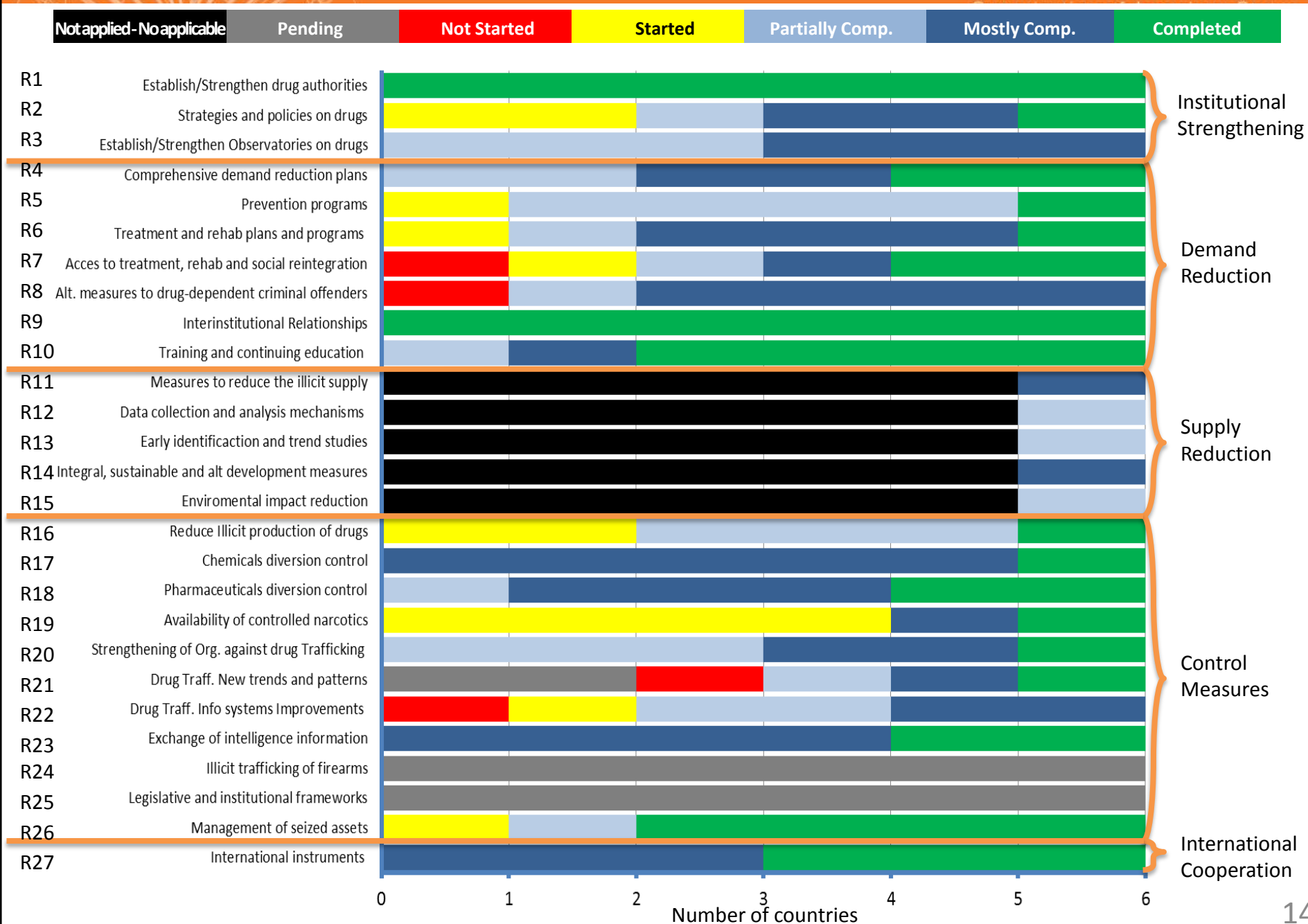

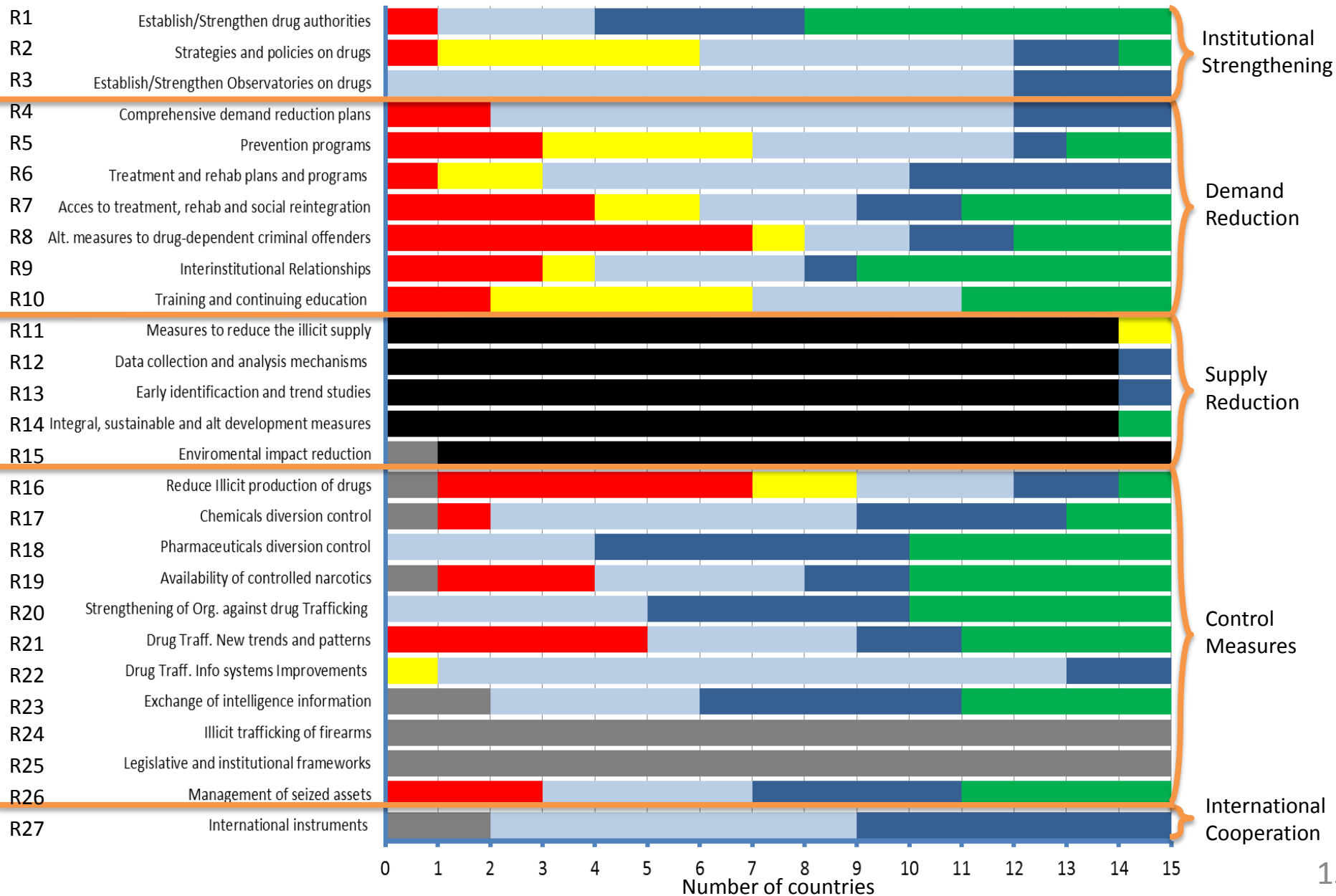

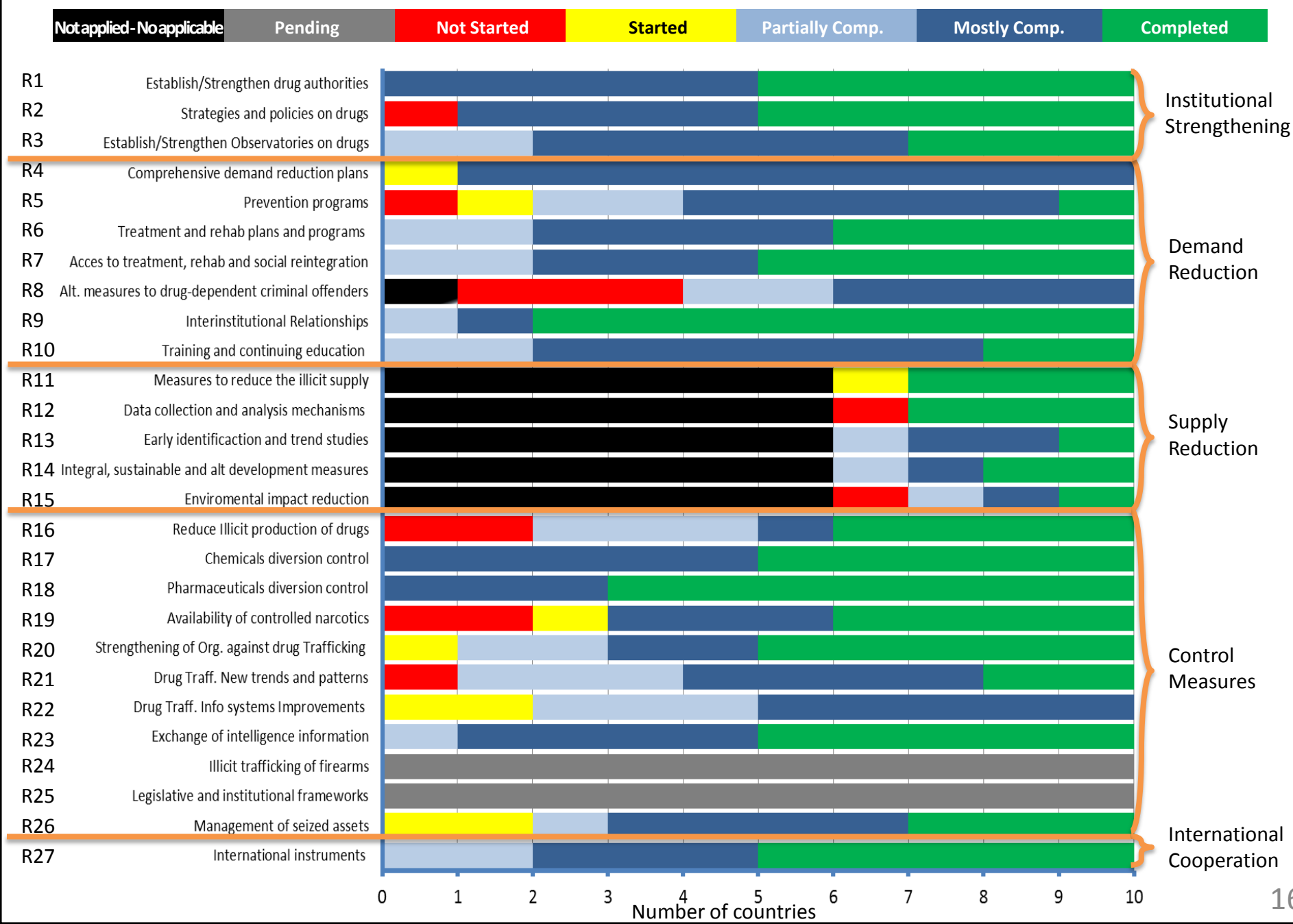
