**Briefing:** In 2003 the CICAD Commission requested the creation of a working group to prepare the hemispheric study.

During the 2013 meeting, need to conduct a new study with a prospective approach given that most of the recommendations made in 2003 were met and that there are new challenges in the use of the seas, rivers, lakes and ports for drug trafficking.

Two working groups were formed to begin the process of identifying how to assess the current state of maritime narcotrafficking in the hemisphere and how this might evolve and how to determine the capacity of member states to respond to the foregoing.

In June 2014, a special working group meeting was held in Lima, Peru, to draft a questionnaire to collect information from the Member States to assist in the preparation of the new study.
