During the Fifty-fourth Regular Session of the Inter-American Drug Abuse Control Commission (CICAD) — which took place in December, 2013 in Bogota — Colombia, who assumed the presidency, requested the Executive Secretariat of CICAD that a Working Group be created and charged with setting forth different alternatives to incarceration for drug-related offenses. During the Fifty-fifth Regular Session of CICAD — which took place in April, 2014 in Washington — the Commissioners approved in plenary the creation of this Group.

The Working Group is comprised of experts designated by the Member States and is supported by a Technical Support Group. The government of Colombia is in charge of the coordination of the Group and the Ministry of Justice and Law directs the Technical Secretariat, which is supported by a "Legal Technical Leader." In fulfilling its mandate, the Technical Support Group is currently producing a Technical Report on "Alternatives to Incarceration," with CICAD's support.

Objective: Encourage a high-level dialogue between OAS Member States on alternatives to incarceration for drug-related offenses
