# BACKGROUND

- The GELAVEX was created in 1990 in accordance with article 22 of the Statute of CICAD and is, therefore, one of the advisory bodies of CICAD
- The GELAVEX is currently formed by two Sub-Working Groups:
  - the Sub-Working Group on **International Cooperation and Forfeiture**; and
  - the Sub-Working Group on **Financial Intelligence Units (FIU) and Law Enforcement Agencies (LEA)**
- Its activities are determined by **strategic plans** that define lines of action and by **work plans** that define concrete actions to be developed in accordance with the previously defined lines of action
- The **Strategic Plan Proposal** for the **2015-2017** period was approved at the fifty-sixth regular session of CICAD and, therefore, serves as a guideline for the future activities of the group between 2015 and 2017.
