

## **Expert Group on Comprehensive and Sustainable Alternative Development**

The ES/CICAD will provide technical support to participating member states in the development of various activities as a follow up to the First Expert Group meeting held in 2016 (Peru).

## **Drug Policies and Strategies**

Provides technical assistance to support the development of a national drug policy and the design and implementation of national drug strategies/plans and actions, supporting development of monitoring and evaluation tools.

#### Estimated Expenditures: US\$ 88,332

Beneficiaries: OAS Member States (particularly the Caribbean during 2017).

**Expected Results:** To continue its training processes, promoting knowledge and the exchange of best practices for drug policymakers and public planners. To provide technical assistance to the Gov. of St. Kitts and Nevis. Together with the OID and MEM support Panama with the evaluation process of its national drug strategy.

# SAVIA (Health and Life in the Americas)

This program, financed and promoted by the Government of Spain, focuses on local drug policies that derive from national strategies and plans implemented in the territories (decentralization), or policies established by guidelines of local governments in response to the drug problem in accordance to their competences. Three projects will be developed: SAVIA III, develops local diagnostic studies, methodologies and good practices in local management; SAVIA IV is focused in Central America, and a new project, defines indicators and tools for the monitoring and evaluation of drug policies at the local level.

#### Estimated Expenditures: US\$ 334,937

**Beneficiaries:** National drug authorities and local governments in El Salvador, Costa Rica, Honduras, Dominican Republic, Guatemala, Nicaragua, Ecuador, Colombia and other Latin American countries

#### **Expected Results:**

- Dissemination of methodologies and good practices of local management on drugs and social integration.
- Training and technical assistance cooperation on programs of prevention, local management, monitoring and evaluation methodologies for local drug policies and development of policies on drugs and social integration, starting from the analysis of proposals and demands received at the local-municipal level, coordinated with the institutions of each country.
- Development and application of criteria and indicators for monitoring and evaluation of decentralized drug policies.
- Drafting a balance report on decentralization and work plan for technical cooperation and training designed jointly with the countries.

# **Alternatives to Incarceration**

Includes all measures such as legal reforms, as well as strategies / programs / policies that support the social integration of drug related offenders, reduce criminal prosecution, limit incarceration in the event of prosecution, and decrease prison time in the event of incarceration. ES/CICAD will support member states with the analysis of several alternatives and the development and implementation of specialized intervention strategies (pre-trial, during trial, and post-trial).

Alternatives to incarceration currently involves three programs: "Closing the Gap" which explores various alternatives; treatment under judicial supervision (example: drug treatment courts, community courts); and "Legislation in the Americas –LEDA", for the exchange of good practices and the collection of member states' legal norms relating to drugs.

#### Estimated Expenditures: US\$ 1,215,406.88

**Beneficiaries:** OAS Member States. Currently working with Argentina, Barbados, Belize, Colombia, Costa Rica, Jamaica, Mexico, Panama, Peru, Dominican Republic, and Trinidad & Tobago

#### Expected Results:

- Provide training and technical assistance (as requested by member states) for multidisciplinary teams in participating countries as well as exchange and study visits between Member States (horizontal cooperation).
- Support the Monitoring and Evaluation process of current Drug Treatment Courts.
- Increased awareness and knowledge by policy makers, media, communities, alternatives to incarceration stakeholders and practitioners of what Juvenile Drug Treatment Courts and Community Courts offer as an alternative to punishment/incarceration. Promote Case Management approaches to tailor specific populations.

# **Demand Reduction Expert Group**

The Demand Reduction Expert Group is the technical-political forum represented by technical experts of the OAS Member States. Its purpose is to provide expertise, facilitate collaboration among countries and make recommendations to the Commission on the implementation of the Hemisphere Drug Strategy.

### Training and Certification MODEL for Drug PROCCER Prevention, Treatment and Rehabilitation (PROCCER)

**PROCCER** seeks to promote optimal standards of care in prevention and substance use disorders treatment services. It also responds to the need to strengthen, disseminate, and institutionalize systematic training in drug abuse research, prevention, and treatment through the establishment of certification mechanisms and the development of effective prevention and treatment models and approaches.

#### Estimated Expenditures: US\$ 460,000

**Beneficiaries:** Antigua & Barbuda, Dominica, Dominican Republic, Jamaica, Mexico, Panama, Paraguay, Saint Lucia and Trinidad & Tobago.

**Expected Results:** 1,080 service providers trained and certified by the Program, adolescent treatment training manual completed, training delivered and certification mechanism established in 3 Caribbean Member States.

# **Supply Reduction Unit**

### Mission

Increase the capacity of member states to address the problems of illicit production and trafficking of drugs and reduce the availability of these substances.



# **Counterdrug Intelligence**

Program to increase the capacity, knowledge and competence of officers from participating member states in specialized techniques related to the development and analysis of counterdrug intelligence enhancing their ability to respond to threats and challenges related to drug trafficking and production.

Regional and national courses and training seminars on strategic, operational and prospective counterdrug intelligence analysis and investigations for member states in Latin America continue under the umbrella of the Counterdrug Intelligence School of the Americas (ERCAIAD). Plans for 2017 in the continued implementation of the Regional Counterdrug Intelligence Training School in Trinidad and Tobago for English-speaking Caribbean member states include a technical assistance mission to the National Police Academy by SE-CICAD and ERCAIAD officials.

#### Estimated expenditure: US\$ 125,000

#### Beneficiaries: OAS Member States

**Expected Results:** Approximately 175 counterdrug intelligence analysts and investigators will receive training and have an increased capacity in the development and analysis of counterdrug intelligence in their efforts to investigate and interdict the illicit production, trafficking and distribution of illicit drugs **Link to HDS and Plan of Action**:

# **Precursor Chemical Control**

Program for officers (police, customs, regulatory, administrative control, chemists, judges, prosecutors and others) from agencies dealing with the control of chemicals to enhance their knowledge and skills in the administrative processes and specialized operational techniques to safely and effectively monitor, investigate, detect and control the diversion of chemicals that can be used to produce illicit drugs.

Group of Experts on Chemical Substances and Pharmaceutical Products

National seminars in precursor chemical diversion control and investigation are planned for Central America and Caribbean member states in 2017.

#### Estimated expenditures: US\$ 75,000

Beneficiaries: Central American and Caribbean member states

**Expected Results:** Approximately 65 precursor chemical control personnel will receive training in diversion investigation, illicit drug production methods, dismantling clandestine labs, and officer safety thereby enhancing their awareness and capacity to effectively apply new investigative and regulatory methods and promote a common approach to controlling illicit chemical production and diversion

## Maritime Narcotrafficking and Border Control

Program for maritime authorities, law enforcement, customs and other agencies working in the maritime domain, land borders, airports and sea ports to increase their knowledge, skills and capacity to monitor, investigate, detect and interdict the movement of illicit drugs and related contraband.

Meeting of the Group of Experts on Maritime Narcotrafficking

Plan for 2017 includes a pilot seminar for legal and operational maritime counterdrug entities to construct a regional cooperative protocol in counterdrug interdiction operations through case studies.

Estimated Expenditures: US\$ 65,000

Beneficiaries: OAS Member States

**Expected Results:** Enhanced bilateral and multilateral counterdrug maritime interdiction cooperation in the region

# **Synthetic Drugs**

Program to increase the awareness of law enforcement and regulatory/administrative officers as well as chemists, prosecutors, judges and others concerned with the control of synthetic drugs - including New Psychoactive Substances (NPS) - regarding this evolving threat and enhance their skills, knowledge and capacity to safely identify, monitor, and interdict the production and trafficking of these drugs and respond to new drugs, production techniques and trafficking methods.

This issue will be addressed extensively at the next meeting of the Group of Experts on Chemical Substances and Pharmaceutical Products with the aim of providing guidance to member states in strengthening legislation, regulations, and policies to control these illicit drugs and the chemicals associated with their manufacture.

#### Estimated Expenditures: US\$ 35,000

Expected Results: Increased awareness of the growing problem of the production, trafficking, distribution and consumption of synthetic drugs and New Psychotropic Substances (NPS), contributing to a decrease in the availability of these drugs in our member states

### **Mission**

The OID is CICAD's scientific research and information branch. Its mission is to help member states better understand, design and implement policies to confront the drug phenomenon in all its forms through the use of scientific information that is objective, reliable, up-to-date, and comparable across countries.

## Drug Information Networks (DINs) Phase 2

The OID is seeking funding for a **new phase** of this program to support DINs among countries in the Hemisphere that need to further develop their human and institutional capacity to manage their networks. The goal is to create self-sustaining national networks that routinely collect and regularly report on drug production, drug consumption, consequences, and policy responses and actions. The information produced by these networks will enhance the monitoring of the drug situation and support national drug policies.

## Inter-American Drug Use Data System (SIDUC)

### **Educational Development:** International Research Capacity-Building Program for Health-Related Professionals to Study the Drug Phenomenon

This program is an initiative of the ES/CICAD, in partnership with the Centre for Addiction and Mental Health (CAMH)-Toronto, Canada (2006). This is a multidisciplinary curriculum that has trained over 100 health-related professionals from 20 countries in Latin America and the Caribbean.

The cohort from 2015/2016 will finish their research studies in May 2017, and publish their final reports and scientific articles.

The OID is seeking to create a Spanish language version of this same training.

# Program on New Psychoactive Substances (NPS)

## Multilateral Evaluation Mechanism (MEM)

### **Mission**

Provides ongoing technical and managerial support in designing, reviewing and executing CICAD's multilateral drug policy evaluation process. Guides the OAS Member States in the process of measuring progress and compliance to confront the drug problem in line with the Hemispheric Drug Strategy and its Plan of Action, 2016 - 2020.



### MEM Process – 2017

The MEM process initiates with the Inter-Governmental Working Group (IWG) streamlining the MEM Evaluation Instrument and its corresponding documents. Thereafter, the MEM conducts its evaluation process via the Governmental Expert Group (GEG) for the 34 countries resulting in national reports and a hemispheric report.

Feb 2017 - the IWG started working via a series of 3 drafting phases, that include 21 online and in-person meetings to have final draft documents of the Instrument by Sept 2017.

Estimated Expenditure: US\$792,705

Beneficiaries: OAS Member States

## MEM Process – Expected Results - 2017

- July September, 2017: Procedural Manual and Schedule of Activities for the MEM 7<sup>th</sup> Round are reviewed and agreed to.
- November, 2017: CICAD 62 approves all components (Evaluation Ouestionnaire, Evaluator's Manual, Procedural Manual & Schedule of Activities) of the MEM 7<sup>th</sup> Round Evaluation Instrument.
- **2018:** MEM 7<sup>th</sup> Evaluation Round starts.
