

COSTA RICAN JUVENILE JUSTICE


Juvenile Criminal Justice Law (LJPJ). N° 7576 of 1996.



PRECEDENT FOR ALTERNATIVE SENTENCE

Article 132 LJPJ.

- a) Efforts to repair the damage done.
- a) Low level of harm or injury.
- b) Opportunity for educational or work development.
- Social and family situation.
- b) Formulate an alternative life proyect.

MINORS WITH CRIMES LINKED TO CONSUMPTION

Survey on Drug Use of Young People with Cases in Juvenile Criminal Courts. Costa Rica. 2016.

- □ 62% consumed alcohol.
- □ 57% consumed marihuana.
- □ 24% consumed cocaine.
- □ 14% consumed ketamine.
- □ 12% consumed LSD.

Recommendations to reduce crime associated with drug use:


- Comprehensive treatment programs.
