 DRUG TREATMENT IS THE PROCESSES USING MEDICAL AND/OR PSYCHOTHERAPEUTIC INTERVENTIONS FOR DEPENDENCY ON PSYCHOACTIVE SUBSTANCES SUCH AS ALCOHOL, PRESCRIPTION DRUGS, AND STREET DRUGS
