#### How is in-country coordination progressing?

Efforts to coordinate the collection of this data on a monthly basis continues to be a challenge

### What is your experience using the intake form?

- Date of Admission: Outpatient programme does not record a date of admission. If the same client enrolls in the residential programme a new form is filled out.
- Have you ever been deported?: Clients are concerned about reporting their deportation status.
- **Ethnicity**: Clients take for granted that ethnicity can be determined by sight although they self identify differently.
- Marital Status: Clients are not clear on categorizations.
- Who do you live with?: Clients are not clear on categorizations.
- Main & Secondary substances: Clients often cannot differentiate between main and secondary substance.

### What is your experience using the Epi-Info data entry software?

► Epi-Info data entry has been proceeding smoothly without any major issues

### What are the barriers or challenges you face if any?

- Lack of staff for proper coordination, collection of data and data entry
- Stakeholder's lack of staff
- Stakeholder uses its own intake form and views the standardised data collection form as additional work
- Some sites turn in forms on an inconsistent basis
- Sometimes fields are still filled in incorrectly

## THE IMPORTANCE OF CONNECTING THE TREATMENT INFORMATION TO THE DIN IN TRINIDAD

To bridge the gaps in the data that is currently available; for example:

- To determine where outreach activities should be undertaken or to determine the impact of outreach activities in particular areas
- ► To be able to analyse the data in connection with arrests, charges, seizures and eradication exercises, taking into account:
  - Sex
  - Age
  - Address
  - Nationality
  - Substance of Use
  - Judicial Information
