

THE PHENOMENON IN COLOMBIA






Although sold as LSD, paper doses are infused with a stronger substance known as 251-NBOMe, "the bomb". This is a lucrative criminal alternative, which directly affects consumer health.

THERE IS NO EVIDENCE IN THE COUNTRY OF ILLICIT MANUFACTURING OF SUBSTANCES, OR TRAFFICKING OF ITS PRECURSORS

2013 National Study of Psychoactive Substances Consumption



The 2013 National School Population Survey showed, for the first time that 2.2% of this population had consumed Ecstasy.


Of the 21 consumed substances detected, 7 are NPS drugs (33%).

According to recent consumer studies, university population shows higher levels of abuse of this type of synthetic psychoactive substance, compared to other Andean Community countries.

Hallucinogenic drugs, such as LSD, are second only to marihuana in illicit drugs prevalence, higher than cocaine.

First consumption data of other synthetic substances such as methamphetamines, GHB and ketamine.







Characteritics

Manufacturing of synthetic drugs presents great advantages to organizations dedicated to its production and trafficking:

- It does not require big infrastructure.
- It does not require products of natural origin, but rather chemical compounds and molecular alternations.





- + 200,000 users worldwide.
- + 40,000 sellers offering illegal products in these websites.
- + **350,000** products
- + **250,00** drug listings, synthetic NSP and toxic chemicals
- + 100,00 listings of stolen travel documents

Between **30,000** and **80,000** criminal sites identified worldwide.

Criminal structures and sale methods (from home, social networks, and "DEEP WEB")

- Covered agents.
- Controlled deliveries.



IMPORTANCE OF TECHNICAL EVIDENCE

Seizure of **22,500** (9,000 gr) "amphetamine" pills. Chromatographic analysis in chemical laboratory showed prevalence of ibuprofen with some coloring. These pills were transported via mail.

Approximately 20 NPS have been detected in Colombia, most of them of synthetic origin. Many are sold as known substances. Studies to LSD samples show prevalence of NBOME.

•The substance identifies as fenetilamine or 25I-NBOMe is a hallucinogenic drug from the "tucibi" family, which causes "mental and physical stimulation". This Drug is known in Colombia as a party drug of the upper class.
