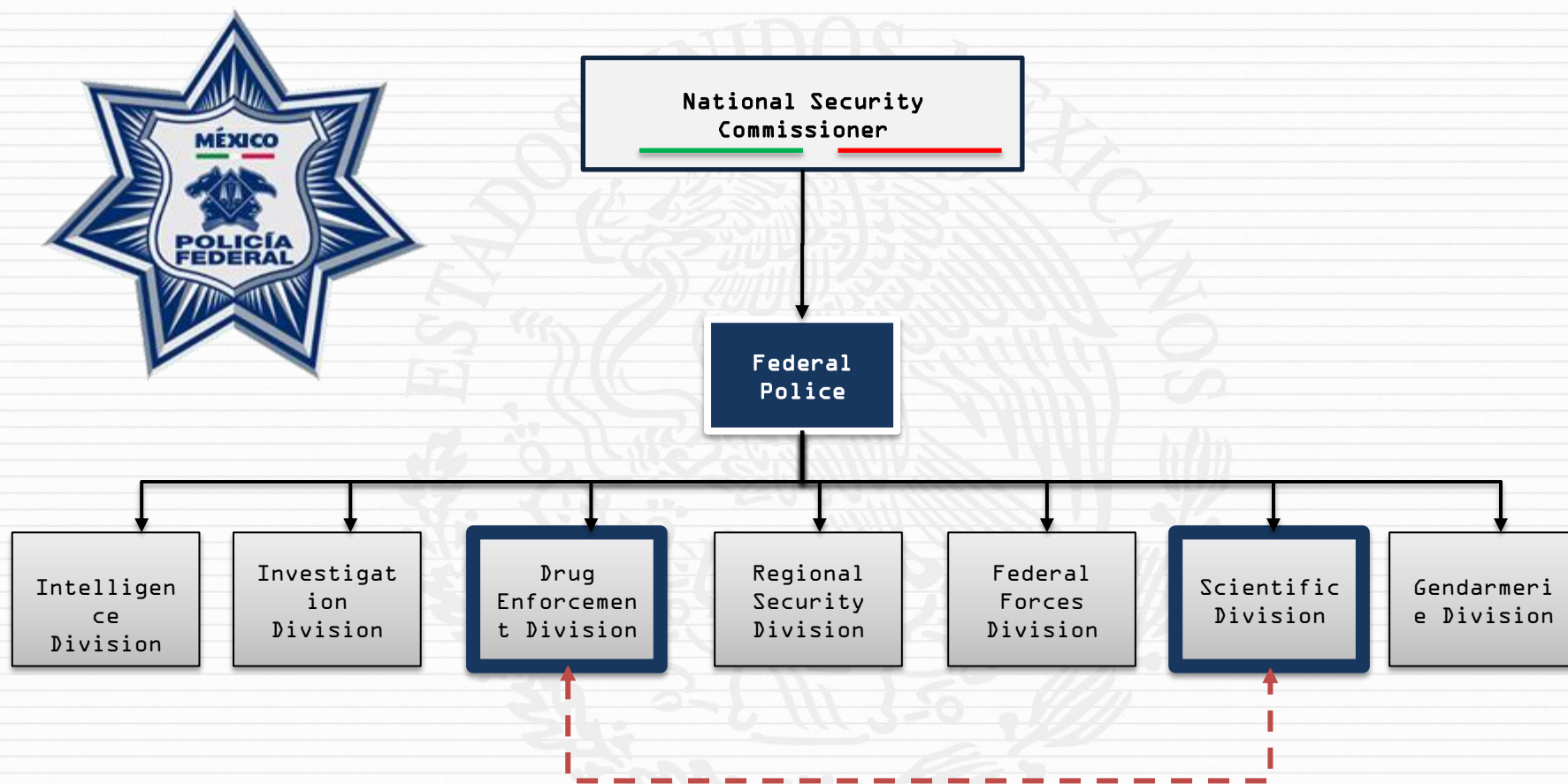

General Health Law

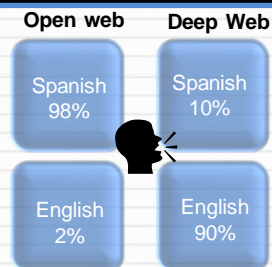

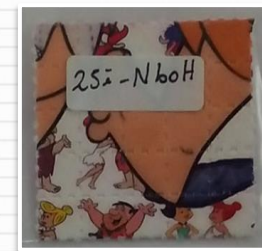
Proceso de compra.

Considerations

Challenges

- Fast development, proliferation and diversification in the market
- Why the consumption of NPS? Low perception of risk / perception of legality
- The purchase via web is simple and visible; once regulated they could move to the Dark Web
- Smaller dosages, which makes it difficult to detect
- The regulation / prohibition of an NPS motivates to create a new one, which can be more powerful
- Generate an adequate regulation
- Reference standards
- New production, traffic and commercialization dynamics

Actions

- Comprehensive attention between regulatory and security institutions, NGOs and multilateral organizations
- Appropriate regulation for each country
- Specific prevention campaigns
- Continuous diagnostics (substance analysis / availability / usage trends)
- Permanent patrols in the network
- New forms of research
- Include NPS in drug use surveys
- Analysis of its real composition and identification of its adverse and toxicological effects
