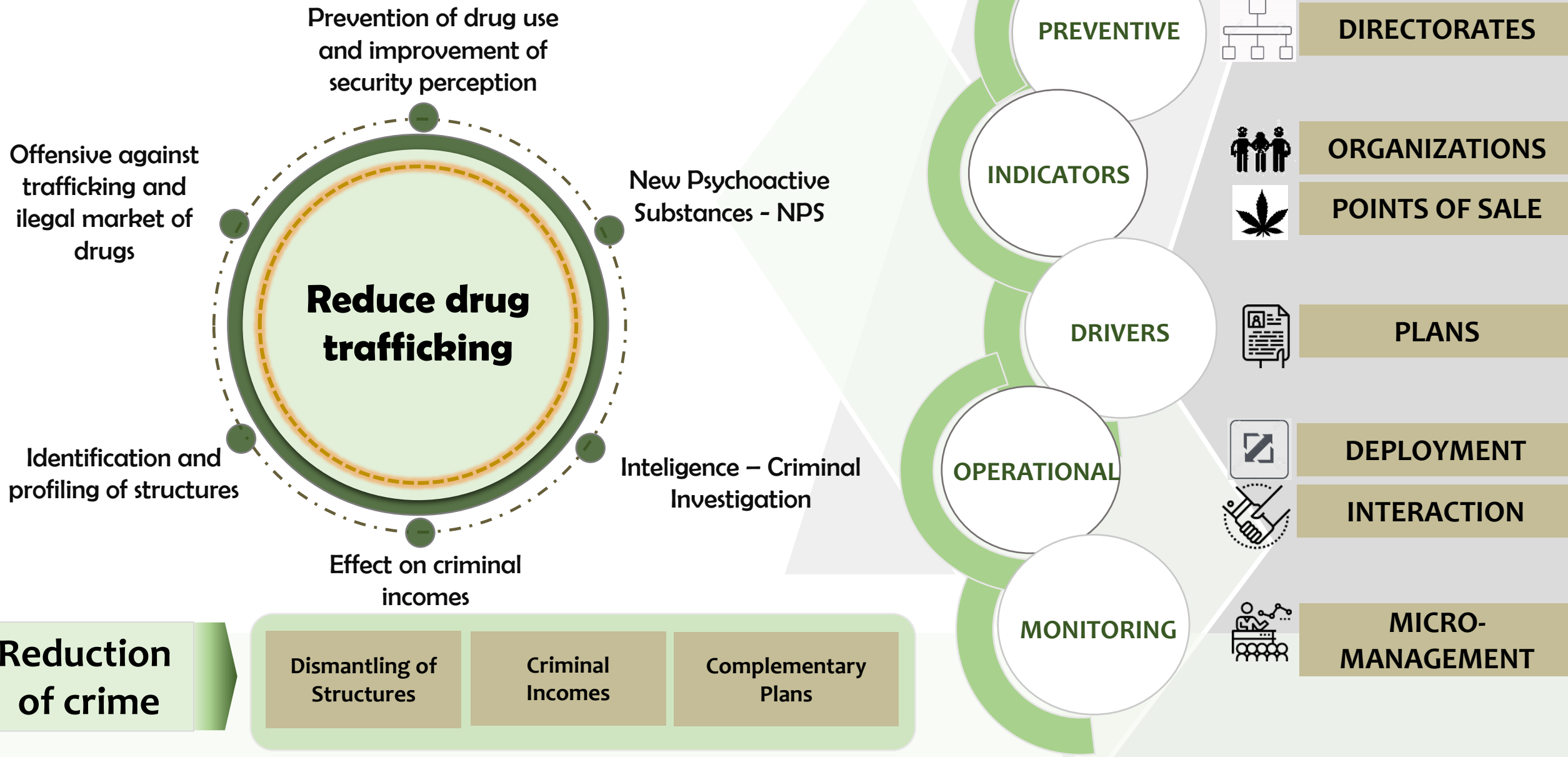

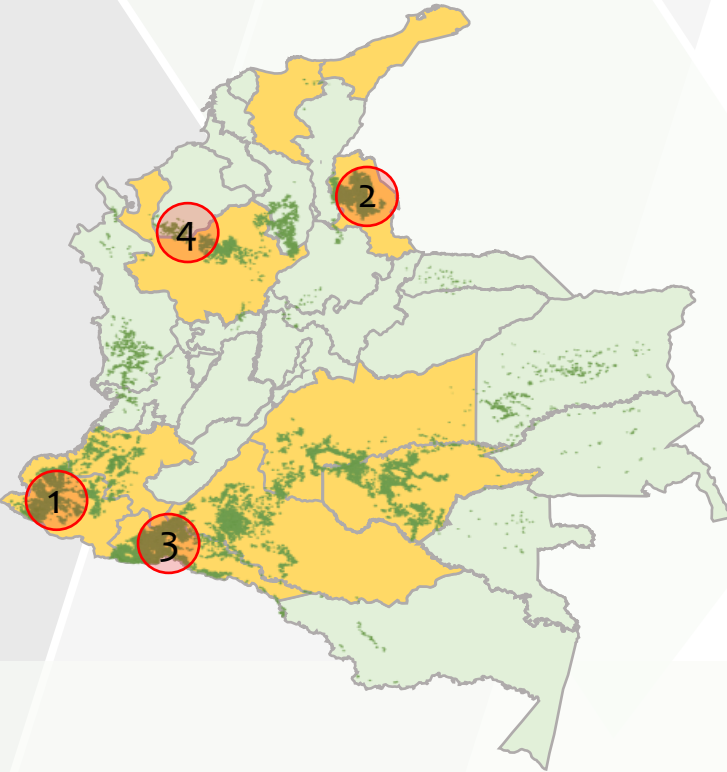

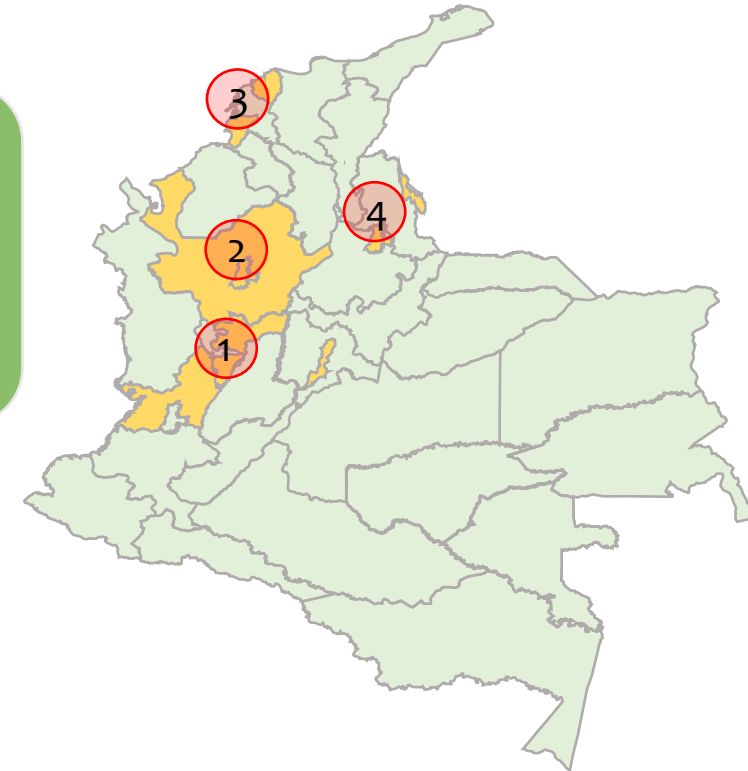

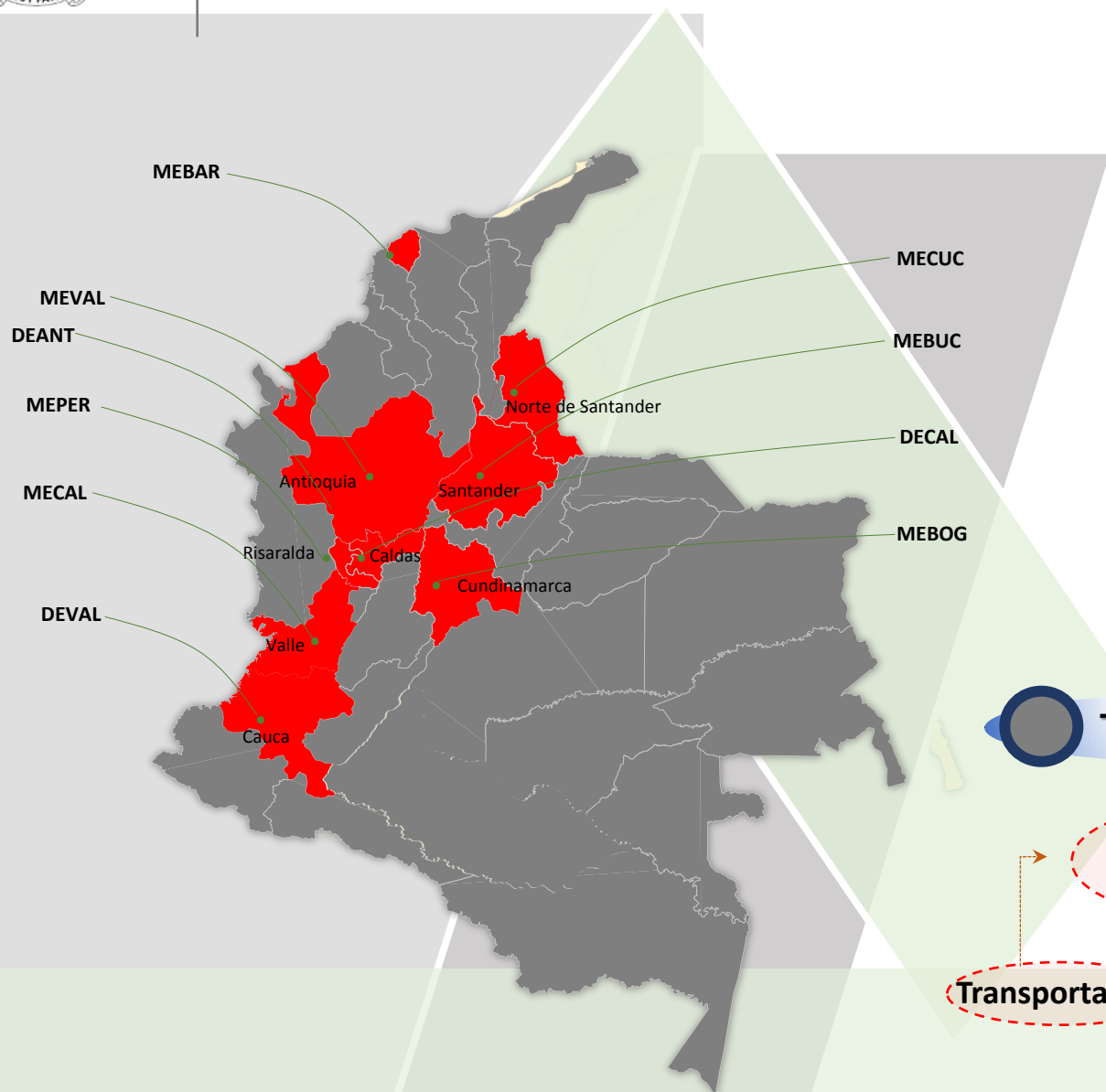

Context of ETEMC (Strategy against Micro-Trafficking)



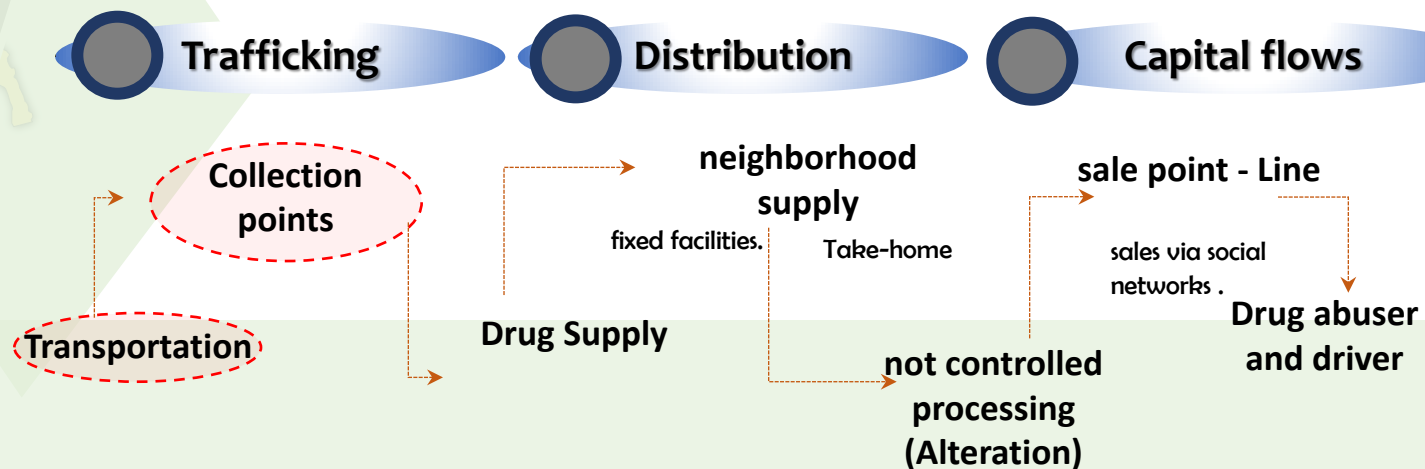

Crime chain- criminal modalities

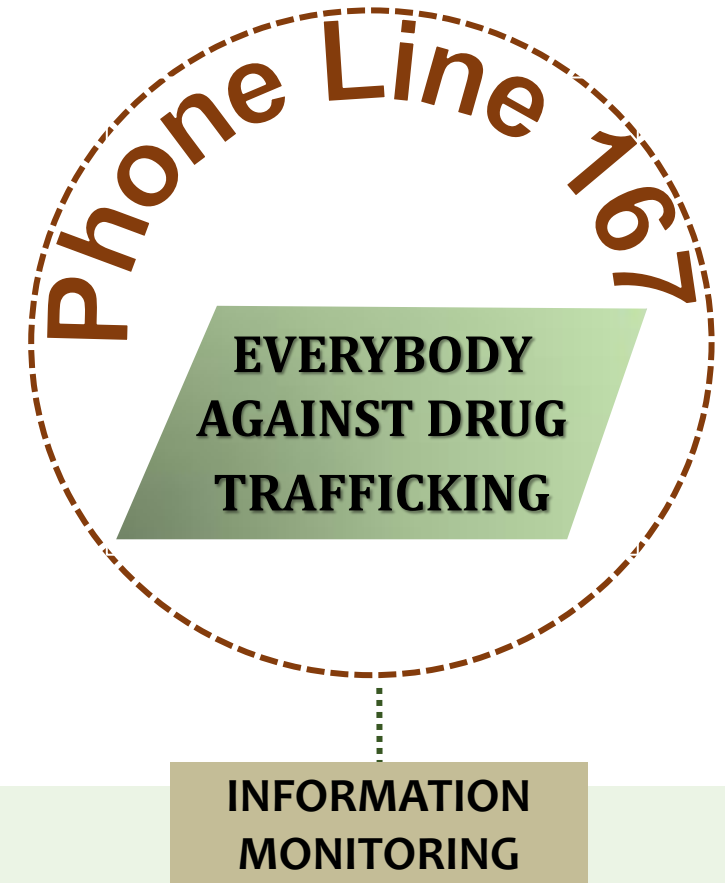




Actions of investigation



- Identification and dismantling of main structures and repeat offenders – Prioritization (NPS synthetic drugs)
- Process of in rem forfeiture - money laundering and asset forfeiture
- Development of impact plans (demolitions- occupancies -TEMIS)
- Prioritization of reward payments
- Monitoring of structure leaders arrests by judicial warrant
- Promotion of citizen reports on pockets of insecurity - ilegal retail places - Dealers- fixed and mobile retailing places – cyber retailing sites.
- Focus on joint action with Attorney General’s Office, linking prioritized municipalities
- Co-responsibility with Ministry of Justice and Ministry of Defense (regulation/norm)
