An overview: This session will explore the components that comprise a comprehensive national drug control policy, and present a simple framework that can help organize the development of a national plan. You will be introduced to a strategic planning tool that CICAD promotes to help countries plan their strategies through the linkage of situation assessments, national plans, resources, and performance monitoring to ensure quality assurance in the implementation of the national plan.

11:15– 11:45	Theoretical and Conceptual Framework (Policy framework, Strategic Planning Pyramid): This session will cover the vision, mission, goals, objectives of a national plan, as well as the relationship between inputs and outcomes. The sessions will show how certain approaches to thinking about the framework can simplify its development and practicality for your use.

Introduction to Logic Models: This session will introduce you to logic models, the questions that should be asked in building one for your national plan, and will include an exercise where we will create a logic model. In addition, you will be shown a few developed logic models that can serve as examples for your future effort to develop a logic model for your national plan or strategy.

Exercise: Develop a logic model for a specific program

Using Logic Models to identify performance targets and design program evaluation plans: Performance accountability systems are tools that can provide feedback to your national plan. Logic models are a means to identify performance metrics for the entire national plan, and for each program used to support its implementation. In this session, you will be shown how logic models can be of great assistance in designing a performance accountability system.

Exercise: Creating performance targets and measures for your program: This exercise will ask you to work with a logic model to propose performance metrics for a program. You will be given an opportunity to practice creating performance targets with the goal of a group presentation and discussion led by the facilitator to provide constructive feedback on your work.

11:15 – 12:15 Leadership, effective coordination, overlapping: In developing a national plan, you







may encounter that many programs and policies that support it will be duplicative across different departments involved in the implementation of the national plan. You may also discover that some government and non-government sectors may have efforts of their own that should be accounted for in your national plan to ensure its successful implementation. This session will explore these challenges drawing from your own experience.
