Pursuant to the authority contained in the Foreign Assistance Act of 1961, as amended, the Agency for International Development, hereby amends the subject Agreement. The purpose of this amendment is to provide an extension of the completion date to September 30, 1992 at no additional cost to the A.I.D.

The specific changes are as follows:

Except as amended herein, all other terms and conditions of this Cooperative Agreement remain unchanged, in full force and effect.


