The Parties, the General Secretariat of the Organization of American States ("GS/OAS"), through its Department of Human Development, Education and Culture ("DHDEC"), and Carleton University ("the University"),

#### **CONSIDERING:**

The Agreement between the General Secretariat of the Organization of American States ("GS/OAS") through the Department of Human Development, Education and Culture and Carleton University, signed on July 16, 2007 ("the Agreement");

Article IX. 2 of the Agreement which provides for its amendment by the duly authorized representatives of the Parties,

### **HEREBY AGREE:**

- 1. To change the website URLs in Article 4.4 of the Agreement to <a href="http://www.carleton.ca/calendars/ugrad/current/">http://www.carleton.ca/calendars/ugrad/current/</a> for undergraduate program information and <a href="http://www.carleton.ca/calendars/grad/current/">http://www.carleton.ca/calendars/grad/current/</a> for graduate program information.
- 2. The following will thus be the new Article 4.4 of the Agreement: General descriptions of the programs offered by Carleton University may be found at <a href="http://www.carleton.ca/calendars/ugrad/current/">http://www.carleton.ca/calendars/ugrad/current/</a> and <a href="http://www.carleton.ca/calendars/grad/current/">http://www.carleton.ca/calendars/grad/current/</a> for undergraduate and graduate programs respectively.
- 3. To add the following as the first paragraph of Article 5.5 of the Agreement: Each OAS scholarship recipient admitted into a Carleton University graduate program will be awarded funding by the University in the amount of CAN\$5000 which will be set against the student's international tuition fees. This funding will continue to be provided per academic year for the normal duration of the scholarship recipient's program of study subject to Carleton University's Terms and Conditions of Admission and Funding.

4. The following will thus be the new article 5.5. of the Agreement: Each OAS scholarship recipient admitted into a Carleton University graduate program will be awarded funding by the University in the amount of CAN\$5000 which will be set against the student's international tuition fees. This funding will continue to be provided per academic year for the normal duration of the scholarship recipient's program of study subject to Carleton University's Terms and Conditions of Admission and Funding.

Carleton University may, in accordance with its internal criteria and subject to the availability of funding, offer paid teaching or research assistantships to OAS scholarship recipients.

- 5. Pursuant to Article IX of the 2007 Agreement, this Amendment No.1 to the 2007 Agreement shall come into force as of the date of signature by the authorized representatives of the Parties.
- 6. All other terms and conditions of the July 16, 2007 Agreement as amended by Amendment No.1 that are not inconsistent with the provisions of this Amendment No.1 remain unchanged and are in full force and effect.
