
On July 10, 2006, the General Secretariat of the Organization of American States, (hereinafter referred to as “GS/OAS”) through its Department of Sustainable Development (hereinafter referred to as “DSD”) and the Universidad de la República Oriental del Uruguay (UDELAR) through its Facultad de Ciencias (hereinafter referred to as the “Institution”) (hereinafter collectively referred to as the “Parties”) entered into a Project Agreement (hereinafter referred to as the “2006 Project Agreement”) to “Implement, Update and Maintain an I3N IAS DataBase in Uruguay.”, and

Paragraphs 13.1 and 13.2 of the 2006 Project Agreement provide for amendment of the Agreement by the duly authorized representatives of the Parties,

WHEREFORE, the Parties hereby agree as follows:

1. A new paragraph, 13.8, is hereby added to the 2006 Project Agreement as follows:
“13.8. This Agreement shall remain in force until November 2, 2007”.
2. All other terms and conditions of the 2006 Project Agreement, as amended by this Amendment Number One that are not inconsistent with the provisions of this Amendment Number One remain unchanged and in full force and effect.
