ADDENDUM NUMBER 2

TO THE

COORDINATING INSTITUTION TRANSFER AGREEMENT

BETWEEN

THE GENERAL SECRETARIAT OF THE ORGANIZATION OF AMERICAN STATES, THROUGH THE DEPARTMENT OF SUSTAINABLE DEVELOPMENT OF THE EXECUTIVE SECRETARIAT FOR INTEGRAL DEVELOPMENT

AND

FUNDAÇÃO O BOTICÁRIO DE PROTEÇÃO À NATUREZA COORDINATING INSTITUTION

FOR

"THE IMPLEMENTATION OF ACTIVITIES IN SUPPORT OF THE IABIN (INTER AMERICAN BIODIVERSITY INFORMATION NETWORK) PROTECTED AREAS THEMATIC NETWORK"

This Addendum Number 2 (the "Addendum 2") between the Fundação O Boticário de Proteção à Natureza, referred to herein as "FUNDACAO", the "Coordinating Institution" or "CI", and the General Secretariat of the Organization of American States, hereinafter referred to as "GS/OAS", through its Department of Sustainable Development, hereinafter referred to as "GS/OAS/DSD" (jointly referred to herein as the "Parties"), shall be appended to and be governed by, the terms set out in the Coordinating Institution Transfer Agreement between the GS/OAS and the CI signed on March 9, 2006 (hereinafter "the CI Transfer Agreement") and amended on October 10, 2006. Nothing in this Addendum 2 shall be construed as modifying the terms agreed to under the CI Transfer Agreement except as specifically set forth herein.

Under this Addendum 2, the Parties hereby agree that pursuant to Article XIV of the CI Transfer Agreement, the provisions indicated below of the CI Transfer Agreement will be amended, as follows:

Article I

1.1 Section 2.1 and Subsection (d) of the CI Transfer Agreement shall be amended to read as follows:

"2.1 FUNDACAO, the Coordinating Institution, declares its commitment to collaborate with GS/OAS and IABIN, specifically with the objectives of Subcomponents A.2 and B(1), as set forth in Schedule 2 of the GEF Trust Fund Grant Agreement in terms satisfactory to GS/OAS/DSD and the IBRD, and to this end, FUNDACAO shall:



(d) Prepare an annual operating plan (AOP) in accordance with the provisions set forth in Part B.2.3 of this Agreement, which is designed to meet the objectives of this Agreement in such manner that all activities ensure the achievement of goals of Subcomponents A.2 and B(1) and sustainability of both Thematic Networks that have been entrusted to FUNDACAO."

Article II

- 2.1 A Subsection 4.1.3 shall be added under Section 4.1 of the CI Transfer Agreement, to read as follows:
 - "4.1.3 Pursuant to the Addendum 2, GS/OAS shall contribute to the Coordinating Institution a total of up to US\$75,000 for the execution of Subcomponent B(1) of the Project. This amount is a portion of the GEF Trust Fund Grant proceeds (hereinafter "CI Transfer Funds") and will be disbursed as indicated in Subsection 4.1.4."
- 2.2 Subsection 4.1.4 shall be added under Section 4.1 of the CI Transfer Agreement, to read as follows:
 - "4.1.4 The Coordinating Institution shall provide a budget to the GS/OAS for the carrying out of Subcomponent B(1), consisting of the organization of training sessions on the use of data creation tools (within the meaning of "Training" defined in the GEF Trust Fund Grant Agreement). Within five (5) working days from delivery of said budget to GS/OAS/DSD, the latter shall review it and approve it. Once said budget is approved, GS/OAS/DSD shall disburse and advance to the CI up to 50 percent of the corresponding funds according to such budget. The remaining funds shall be disbursed upon delivery by the CI and approval by GS/OAS/DSD of a financial statement, after the completion of the training sessions. The financial statement shall include eligible expenditures in accordance with the provisions set forth in the approved budget."
 - 2.3 Section 4.4 of the CI Transfer Agreement shall be amended to read as follows:
 - "4.4 The contribution of up to US\$272,500.00 until March 9, 2009 period that the GS/OAS will contribute to the Coordinating Institution for the execution of the Project is subject to and exclusively limited to GS/OAS' receipt of the funding provided by the IBRD GEF Trust Fund Grant."

Article III

- 3.1 Section 14.3 of the CI Transfer Agreement shall be amended to read as follows:
- "14.3. This Agreement shall enter into force on the date on which the duly authorized representatives of the Parties have signed it. It shall remain in force until Margh 9, 2009."
