

The Parties, the General Secretariat of the Organization of American States ("GS/OAS"), through its Department of Human Development ("DHD"), and the Academic & Professional Programs for the Americas, Inc. ("LASPAU"), having entered into the above-entitled Agreement on April 30, 2007 (hereinafter the "April 2007 Agreement"), take into account the following:


- 1) That by operation of Amendments Number One through Three, the duration of the April 2007 Agreement was extended by mutual agreement of the Parties through April 30, 2009, under the same terms and conditions of the April 2007 Agreement;
- 2) That the Parties wish to continue with the services provided to the GS/OAS by LASPAU pursuant to the April 2007 Agreement beyond the date of April 30, 2009;
- 3) That Article IX of the April 2007 Agreement authorizes the extension of the duration of the Agreement upon the written agreement of the Parties;

Wherefore, effective upon the signature of their duly authorized representatives, the Parties agree to the following:

Pursuant to Article IX of the April 2007 Agreement, to amend the duration of the April 2007 Agreement, until August 30, 2009 under the same terms and conditions of the April 2007 Agreement;


