CONVENIO ENTRE LA SECRETARIA GENERAL DE LA ORGANIZACION DE LOS ESTADOS AMERICANOS, LA ORGANIZACION PANAMERICANA DE LA SALUD Y EL BANCO INTERAMERICANO DE DESARROLLO PARA LA PARTICIPACION EN LA EXPOSICION MUNDIAL DE SEVILLA EN 1992.

**AGREEMENT BETWEEN THE GENERAL SECRETARIAT OF THE
ORGANIZATION OF AMERICAN STATES AND THE
INTER-AMERICAN INSTITUTE FOR COOPERATION
ON AGRICULTURE FOR PARTICIPATION IN THE
SEVILLE WORLD FAIR 1992**

THE PARTIES TO THIS AGREEMENT. The General Secretariat of the Organization of American States ("GS/OAS") and the Inter-American Institute for Cooperation on Agriculture ("IICA") (together, "the parties"),

CONSIDERING, that GS/OAS intends to participate together with the Inter-American Development Bank (IDB) and the Pan American Health Organization (PAHO) in presenting an Exhibition for the Inter-American System ("the Exhibition") at the 1992 Universal Exposition in Seville;

BEARING IN MIND, that GS/OAS, IDB, and PAHO have each pledged \$420,000 for the design, construction, and use of the Pavilion for the Exhibition ("the Pavilion");

TAKING INTO ACCOUNT, that the General Assembly of the Organization of American States, in the Program-Budget Resolution for the 1992-1993 Biennium, approved an expenditure of \$300,000 for GS/OAS' participation in the Exhibition at the rate of \$150,000 for each year of the biennium; and,

BEARING IN MIND, that IICA is a Specialized Organization under Article 52 of the OAS Charter; that on May 16, 1974, GS/OAS and IICA entered into an agreement for Cooperative Relations in areas and activities of joint interest; and that IICA and GS/OAS have participated as partners in a variety of programs and projects in furtherance of the interests of the Member States of OAS and IICA.

HAVE AGREED, to the following terms and conditions,

ARTICLE I

IICA will contribute to GS/OAS one hundred and twenty thousand dollars (\$120,000) by paying that amount in full to the GS/OAS Treasurer; however, IICA shall not be obligated under this Agreement to pay any more than that amount. The Contribution shall be made in three payments: the first, for \$20,000 on or before December 31, 1991; the second, for \$50,000 on or before January 31, 1992; and the third, for \$50,000 on or before March 31, 1992.

ARTICLE II

GS/OAS shall include IICA's entire Contribution as part of SG/OAS' four hundred and twenty thousand dollar (\$420.000) obligation under its Agreement with PAHO and BID for participation in the Exhibition.

ARTICLE III

In exchange for its contribution, IICA shall be entitled to participate, together with the other institutions of the Inter-American System, in the space and general services of the Pavilion, to the extent that corresponds to its contribution and subject to the conditions set out in an Agreement to be concluded by GS/OAS, PAHO and IDB with the Exposición Universal de Sevilla 1992 S.A. (EXPO 92), to which the present agreement will be an Annex.

ARTICLE IV

GS/OAS' representative for purposes of implementing this Agreement shall be James Patrick Kiernan or such other person whom the OAS Secretary General shall delegate in writing with notice to IICA's Director General. IICA's Representative for purpose of implementing this Agreement shall be Jorge Werthein or such other person whom IICA's Director General shall delegate in writing with notice to the OAS Secretary General. The GS/OAS representative shall not have authority to bind GS/OAS without an express written delegation of authority for that purpose from the Secretary General. Similarly, IICA's representative shall not have authority to bind IICA without an express written delegation of authority for that purpose from IICA's Director General.

ARTICLE V

GS/OAS' representative shall consult with IICA's representative over the design and use of the Pavilion, and after considering the concerns of IICA's representative, will be solely responsible for taking the appropriate actions in relation to such use in design.

ARTICLE VI

The parties shall resolve any dispute arising out of this Agreement through consultation and negotiation with each other.


ARTICLE VII

In the event that either no final written agreement is concluded between PAHO, BID and GS/OAS for the financing, design, and use of the Pavilion, or PAHO, BID, and GS/OAS fail to conclude a final written agreement with Expo '92 over the use, financing, and design of the Pavilion, this agreement shall terminate and GS/OAS shall return to IICA any part of IICA's contribution not expended on the design and use of the Pavilion.


IN WITNESS WHEREOF, the duly authorized representatives of the parties have signed this Agreement at the place and upon the date as indicated below.
