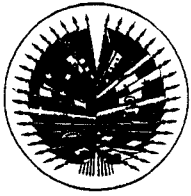

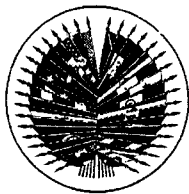

Embassy of the Republic of Korea:

The General Secretariat of the Organization of American States respectfully salutes the Embassy of the Republic of Korea in the United States of America.

Further to our recent exchange regarding support from the Government of the Republic of Korea (the "Government") to OAS Electoral Observation Missions ("EOMs"), the General Secretariat of the OAS (the "General Secretariat") would like to present the following matters for consideration by your Government.

The Electoral Observation Missions of the Organization of American States ("OAS") have become an essential instrument in the promotion and defense of democracy throughout the Americas. These initiatives have not only helped guarantee the integrity and impartiality of, and the confidence in, numerous electoral processes, but they have also helped reinforce the credibility of democratic institutions of OAS Member States.

EOMs not only promote the right of citizens to choose and to be elected in an inclusive, free, and transparent manner, but they also help to ensure that the popular will, as expressed through the ballots, is respected.

We acknowledge, and accept with gratitude, the offer of your Government, via the Permanent Observer Mission of the Republic of Korea to the OAS, to contribute to OAS Electoral Observation Missions.

The contribution from the Government of the Republic of Korea to the General Secretariat will be decided after signing, in support of upcoming OAS EOMs.

It is understood that the Contribution will cover the participation of a Government official in the OAS Electoral Observation Missions, and as such, will cover the round-trip airfare of this individual, as well as local transportation, related indirect costs, and per diem for approximately five days.

Furthermore, it is understood and agreed:

(A) that the Government will select the Government's participant for the OAS EOMs;
and

(B) that the individual selected by the Government will meet the following conditions::

(1) the individual selected by the Government shall be available to participate in a given OAS EOM for at least five days, which would include one day for training purposes, and


(2) that this individual must speak fluent Spanish.

(C) Twelve (12) per cent of the Contribution may be used by GS/OAS to cover administrative support costs in connection with this project.

(D) Any unused funds from the Contribution will be transferred by the General Secretariat to an un-programmed account for use in future OAS Electoral Observation Missions.

The duly authorized representatives of the Permanent Observer Mission of the Republic of Korea to the OAS and of the General Secretariat hereby agree to the above terms and conditions on the dates and locations set forth below.


