I am pleased to confirm with you the intention of the Canadian International Development Agency ("CIDA") to contribute the sum of up to five hundred thousand Canadian dollars (C\$500,000) (the "Contribution") to the General Secretariat of the Organization of American States (the "GS/OAS") to support the implementation of the Strengthening Democracy in the Americas Project (the "Project") by enabling the GS/OAS to organize workshops and provide technical support to meetings of several inter-Amercian bodies, and for dissemination of the Democratic Charter and Summit of the Americas Mandates relating to strengthening democracy.

Please note that the payments from CIDA under this Agreement are subject to there being an appropriation by the Parliament of Canada for the fiscal year in which the payment is to be made.
