**AMENDMENT to the ARRANGEMENT**  
**between**  
**the Netherlands Minister for Development Cooperation**  
**and**  
**the General Secretariat of the Organization of American States**

Whereas the Netherlands Minister for Development Cooperation, hereafter referred to as the 'Minister', and the General Secretariat of the Organization of American States, hereafter referred to as the 'Organization', concluded an Arrangement in December 2005 concerning a Netherlands contribution to the "Organization of American States' Mission to support the Peace process in Colombia (Misión de Apoyo al Proceso de Paz en Colombia", Minister's project. no. 13195 (DMV0063905), hereafter referred to as the project;

Whereas developments relating to the project justify amendment of the said Arrangement;

The Minister and the Organization have come to the following Arrangement:

- 1) The project will be implemented from 1 January 2006. It will be completed by 31 December 2006.

In case the implementation period for the Project agreed upon pursuant to this Arrangement is likely to be overrun, the Organization shall submit to the Minister a written request for an extension of the implementation period at no additional cost to the Minister, as soon as possible.

- 2) The Organization will submit to the Minister an unaudited financial statement, signed by its Chief Financial Officer, no later than 30 April 2007.  
The financial statement will show:
  - a the available project cash balance on 1 January 2006 (including the Minister's contribution;
  - b the total expenditures of the project (per budget item) between 1 January 2006 and 31 December 2006

The Organization will also submit to the Minister, no later than 30 June 2007, a final narrative report containing an overview of project activities.

the Organisation will submit reports and statements of account in the currency of the budget, i.e. USD.

- 3) The other terms and conditions of the Arrangement remain unchanged.


