AMENDMENT TO THE PROJECT COOPERATION AGREEMENT
between
THE UNITED NATIONS DEVELOPMENT PROGRAMME
and
THE GENERAL SECRETARIAT OF THE ORGANIZATION OF AMERICAN STATES,
SIGNED AUGUST 23, 2004

**FOR THE IMPLEMENTATION OF A PROJECT TO SUPPORT THE
CONSOLIDATION OF DEMOCRACY IN HAITI**

The Parties: the United Nations Development Programme (hereinafter "UNDP") and the General Secretariat of the Organization of American States (hereinafter "GS/OAS"),

Considering:

That on August 23, 2004, the Parties signed a Project Cooperation Agreement (hereinafter the "Agreement") to implement the activities established on the project document entitled "the project document entitled "Support for the Consolidation of Democracy in Haiti" (hereinafter the "Project Document"),

That paragraph 2 of Article VIII of the Agreement provides, among other matters, that "variations exceeding 20 per cent on any one-line item that may be necessary for the proper and successful implementation of the Project shall be subject to prior consultations with and approval by the UNDP",

That Article XVIII of the Agreement provides that the Agreement or its Annexes, "may be modified or amended by written agreement between the Parties" and that the Parties now wish to amend provisions of Annex 1 - Project Document, to the Agreement,

The Parties agree to the following:

To allocate the entire financial contribution of the UNDP consisting of US \$8,756,594.00 under paragraph 1 of Article VIII of the Agreement, to the execution of activities to support the holding of elections in Haiti.

To this end, the introduction and first paragraph of item C. DESCRIPTION OF THE PROJECT on page 4 of the Project Document are hereby amended, as follows:

The sentence "Le present projet comporte deux composantes faisant des lignes indiquées par la Résolution AG/RES 2059: "is deleted.

The number "1" appearing before the title "Support aux Elections" is deleted.

The first paragraph following the title "Support aux Elections" is deleted and the following substituted therefore:

"This Project is devoted to activities to support the holding of elections in Haiti in pursuance of OAS General Assembly Resolution AG/RES 2058 (XXXIV-04) "Situation in Haiti: Strengthening of Democracy". To support these activities, the UNDP is providing a contribution of US \$8,756,594.00 to be applied to a technical electoral assistance program

over an 18- month period that will assist the Provisional Electoral Council ("CEP") with respect to voter registration, the creation of a database of eligible voters, and the management of the elections of 2005. The OAS will provide technical experts from its member states. The OAS will provide technical experts from its member states. The program has, among others, the following three main components:"

The title and the entirety of the text appearing under numbered paragraph 2. Coûts Opérationnels de la Mission Spéciale de l'OEA on pages 5 and 6 of the Project Document are deleted.


The budget attached to the Project Document is deleted and is replaced by the budget attached as Annex I to the present Amendment.

All references in this Amendment and throughout Annex 1 - Project Document, to "OAS General Assembly Resolution AG/RES 2059" are hereby deleted and replaced by reference to "OAS General Assembly Resolution AG/RES 2058 (XXXIV-04) Situation in Haiti: Strengthening of Democracy".

With the exception of the provisions of this Amendment, all other provisions of the Project Cooperation Agreement signed August 23, 2004 and Annex 1 - Project Document, shall remain in full force and effect and shall be applicable and enforceable. In the event of incompatibility between the provisions of this Amendment and the Project Cooperation Agreement signed August 23, 2004 and Annex 1 - Project Document, the provisions of this Amendment shall prevail.


