## MEMORANDUM OF UNDERSTANDING

between

THE GENERAL SECRETARIAT OF THE ORGANIZATION OF AMERICAN  
STATES  
(GS/OAS)

and

THE UNITED NATIONS INDUSTRIAL DEVELOPMENT ORGANIZATION  
(UNIDO)

The General Secretariat of the Organization of American States (hereinafter referred to as "GS/OAS"), represented by its Secretary General, José Miguel Insulza, and the United Nations Industrial Development Organization (hereinafter referred to as "UNIDO"), represented by its Director-General, Carlos Magariños (hereinafter collectively referred to as the "Parties"),

Considering that the 10<sup>th</sup> Session of the General Conference of UNIDO in December 2003 called for a plan of action to foster sustainable industrial development and to fight against poverty in Latin America and the Caribbean,

Noting the recommendations and observations that have been made in different fora at the international and regional levels, including, inter alia, the Ibero-American Summits, the Millennium Development Goals and other Development Goals established by the major UN Conferences of the 1990's, with regard to confronting the social effects of globalization and the fight against poverty,

Considering that UNIDO has the primary responsibility in reviewing and promoting the co-ordination of all activities of the United Nations system in the field of industrial development in the developing countries and in countries with economies in transition,

Considering that the intensive globalization process, accelerating technological advances as well as free trade, and the opening up of individual countries' markets to foreign investment in accordance with their respective interests and

developmental priorities represent more options for income and employment generation but also mean new challenges for economic development,

Considering, in particular, that the majority of developing countries have not attained the productivity and standard of living of industrialized countries, and that this gap between rich and poor is evident among the countries of the Americas and needs to be addressed,

Further considering that improvements in competitiveness and technological development offer developing countries significant opportunities to address critical social and economic aspects of their development,

Conscious of the need to strengthen technical cooperation between the Parties that aims at the generation of productive employment, a competitive economy and a sound environment,

Seeking to achieve the objectives contained in this Memorandum of Understanding (hereinafter referred to as "MOU"), the Parties will promote and support one another by sharing their particular institutional expertise, knowledge, skills, information and technology,

Stressing that the activities to be implemented under this MOU will benefit the needs of Latin American and Caribbean member states of OAS and UNIDO,

Considering that the GS/OAS is the central and permanent organ of the Organization of American States and is authorized to carry out relations of cooperation in accordance with Article 112(h) of the Charter and OAS General Assembly Resolution AG/RES. 57 (I-O/71),

**Therefore, the Parties** agree to sign this Memorandum of Understanding based on the following provisions:

#### **ARTICLE 1: PURPOSE**

- 1.1. The purpose of this MOU is to establish a framework for cooperation between the Parties under which the GS/OAS may choose to associate itself with UNIDO projects identified in Annex I (which is attached hereto and incorporated by reference herein), and the development of joint programs,

projects or activities between the Parties in the five areas of collaboration specified in Article 2, below.

- 1.2. This cooperation will contribute to support the needs of Latin American and Caribbean member countries of OAS and UNIDO and provide the basic framework for developing a long-term, flexible collaborative relationship between the Parties that will be responsive to their respective mandates, and lead to the generation of new employment and economic development by providing technical assistance in the five areas of collaboration specified in Article 2, below.

## **ARTICLE 2: AREAS OF COLLABORATION**

- 2.1. The initial collaboration between the Parties will consist of joint initiatives in the following five principal areas:
  - (a) Investment and Technology Promotion,
  - (b) Industrial Competitiveness and Trade,
  - (c) Private Sector Development,
  - (d) Sustainable Energy and Environment, and
  - (e) Security, Human Rights and Development.

## **ARTICLE 3: WORKING AND COORDINATION MECHANISMS**

- 3.1. To ensure an efficient and qualitative cooperation, the Parties foresee periodic working meetings, of which the first will take place in November, 2005.
- 3.2. All specific instances of collaboration, whether by way of GS/OAS' association with existing UNIDO projects and activities identified in Annex I, hereto, or through programs, projects or activities jointly developed and undertaken by the Parties will be subject to approval by the duly authorized representatives of the Parties and agreed to in supplementary agreements, memoranda of understanding, exchange of letters, or a project document signed by the duly authorized representatives of the Parties. Each such document will include, at a minimum, identification of the agreed-upon program, project or activity, the objectives sought, the responsibilities of each Party with regard to project funding, reporting and implementation, including a work plan and the identification of the dependencies of the Parties that will execute the project,

program or activity, together with dates of commencement, termination and coordination.

- 3.3. This MOU in no way restricts either of the Parties from participating in similar arrangements or agreements, including the pursuit of project funding, with other entities.

#### **ARTICLE 4: FINANCIAL ASPECTS**

- 4.1 The implementation of activities envisaged in the present MOU shall depend on the availability of the necessary financial resources and will be made in accordance with the regulations and procedures in force in UNIDO and in GS/OAS.
- 4.2 The level of investments to be made from UNIDO to comply with the purpose of the present memorandum will not be lower than the current level of investments made from its regular budget in the projects listed in the annex.
- 4.3 GS/OAS will work together with UNIDO in fund-raising activities for joint programs, projects and activities as specified in Article 1, above.

#### **ARTICLE 5: REPRESENTATION AND NOTICE**

- 5.1. For purposes of sending and receiving notice and coordinating activities under this MOU , each Party will name a focal point. For the GS/OAS, the focal point will be the Department of Communications and External Relations, and for UNIDO, the focal point will be the Latin America and Caribbean Bureau.


#### **ARTICLE 6: MISCELLANEOUS CONDITIONS**

- 6.1. The Parties mutually recognize the privileges and immunities accorded to each of them by virtue of general principles of international law and by such agreements on privileges and immunities as may be relevant. Nothing in this Agreement constitutes an express or implied waiver of the privileges and immunities of either Party.

- 6.2 In the event of a dispute, controversy or claim arising out of or relating to this MOU, or the breach, termination or invalidity thereof (a "dispute"), the Parties will use their best efforts to settle promptly such dispute through direct negotiation. Any dispute that is not settled within sixty (60) days from the date either party has notified the other party of the nature of the dispute and of the measures that should be taken to rectify it will be resolved through consultation between the Director-General of UNIDO and the Secretary General of the OAS. Each Party will give full and sympathetic consideration to any proposal advanced by the other to settle amicably any matter for which no provision has been made or any controversy as to the interpretation or application of this MOU.
- 6.3 The Parties may only modify or otherwise amend this MOU by way of a written instrument signed by the duly authorized representatives of each Party, dated, and attached hereto.
- 6.4 The MOU shall enter into force upon signature by the Director-General of UNIDO and the Secretary-General of OAS once the internal requirements of both organizations for entry into force have been met. The MOU will continue in full force and effect for two years thereafter unless it is terminated in accordance with Article 6.5.
- 6.5 Either Party may terminate this MOU by giving sixty days' written notice to the other. In addition, both Parties may agree to terminate this MOU according to whatever terms as they may mutually agree. If the MOU is terminated by either Party, steps shall be taken to ensure that the termination does not affect any prior obligation, project or activity already in progress.
- 6.6 Paragraphs 6.1 and 6.2, above, shall survive the expiry or termination of this MOU.
- 6.7 Nothing in this MOU will so construed as to require either UNIDO or the GS/OAS to furnish any material, data and information the furnishing of which could, in its judgment, require it to violate its policy regarding the confidentiality of such information.

## **UNIDO signs agreement with the Organization of American States**

**Vienna, 18 October 2005** – Carlos Magariños, Director-General of the United Nations Industrial Development Organization (UNIDO), and José Miguel Insulza, Secretary-General of the Organization of American States (OAS), signed today a Memorandum of Understanding at UNIDO's headquarters in Vienna.

Built on the mandates of both organizations, the Memorandum takes into consideration the recommendations of the 10th Session of the UNIDO General Conference in December 2003, calling for a plan of action to foster sustainable industrial development and fight against poverty in Latin America and the Caribbean. The aim is to support the needs of OAS and UNIDO member states and to provide the basic framework for developing a flexible long-term collaboration with UNIDO.

The intensive globalization process, the accelerating technological advances as well as free trade and the opening up to foreign investment represent more options for income and employment generation in the region. Following the agreement, the OAS can associate itself with ongoing UNIDO projects in the Americas and both parties can now develop joint projects leading to employment generation. The organizations will be providing technical assistance in five areas: Investment and Technology Promotion, Industrial Competitiveness and Trade, Private Sector Development, Sustainable Energy and Environment, and Human Security.
