LOGISTICAL SUPPORT TO THE NORWEGIAN ELECTION OBSERVER GROUP TO THE OBSERVATION MISSION FOR THE ELECTIONS IN COLOMBIA ON OCTOBER 28,2007

1. Appointment

The Norwegian Refugee Council (hereinafter referred to as "NRC") hereby appoints the General Secretariat of the Organization of American States (hereinafter referred to as "GS/OAS") and GS/OAS accepts, the appointment on the conditions laid down in this Contract and in the Budget in Annex I, which is an integral part of this Contract.

2. Scope of the services

GS/OAS shall provide logistical and administrative support (hereinafter referred to as the "Service") to the Norwegian Election Observer Group, as listed in the budget Annex I, during the elections in Colombia on October 28, 2007.

3. Implementation of the Services

4. Reporting

A final report with financial statements for the Services shall be submitted to the NRC no later than one month after the end of the Election Observation Mission.

5.5 In accordance with GS/OAS financial rules and regulations, twelve percent (12 %) of the NRC contribution shall be used by GS/OAS to cover indirect costs related to the administration of the contribution.

6. Delays

In the event of major delay in providing the Services, GS/OAS shall notify the NRC in writing. In its notification, GS/OAS shall state the reasons for the delay. It will exert its best efforts to reduce any additional costs caused by the delay. Where the delay was caused or significantly contributed to by GS/OAS, the extra costs shall be borne by GS/OAS.

7. Control of expenditure - changes

- GS/OAS shall closely control the expenses incurred in the implementation of the Services and shall promptly inform the NRC in writing of any indications that the completion of the Services may imply an excess of the limitation in this Contract and present revised estimates.
 The performance of Services and both in Contract and the present revised estimates.
- 7.2 The performance of Services under this Contract which would involve costs exceeding the total approved budget amount referred in section 5.1 above shall require written approval in advance from the NRC. Any excess cost incurred without approval shall be the responsibility of GS/OAS.

8. Liability

The NRC shall not be liable – financially or in other ways – to firms or individuals engaged by GS/OAS under this Contract.

9. Compliance with local laws

10. Duration

The Contract shall enter into force upon its signature and shall remain in force until the final expenses referred to in Section 5.3 have been paid to GS/OAS by the NRC.

11. Termination

This Contract may be terminated by either party through advance written notice of thirty days.

12. Settlement of disputes

Any dispute between the parties or claim arising out of or in relation to the interpretation, application or performance of this Contract, including its validity or termination, or with regard to any further arrangement which may result thereof shall be settled amicably by negotiation between the Parties. In the event that such negotiation is unsuccessful, either Party may submit the dispute to arbitration. The arbitration will be carried out in accordance with the UNCITRAL arbitration rules. The arbitration decision will be final and binding.

13. Miscellaneous

Nothing in this Agreement constitutes an express or implied waiver of the privileges and immunities of the GS/OAS in accordance with the OAS Charter, relevant agreements, applicable national law or general principles and practices of international law.
