Amendment no. 1 to the Research Support Grant Agreement

for the project entitled

"Supporting e-government development in Latin America and the Caribbean"

1. Special conditions

- (ii) that the OAS and the Recipient have privileges and immunities under Article 133 of the OAS Charter under which they enjoy, in the territory of each member state, such legal capacity, privileges, and immunities as are necessary for the exercise of their functions and the accomplishment of their purposes; and
- (iii) that under headquarters agreements with various member states, the OAS and the Recipient are exempt from all sales, use, and property taxes and are exempt from all custom duties and charges of a similar nature in respect of articles imported or exported for their official use.

All other terms and conditions of the original Agreement continue to apply.
