INSTRUCTIONS FOR UNIFORM INTER-AMERICAN REGISTRATION FORM Amendment Form

Line 1 – Original Registration

Enter original registration file number allocated during first registration.

Line 2 – Amendment

Please check the requisite box for the intended amendment. To change the name and/or address of a party. Indicate whether this amendment amends information relating to a Debtor or a Secured Creditor; also indicate that this a name and/or address change.

Line3 – Current information

Enter only one name in item 3. Enter Debtor or Secured Party exact full legal name as appropriate.

Organization: "Organization" means an entity having a legal identity separate from its owner. A partnership is an organization; a sole proprietorship is not an organization, even if it does business under a trade name. If Debtor is a partnership, enter exact full legal name of partnership; you need not enter names of partners as additional Debtors. If Debtor is a registered organization (e.g. corporation, limited partnership, limited liability company), it is advisable to examine Debtor's current filed charter documents to determine Debtor's correct name, organization type, and jurisdiction of organization.

Individual: "Individual" means a natural person; this includes a sole proprietorship, whether or not operating under a trade name.

Address: An address is always required for the Debtor named.

Identification number i.e. social security number or employer identification number, may be required in some States.

Type of organization (e.g. corporation, limited partnership, limited liability company)

Jurisdiction of Organization where The Organization has been registered first.

Line 4 – changed or added information: provide the new party, name and/or new address in this section

Enter information determined and formatted per Instruction in Line 3.

Enter only one name in item 4

Line 5 –Collateral change:

To change collateral covered by the identified registration document, describe the change in item 5. This may be accomplished whether by describing the collateral to be added or deleted, or by setting forth in full the collateral description as it is to be effective after the filing of this Amendment, indicating clearly the method chosen.

(NOTE: Choose amendment under item 2 or item 5, **not both**).

Line 6 – Secured Creditor Authorizing this registration.
