Context and Background:

The First Inter-American Meeting of Ministers and High Level Authorities on Sustainable Development will identify and advance concrete partnerships at the regional and hemispheric level to integrate environmental considerations into development, poverty alleviation, social and economic policies. This meeting, to be held in Santa Cruz, Bolivia, will take into account progress in implementing sustainable development, including, *inter alia*, the 1992 United Nations Conference on Environment and Development, the 1996 Santa Cruz Summit on Sustainable Development, and the 2002 Johannesburg UN Conference on Sustainable Development.

This ministerial meeting will also serve as part of the follow-up activities of the Fourth Summit of the Americas: “Creating Jobs to Fight Poverty and Strengthen Democratic Governance” that took place in November 2005. The main focus of the meeting will be the environment-economy nexus, and refer to the Millennium Development Goals (MDG) of particular relevance to sustainable development. The meeting will identify specific opportunities for cooperation among OAS Member States in integrating environmental management within core economic development, poverty alleviation, and related goals.

In order to achieve MDGs policy objective to build “a comprehensive approach and a coordinated strategy, tackling many problems simultaneously across a broad front” the meeting shall identify practical, replicable project and policy lessons integrating the three pillars of sustainable development, namely, economic development, social issues, and environmental protection.

The OAS’ Inter-American Strategy for the Promotion of Public Participation in Decision-Making for Sustainable Development recognizes that any development effort requires the active involvement of an informed civil society to be truly sustainable. Public participation in the decision-making process introduces a broader range of ideas, experiences, and expertise that motivate the development of alternative solutions. Public participation provides opportunities for cooperation and coordination between government and civil society. All this is particularly true in dealing with issues related to the environment and sustainable development, since they affect people from all segments of society and can bring them together to work toward common goals.

For this reason, on September 19, 2006, the Department of Sustainable Development, with the support of the Summits of the Americas Secretariat, the Canadian International Development Agency, and the Sustainable Economic Development Unit (SEDU) for Small and Island Developing States (SIDS) of the Department of Economics of the University of the West Indies, St. Augustine Campus, will hold the *Caribbean Roundtable with Civil Society* in order to facilitate broad-based civil society participation during the preparatory process of the Ministerial Meeting, and to facilitate the dialogue between civil society and different community groups to obtain their comments for consideration in the drafting of the *Declaration of Santa Cruz*.

Themes of analysis:

- Integrated water-resource management
- Risk sharing and risk transfer arrangements of natural disasters
- Sustainable agriculture, sustainable forestry and tourism
