A. Introduction

In recent years, countries from the American hemisphere have encounter serious levels of vulnerability regarding natural disasters, which includes hurricanes, inundations, earthquakes, landslides, droughts, and natural phenomenon like EL Nino among others. Since the 60's, natural disasters in Latin American and the Caribbean have affected more the 40 million habitants, causing more than 45,000 fatalities and provoking more 20 million in economic losses.¹

Responding to this depiction, the Santa Cruz Summit on Sustainable Development, established a conformity among states members, which was reaffirmed during the IV Summit of the Americas Mar del Plata (2005)) to guide and elevate interest of topics, projects, and policies on Sustainable Development issues in Latin America and the Caribbean through the celebration of the First Inter-American Meeting of Ministries and High-Level Authorities on Sustainable Development

In reaction, The Department of Sustainable Development/OAS, have directed its energy to the materialization of this meeting, by creating an agenda that include the three main topics on sustainable development, which are economic development, social issues, and environment. Enclosed by this three subjects:

- a) Integrated Water-Resource Management;

- b) Sustainable Agriculture, Sustainable Forestry and Tourism
- c) Managing risk of natural hazards, risk sharing and risk transfer arrangements of Natural Disasters

Each topic is to be studied and analyzed in different workshops, developed by the DSD. This Department will bring experts and specialists of the States Members in each of the areas to contribute with their knowledge and expertise to finally create a series of proposals, and recommendations to be used later on by the Ministers of Sustainable Development. To summarize, each workshop will provide a series of measures, and policy making during the Ministerial sessions.

The Managing risk of natural hazards workshop intends to comprise experts and specialists knowledge to begin the creation of strategic alliances that promote enhancements in the natural hazards management in order to reduce the hazards effects; additionally, to identify policies, project and cooperation agreements that facilitates and increase the assessment of risks. This will provide State Members the ability to act upon these risks, and ultimately lessens the impact of them by the use of the previous mentioned assessment.

On the other hand, to be able to obtain an improved understanding and a broader vision for a risk management system and following with the Summit regulations, the four cross-cutting issues are: public and citizen participation, gender equality, good governance, and inclusion and respect of indigenous people.

B. Background

In the IV Summit of the Americas Mar del Plata (2005), in which the main focus was “Creating Jobs to Fight Poverty and Strengthen Democratic Governance”, several action plans were established through the Declaration and Plan of Action of Mar de Plata (2005) related to natural disasters. In these declarations the member States expressed their concern over disaster risk and the devastating impact of natural disasters on the lives, infrastructure and economies of the hemisphere. These action plans can be implemented through several initiatives that will be developed in the **Managing risk of natural hazards workshop** with the goal of reducing the impact of natural disasters in the region and increasing support for the sharing of information.

Mainly, the Member States of the Organization of the American States, in the Declaration del Mar de Plata, call for “action at the national, regional, and international levels to strengthen disaster management programs.”

On the other hand, in the Plan of Action of the IV Summit of the Americas, Mar del Plata (2005), the Member States of the OAS called for the unity of efforts to “substantially improve the capacity at the national, regional and hemispheric levels for risk mitigation, to implement cost-effective and robust early warning systems, and to enhance disaster recovery and reconstruction capabilities in collaboration with relevant international and regional institutions and the coordinated development of effective public-private catastrophic risk insurances systems”.²

Initiative 1	calls to increased capacity for disaster preparedness
Initiative 2	Development of early warning and risk mitigation systems
Initiative 3	Development of post-disaster recovery and reconstruction
Initiative 4	Financial assistances as appropriate, particularly for disaster-prone countries, to reduce the impact of disasters.
Initiative 5	The member states also support efforts under way to explore private and public sector involvement in comprehensive approaches to catastrophic risk insurance

The Managing Risk of Natural Hazards Workshop will take into consideration the results obtained in the World Conference on Disaster Reduction Kobe, Hyogo, Japan, on January 2005. the conference included in its report a guide for the prevention, preparation and mitigation of natural disasters. The conference drew upon the Plan of Action for 1994 in the "Yokohama Strategy," which established frameworks of action geared towards the reduction and mitigation of impact of natural disasters.

The World Conference on the Reduction of Disasters the strategic objectives were: (i) governance: organizations, law and politics; (ii) risk

identification, assessment, monitoring and early warning systems; (iii) generation of knowledge and education; (iv) reduction of risk factors; (v) preparation of responses and effective reconstruction strategies.

The Department of Sustainable Development, considering the initiatives of the IV and V Summit of the Americas and the World Conference on Disaster Reduction Kobe, Hyogo, Japan, on January 2005, has organized the **"Managing Risks of Natural Hazards workshop: Risk sharing and Risk transfer arrangements of Natural Disasters"** for the First Inter-American Meeting of Ministries and High-Level Authorities on Sustainable Development

The international organizations have been called to "consider as a main issue, in the context of sustainable development, the reduction of impact of natural disasters as an important element within the international development goals included in the millennium declaration. Therefore, each effort should be geared towards humanitarian assistance so that future risks and vulnerabilities may be reduced to their least possible form."³

C. Managing risks of natural hazards workshop description

C.1 Date and venue workshop

The "Managing Risks of Natural Hazards workshop: Risk sharing and Risk transfer arrangements of Natural Disasters" will take place on April 18-19, 2006 at the Courtleigh Hotel & Suites, New Kingston, Jamaica.

C.2 Objectives of the workshop:

It is expected that the international experts will analyze the themes of policies and operational projects that will address the vulnerability of populations and their economic and social infrastructure with the following specific objectives:

- (i) Identify projects, policies and cooperative partnerships that make progress in both risk mitigation and risk transfer,
- (ii) Strengthen economic analysis associated with the benefits and costs of risk mitigation and risk sharing,
- (iii) Identify best practices in the adoption of risk mitigation technical standards,
- (iv) Identify specific risk sharing and risk transfer initiatives at the regional and sub-regional levels, including through insurance pooling.

C.3 Agenda

Managing Risks of Natural Hazards Workshop:

"Risk sharing and Risk transfer arrangements of Natural Disasters"

Objective and Context: The objective of the small, informal workshop of experts is to highlight priority areas in relation to reducing the risks of natural disasters. Recommendations from the workshop will be conveyed to the First Inter-American Ministerial Meeting on Sustainable Development, to be hosted by the Government of Bolivia on October 5-6, 2006. Among the themes of the ministerial meeting will be risk reduction measures at the regional level, to mitigate the impacts of natural disasters.

A particular focus of the workshop will be to identify partnerships at the regional and sub-regional levels, including identifying specific priorities, gaps and opportunities in capacity building, information exchange and technical cooperation in relation to risk reduction. Given the overarching focus of the OAS Ministerial meeting will be sustainable development, a key priority will entail the identification of options to mainstream risk reduction measures into sector-specific planning, as well as cross-cutting fiscal, developmental and economic planning approaches.

Given the need to integrate risk reduction measures into specific sectors, the workshop will examine a limited number of sectors within which risk reduction efforts are underway.



These will include the tourism, agriculture, and water management infrastructure. The workshop will examine how best practices in sector-specific risk mitigation can be extrapolated into other sectors.

Finally, the workshop will recommend opportunities for collaboration among OAS member states in the area of risk reduction. This can include opportunities to enhance the exchange of information and related coordination among different regional organizations, such as the recently-launched Comprehensive Disaster Management plan under CDERA and other examples from North, Central, and South America
