VENUE OF THE GENERAL ASSEMBLY

The fifty-second regular session of the General Assembly of the Organization of American States (OAS) will be held from October 5-7, 2022, in Lima, Peru. The sessions will be held at the Lima Convention Center (LCC), located at *Calle la Arqueología* # 206, *San Borja*, Lima.

The Dialogue of the Heads of Delegation, the Secretary General, the Assistant Secretary General and the Representatives of Civil Society Organizations, workers, the Private Sector and Other Social Actors ("Dialogue") will take place in Lima, Peru, on October 5, 2022, from 9:00 a.m. to 1:00 p.m. All duly accredited people, representatives of civil society organizations, will have access to the Dialogue.

Due to space limitations and the number of people registered, access to the General Committee will be limited to one person per coalition. We ask Coalition coordinators to confirm the name of the person.

A limited number of representatives of civil society organizations will be allowed access to the plenary sessions. Later we will inform the methodology for admission.

COALITIONS

• Since 2017, civil society organizations and social actors have been organized in Coalitions of groups and representatives with similar positions, who choose their spokespersons to represent them in the Dialogue.

- Each Coalition determines its membership and work methodology. Organizations interested in joining a Coalition should contact its Coordination directly (see Annex 3 for contact details).
- The Civil Society Relations Section will communicate directly with the Coalitions coordinators regarding the methodology to be followed for their participation in the Dialogue.

PROCEDURE TO APPLY TO ATTEND THE GENERAL ASSEMBLY

1. Civil Society Organizations, Indigenous Peoples and Communities of African Descent:

In accordance with the Rules of Procedure of the OAS General Assembly, the civil society organizations who wish to attend the General Assembly under the category "Civil Society Organization" submitted the corresponding request to the OAS General Secretariat by **Friday**, **August 12**, **2022**, **at 5:30 p.m.**, **Washington D.C. time**.

2. Workers:

The OAS General Secretariat coordinates with the Trade Union Technical Advisory Council (COSATE, for its acronym in Spanish) —which comprises trade-union confederations from the region- all aspects related to workers' participation in the General Assembly. The Trade Union Confederation of the Americas (TUCA) supports this process.

Invitations to workers organizations are made through COSATE, which internally selects its representatives and spokespersons. The Chair of COSATE will send the GS/OAS a list of the workers representatives who are to attend the General Assembly. Only persons whose names appear on that list may receive accreditation.

The registration of Civil Society Organizations in the Organization of American States is free; as is the registration for attending and participating in meetings of the General Assembly of the Organization.

ONLINE REGISTRATION FOR APPROVED ORGANIZATIONS

Civil society organizations and social actors that have been approved according to the aforementioned list, must register online through the link www.oas.org/52AG in the "Registration of participants" section under the category corresponding to: "Civil Society Organization", "Indigenous Peoples and Afro-descendant Communities", "Worker Organizations" or "Private Sector".

The designated representatives of civil society organizations must be accredited with the names and emails provided to the Section for Relations with Civil Society; otherwise, they will not be able to complete their accreditation.

ACCREDITATION AT THE GENERAL ASSEMBLY VENUE

The participants will be able to collect their accreditations from Sunday, October 2, 2022, in the Mochica Room of the Ministry of Culture; entrance through Av. Javier Prado Este 2465, San Borja from 8:30 a.m. to 5:30 p.m., continuously.

For security reasons, accreditation badges will be required at all General Assembly Activities.

To receive their accreditation badges, participants will be required to bring a copy of the confirmation email they will receive after their online registration, as well as their official invitation letter and identity papers.

FEATURES OF THE DIALOGUE WITH CIVIL SOCIETY ORGANIZATIONS AND OTHER ACTORS

The main activity planned at the General Assembly for Civil Society is the "Dialogue of Heads of Delegation, the Secretary General, the Assistant Secretary General and Representatives of Civil Society Organizations, Workers, the Private Sector and Other Social Actors".

Venue: San Borja Room, first floor of the Lima Convention Center (Entrance through Calle Comercio 160, San Borja).

Date and Time: Wednesday, October 5, 2022, 9:00 a.m. to 1:00 p.m.

This activity seeks to provide civil society, social actors and workers an opportunity to interact with the Heads of Delegations of the OAS Member States, the Secretary General and Assistant Secretary General. The objective of the event will be to foster an open and proposition-based dialogue between social actors, Member States and the General Secretariat.

Speaking Time: Speaking time will be limited to 3 minutes per Coalition. Once the maximum speaking time is reached, the microphones will be turned off. Along these lines, we invite coalitions and social actors to draft their interventions accordingly. In the coming days, we will send detailed information to the Coalitions about their participation.

2. Requirements for entering and leaving the country

The requirements to enter Peru are as follows:

• Passport valid for at least six months and, if applicable, a valid visa for Peru.

<u>Appendix 1</u> contains a list of countries exempt from visa requirements for diplomatic, special, official, service, and ordinary passports. Appendix 1 also gives contact details for Peruvian Consulates in those countries for which a visa may be required.

- Non-resident foreign passengers for whom Peru is a final destination, regardless
 of their country of origin, must be vaccinated against COVID-19 according to the
 vaccination schedule of their country of origin or, otherwise, must provide a
 negative RT-PCR test result, issued by a health institution in the country of origin
 up to 48 hours before boarding (Supreme Decree No. 069-2022-PCM).
- Health Affidavit, pre-filled and signed by each passenger (https://e-notificacion.migraciones.gob.pe/dj-salud/).
- Luggage Affidavit provided by the airline, if carrying items from the list of goods to be declared (https://bienvenidoalperu.sunat.gob.pe/declarar.html). From this link, information can be found regarding goods and items that can be brought into Peru duty-free: https://bienvenidoalperu.sunat.gob.pe/ingreso.html. Accordingly, it should be borne in mind that the privileges set forth in the Vienna Convention on Diplomatic Relations shall be applicable to the relevant individuals.

3. Transportation

The Government of Peru will offer courtesy collective transportation from the suggested hotels to the General Assembly venue and vice versa, where there is a greater concentration of representatives. The routes and schedules will be published in due course through the website: www.oas.org/52AG.

4. Working and document Languages

The Dialogue will have simultaneous interpretation in the four official languages of the Organization: Spanish, English, French and Portuguese, as well as American Sign Language.

For reasons of ecological efficiency, the printing of documents will be limited. In this sense, the participants are requested to keep their documents during all the sessions, as well as to obtain the documents of the General Assembly through the website: www.oas.org/52AG

5. Weather

On average, the temperature around the time of the Lima General Assembly ranges approximately between 18° and 25° C (64.4 to 77° F).

6. Currency

The monetary unit of the Republic of Peru is the Sol. The representative market rate ranges between S/. 3.85 and S/.3.90 soles per US dollar*. International credit cards are accepted in most hotels and shops in general. Currency exchange can be done at the airport, banks, exchange houses and hotels.

*This exchange rate is referential, due to exchange rate fluctuations.

7. Time zone and telephone area codes

Lima's time zone is GMT - 5

The country's international telephone code is +51.

8. Opening hours

Shops are open from 9:00 a.m. through to 8:00 p.m. Monday to Friday, and from 9:00 a.m. to 5:00 p.m. on Saturday. Large shopping centers are open seven days a week until 8:00 p.m.

Banks are open Monday to Friday, from 9:00 to 3:00 p.m.

Most government offices operate from 8:30 a.m. to 5:30 p.m., Monday to Friday.

9. Electricity

The electric current is 220 volts AC.

10. Medical assistance

The government will ensure that ambulance services are available with the necessary healthcare personnel for any medical care or first aid that participants may require during the course of the General Assembly.

11. COVID-19 information

The Health Affidavit must be turned in upon arrival in Peru. Peruvians and resident foreigners 18 years of age or older, for whom Peru is the final destination as passengers - regardless of the country of origin - must certify that they have been administered the three doses of COVID-19 vaccine in Peru or abroad; likewise, individuals between 12 and 17 years of age must certify that they have been administered the first and second doses of the COVID-19 vaccine in Peru or abroad. Non-resident foreign passengers whose final destination is Peru, regardless of their country of origin, must be vaccinated in accordance with the vaccination schedule of their country of origin. If they have not had the aforementioned vaccines, they may produce an RT-PCR molecular test with a negative result, issued by a health institution in the country of origin up to 48 hours before

boarding at their point of origin. Children younger than 12 only need to be asymptomatic to board.

Individuals experiencing symptoms upon arrival in the country will be placed in mandatory isolation, according to applicable regulations. The National Health Authority is authorized to perform COVID-19 diagnostic tests on passengers arriving in the country and in order to establish additional health measures for positive cases.

Supreme Decree No. 063-2022-PCM stipulates furthermore that a KN95 face mask must be worn or, otherwise, a three-ply surgical face mask and, on top of that, a common (cloth) face mask, in order to move about on public roads and in enclosed spaces. Pursuant to Ministerial Resolution No. 319-2022/MINSA, the use of face masks in open places is optional in Lima, provided that physical or personal distancing is observed.

APPENDIX 2

RULES OF PARTICIPATION IN THE VENUES AND ACTIVITIES OF THE GENERAL ASSEMBLY

A large number of representatives from civil society and other social actors will participate in the 52nd General Assembly of the Organization of American States (OAS), which will provide with an open forum for dialogue and exchange of views of this sector with OAS Member States.

The organizers of the General Assembly want this to be a safe and productive space of dialogue for all participants. To this end, this document sets forth the rules of conduct expected from each one of the participants at the General Assembly:

- 1. We are committed to having diverse points of view represented, as well as rich and constructive discussions based on plurality and respect. Thus, participants must commit to making these working forums welcoming and respectful places for all participants, regardless of their national origin, ethnicity, gender, gender identity and expression, age, sexual orientation, disability, or physical appearance.
- 2. No harassment of any kind or disrespect toward General Assembly participants (Member State Delegates, Civil Society) or organizers will be tolerated. Examples of harassment or disrespect include: offensive comments, verbal threats, intimidation, stalking, harassment through photographs or recording or through phone calls or texts, disruptive behavior at sessions, events, or inside and outside of the bathrooms and unwanted physical contact.
- 3. Banners, flags or other objects that promote a particular position on an issue are not allowed inside the venue.
- 4. **During the Dialogue**, representatives of civil society and social actors **must** remain in their seat at all times.
- 5. During the **Plenary and General Committee sessions**, representatives of civil society and social actors can be present as **observers**. This implies that they may not approach or interrupt the work of the Delegates of the Member States for any reason.
- 6. Access to the designated spaces of the General Assembly will be strictly reserved for accredited persons. The accreditations will be delivered only to persons whose organizations have been approved by the Permanent Council and who have received an official letter of invitation from the General Secretariat of the OAS.
- 7. In the event a participant violates these rules, the 52nd General Assembly organizers reserve the right to bar participants involved from remaining, inviting them to leave without a right to continue to participate, as well as to consider adopting the measures they deem appropriate to safeguard the principles of pluralism and respect.
- 8. **Participants must always follow these rules of participation**. If participants are requested to desist from any inappropriate behavior, they must immediately comply with the request or they may be removed from the venue.
