- To apply for the OAS-UTech scholarship, applicants must first be accepted to the UTech program.

- UTech will evaluate the applicants that comply with requirements to be admitted

- Only applicants who have been unconditionally accepted to the UTech program will be considered for the OAS scholarship.

## **EXPENSES NOT COVERED BY THIS SCHOLARSHIP:**

Expenses not covered by the scholarship, and which are the sole responsibility of the scholarship recipients, are:

### **FINANCIAL RESPONSIBILITY OF SCHOLARSHIP RECIPIENTS**

In addition to the remaining program fees of USD \$ 8,760 (*estimated*), the scholarship recipients will also be responsible for payment of research expenses and any other costs not covered by the scholarship.

These above expenses listed as financial responsibility shall be the sole and exclusive responsibility of the scholarship recipients and the scholarship recipients will be responsible for payment of the remaining tuition fees and any other costs as needed to UTech, Ja.

Scholarship benefits are subject to the academic performance of the scholarship recipients. In order to receive these benefits, the scholarship recipients should not be reported with an unsatisfactory academic performance due to absences or failing courses.

## ▼ ELIGIBILITY:

To be considered for this scholarship opportunity, an applicant must:

- Provide an unconditional admission letter from UTech, Ja.;
- Submit a complete scholarship application with all required supporting documents; and
- Be a citizen and/or permanent legal resident of any [OAS member state](#), except *Jamaica*.

The following applicants are ineligible:

- ⊗ Current OAS scholarship recipients;
- ⊗ GS/OAS staff and their immediate relatives or GS/OAS consultants; and
- ⊗ OAS Permanent officials and their immediate relatives.

## ▼ SCHOLARSHIP SELECTION CRITERIA:

- ✓ The merits and overall credentials of the candidate, including his/her academic and professional background;
- ✓ Geographical distribution of the applicants, taking into account the greater needs of the smaller and relatively less developed economies;
- ✓ Applicants whose essays portray the highest potential for impact upon return to their countries of origin; and
- ✓ Gender diversity.

## ▼ SCHOLARSHIP SELECTION PROCESS:

**Selection Committee** UTech, Ja. and the OAS will select the scholarship awardees, based on the [criteria](#) listed above. The names of the scholarship awardees will be published in May 2023 at [www.oas.org/scholarships](http://www.oas.org/scholarships).

**Notification of selected candidates** The OAS will contact selected candidates by email with the scholarship offer and instructions for the scholarship acceptance form. **Applicants who are not selected will not be contacted.**

## ▼ DUTIES AND RESPONSIBILITY OF THE SCHOLARSHIP RECIPIENT:

---

- ✓ This scholarship will be formally awarded only after the selected awardees have signed an OAS/UTech, Ja Acceptance Form, in which the awardees formally accept the scholarship and agree to its terms and conditions.
- ✓ Refrain from activities that are inconsistent with the status of an OAS Scholarship recipient, abiding by the regulations referred to in this Acceptance Form.
- ✓ Comply with all the academic guidelines and admission requirements requested by UTech, Ja and submit to the updates of these guidelines and requirements made by the academic authorities at UTech, Ja.
- ✓ Comply with the provisions indicated in the "Financial responsibilities of awardees."
- ✓ To retain the scholarship, awardees should not have low academic performance (GPA must be at least equivalent to 3.0/4.0), due to absence from the program of study and/or course failure.
- ✓ The scholarship can be declined by the awardee before the start date of the program of study without financial penalties. However, if s/he declines the scholarship after that date without proof of force majeure, the OAS and UTech, Ja may require the awardee to reimburse all funding granted to her/him with the scholarship at the time in which the declination is processed.
- ✓ Commitment to remain their sponsoring country or legal residence in one of the OAS member states, or at an international organization, for at least the length of the duration of the scholarship. Failure to comply with this commitment, the GS/OAS and/or the UTech, Ja could seek reimbursement for the total value of the scholarship awarded.
