GOVERNMENTS OF COLOMBIA AND THE UNITED STATES LAUNCH CONNECTING THE AMERICAS 2022

This new ECPA initiative will foster the exchange of best practices on energy efficiency between the two nations

At the Sixth Summit of the Americas in Cartagena, Colombia, leaders from the United States, Colombia, and throughout the Western Hemisphere pledged to seek universal access to electricity over the next decade through enhanced electrical interconnection. This initiative developed by Colombia and called "Connecting the Americas 2022," will provide access to reliable, clean, and affordable electricity for 31 million people in the region. During the preparatory meetings, both governments agreed interconnected power systems allow for greater integration of renewable energy resources and power exchanges among countries with varying climates. Additionally, intercon-

nection also expands power markets— creating economies of scale which can attract private investment, lower capital costs and reduce electricity costs for consumers.

At the third high-level dialogue the Santos Administration and U.S. Department of State officials reaffirmed their bilateral cooperation to benefit citizens of both countries and strengthened the region as a whole. Deputy Secretary of State, William J. Burns highlighted Colombia's remarkable progress and applauded Colombia's support for ECPA's newest initiative.

The U.S. and Colombia are working with the Organization of American States (OAS), the

Inter-American Development Bank and the World Bank to support this initiative. Working through ECPA and other mechanisms, Connecting the Americas 2022 will tap the expertise, technology, and capital of countries, regulator, utilities, the private sector, and multilateral organizations.

part, the Permanent Representative of Colombia to the hemispheric organization, Ambassador Andrés González Díaz, recalled that the issue of energy resources was one of the pillars of the Sixth Summit of the Americas held in Cartagena de Indias last April. Matthew Rooney, Deputy Assistant Secretary of Western Hemisphere Affairs in the U.S. State Department, said energy security and climate change "are urgent global challenges that impact us all." At the panel discussion, regional specialists reviewed new projects implemented for sustainable development and wise energy use. The session also included networking and a Clearinghouse presentation on new communication tools to promote ECPA initiatives.

CLEARINGHOUSE HOSTS TECHNICAL EXCHANGE ON THERMAL RETROFITTING IN CHILE'S BIO BIO REGION This event was part of the Energy Efficiency Group Initiative

The Ministry of Energy of Chile and Mexico's National Commission for the Efficient Use of Energy, with support from the Department of Sustainable Development at the OAS, joined efforts to share experiences in thermal retrofitting of dwellings.

The Energy Efficiency Agency of Ministry of Energy of Chile and other Chilean entities shared experiences in thermal conditioning and energy efficiency in housing and the implementation of the ISO 50001 standard on energy management systems. The exchange included analyzing the overall energy landscape of the Bio Bio region (with emphasis on residential buildings) and on-site presentations and a side visit. As a result, the Working

group will send government officials from El Salvador to Mexico for a technical exchange mission on efficient conduction. Additionally, Mexico's INFONAVIT will provide technical support to Chile, Panama, Peru in the field of green mortgages.

Manager at the OAS Department of Sustainable Development (OAS/DSD). The training course, offered by the Environmental Engineering and Technology for Sustainable Development Research Group of the University CEU San Pablo based in Madrid, Spain offered a great opportunity to work together with experts in Cradle-to-Cradle (C2C) on translating C2C philosophy into practice by integrating different views and disciplines as

the use of Life cycle Analysis. This training is one of multiple activities of the National Closed Looped Cycle Production Work Plan supported by the consortium comprising the OAS/DSD, the National Cleaner Production Center of Colombia, the Cradle to Cradle Expo Lab of the Netherlands, and the U.S. based McDonough Braungart Design Chemistry (MBDC), with funding from the U.S. State Department.
