Nora Lusting
Samuel Z. Stone Professor of Latin American Economics
Tulane University



Nora Lusting is Samuel Z. Stone Professor of Latin American Economics at Tulane University (New Orleans, LA) and a Nonresident Fellow at the Center for Global Development and the Inter-American Dialogue (Washington, DC). Her current research focuses on assessing the incidence of taxation and social spending in over twenty countries around the world, and on the determinants of income distribution dynamics in Latin America. She is a founding member and past president of the Latin American and Caribbean Economic Association (LACEA) and was a co-director of the World Bank’s World Development Report 2000/1, *Attacking Poverty*. She is currently the director of the Commitment to Equity project, editor of the *Journal of Economic Inequality’s Forum* and Vice-Chair of the Board of Directors of the Global Development Network (GDN). Lusting received her doctorate in Economics from the University of California, Berkeley.

Paulo Vannucchi is a political and union consultant. He studied journalism at the University of Sao Paulo, there he received a Master Degree in Political Science. He was member of the team that conducted the investigation “Brazil, Never Again”; was co-funder of the Cajamar Institute; and was a political adviser to the National Office of the Workers Party of Brazil. He was also served as Executive Secretary of the National Coordinating Committee of the Lula for President Campaign in 1994 and 2002. He held various posts, including that for President, at the Citizenship Institute, between December 21, 2005 and December 31, 2010, as well as President of the

Human Rights Defense Council; the National Commission for the Eradication of Slave Labor; and of the National Committee to Prevent and Combat Torture in Brazil. He was elected member of the Inter American Commission of Human Rights during the 43rd regular session of the OAS General Assembly in June 2013 for the prescribed four-year term, which began on January 1, 2014.
