Resolution AG/RES. 2991 (LII-O/22), "Promotion and Protection of Human Rights," adopted by the General Assembly in October 2022, requested the Permanent Council to hold, "in the first quarter of 2023, an eleventh special meeting of the CAJP on good practices by each official public defender institution in the region aimed at ensuring access to justice for mental health service users."
