### SIXTH SPECIAL MEETING ON AUTONOMOUS OFFICIAL PUBLIC DEFENDERS AS A GUARANTEE OF ACCESS TO JUSTICE FOR VULNERABLE GROUPS

In resolution AG/RES. 2908 (XLVII-O/17) "*Promotion and Protection of Human Rights,*" adopted by the General Assembly on June 21, 2017, the Permanent Council is requested to hold a sixth special meeting of the Committee on Political and Juridical Affairs on autonomous official public defenders as a guarantee of access to justice for vulnerable groups.

The General Assembly requested that this special meeting discuss best practices pursued by each public defense institution in the region for full implementation the Brasilia Regulations regarding Access to Justice for Vulnerable Persons.

The General Assembly further requested that the meeting be held in the first quarter of 2018 to bring together member states and their respective official public legal aid institutions, as well as members of the Inter-American Association of Public Defender Offices (AIDEF), scholars, experts from civil society, and international organizations.
