Resolution AG/RES. 2928 (XLVIII-O/18), "Promotion and Protection of Human Rights," adopted by the General Assembly in June 2018, requested the Permanent Council to hold a seventh special meeting of the Committee on Juridical and Political Affairs on the mechanisms for detention center monitoring that are in place in each official public defender institution in the region.

The General Assembly also requested that the meeting be held in the first quarter of 2019 and attended by the member states and their respective official public defender institutions that provide legal assistance, members of the Inter-American Association of Public Defender Offices (AIDEF), of the Inter-American Commission on Human Rights (IACHR), through its Rapporteurship on the Rights of Persons Deprived of Liberty in the Americas, and experts from the academic community, civil society, and international organizations.
