MINUTES

OF THE THIRTY-EIGTH MEETING OF THE COMMITTEE OF EXPERTS OF THE MECHANISM FOR FOLLOW-UP ON IMPLEMENTATION OF THE INTER-AMERICAN CONVENTION AGAINST CORRUPTION

I. <u>BACKGROUND</u>

In keeping with the schedule for the Sixth Round of Review agreed upon by the Committee of Experts of the Mechanism for Follow-up on Implementation of the Inter-American Convention against Corruption (MESICIC), the Committee's Thirty-Eigth Meeting was held virtually from September 12 to 15, 2022.

II. PROCEEDINGS

Pursuant to Article 34(b) of the Rules of Procedure and within the deadline established in the schedule for the Sixth Round, the Committee received documents from two civil society organizations. These organizations are "Fundación Democracia, Transparencia, Justicia" [Democracy, Transparency, Justice Foundation] of El Salvador, and "Fundación para el Desarrollo de la Libertad Ciudadana" [Foundation for the Development of Civic Liberty] of Panama.

In light of the above and the provisions of Article 35 of the Committee's Rules of Procedure, before beginning the formal meeting, the experts of the MESICIC member states met informally with a representative of the organization "Fundación para el Desarrollo de la Libertad Ciudadana"[Foundation for the Development of Civic Liberty]. Due to last minute unforeseen circumstances, the representative of "Fundación Democracia, Transparencia, Justicia" [Democracy, Transparency, Justice Foundation] of El Salvador was unable to take part in that meeting.

Following the informal meeting with the civil society organization from Panama, the formal meeting of the Committee began, with a speech by the Secretary for the OAS Secreetariat for Legal Affairs, Jean Michel Arrighi.

Pursuant to the first item on the agenda and schedule for this meeting (Annexes I and II), the Technical Secretariat presented a report on the agenda and on the work of the MESICIC.

Under agenda item 2, the Committee considered, in order, the preliminary draft country reports for Panama, Chile and El Salvador.

The Committee proceeded to review the preliminary draft country reports in accordance with Article 25 of the Rules of Procedure. Thus, in each case, the review subgroup presented the content and scope of its preliminary draft report; then, the State Party under review made a brief statement in regard to the draft report; and, finally, the Committee examined the corresponding draft report, with the experts offering observations and comments on the chapters and sections in order.

For each draft report it reviewed, the Committee agreed on modifications, and provided instructions for the corresponding changes to be made and for the revised versions to be submitted to the plenary for consideration and final approval.

As envisaged under item 3 on the agenda, a Special Meeting was held on Anticorruption Training and Education Programs. That special meeting was divided into two parts. During the first panel discussion, representatives of the OAS School of Governance, the United Nations Office on Drugs and Crime (UNODC), the Organization for Economic Cooperation and Development (OECD), the International Anticorruption Academy (IACA), and American University shared information about anticorruption training and education programs provided by their organizations. The electronic copies of those presentations received by the Technical Secretariat of the MESICIC are attached to these minutes (Annexes III, IV, V, and VI).

During the second part of this special meeting, presentations were made by those States that had previously informed the Technical Secretariat that they wished to share with other members of the Committee information regarding the anticorruption training and education programs provided by them. Presentations were given by Argentina, Bolivia, Costa Rica, Chile, the Dominican Republic, Guatemala, Jamaica, Mexico, Panama, Paraguay, Suriname, and Trinidad and Tobago.

The presentations used during the special session, will be posted on the Mechanism's web page to ensure their continued dissemination. On account of its importance, the special session was transmitted by webcast over the official OAS Facebook and YouTube accounts and the official MESICIC Twitter account.

Then, in compliance with agenda item 4, voluntary presentations on best practices were given by the representatives of those States that had previously submitted the standard forms with the relevant information to the MESICIC Technical Secretariat, in keeping with the methodology for the presentation of best practices adopted by the Committee. Best practices were shared by Argentina, Belize, Bolivia, Brazil, Chile, Colombia, Costa Rica, the Dominican Republic, Guatemala, Guyana, Mexico, Panama, and Trinidad and Tobago.

In order to maximize the dissemination of the best practices presented, this session was transmitted by webcast over the official OAS Facebook and YouTube accounts and the official MESICIC Twitter account.

The forms that were previously sent to the MESICIC Technical Secretariat on the best practices presented at this meeting, together with their annexes and the presentations used, are to be published on the Mechanism's web page, in accordance with the methodology adopted by the Committee.

Subsequently, under item 5 on the agenda, the Technical Secretariat presented the "Proposed Indicators to Prevent, Detect and Reduce Impunity related to the Results in the Protection of Whistleblowers and Witnesses of Acts of Corruption in Criminal Matters," prepared by the Technical Secretariat in accordance with the methodology adopted by the Committee in this regard. Following initial considerations by a number of delegations, it was agreed that the representatives of the States would submit to the Technical Secretariat any specific proposals that they might have regarding the texts of the proposed indicators by no later than November 15, 2022.

Based on any proposed changes that the Technical Secretariat receives from the delegations, it shall prepare a revised version of the proposed indicators and distribute it prior to the next meeting of the Committee, to be considered at said meeting. The Committee then addressed the final review of the draft country reports for Panama, Chile, and El Salvador. Following considerations regarding each of

those reports, they were adopted by consensus. The approved texts of these country reports are attached to these minutes (Annex VII).

Under item 6 on the agenda, "other matters":

- 1) The Lead Expert of the United States:
 - a. Announced that his country would host the International Anticorruption Conference (IACC), being organized together with "Transparency International", to be held from December 6-10, 2022. He invited the delegations to participate in that conference and said that they would be receiving the corresponding formal invitations.
 - b. He proposed that the Technical Secretariat present a report on the financial state of the MESICIC at the next meeting of the Committee of Experts.
- 2) The Panamanian expert reported that her country would host the meeting of the Transparency Network, to be held on November 7, 8, and 9, 2022.

Before ending the meeting, the Technical Secretariat read out these minutes, which were then unanimously approved by the plenary of the Committee, together with all the annexes that form an integral part thereof.
