## MASTER'S PROGRAMMES

IACA's master's programmes offer a multidisciplinary study of anti-corruption and compliance. The programmes are designed for professionals and young graduates in the fields of anti-corruption and compliance. IACA's visiting faculty and lecturers include distinguished academics and practitioners in both fields from across the globe. Currently, IACA's master's programmes are delivered in virtual and hybrid formats.

- Master in Anti-Corruption Studies (MACS) (120 ECTS)
  - → Applications are open for admission on a rolling basis until 1 September 2022
- International Master in Anti-Corruption Compliance and Collective Action (IMACC) (120 ECTS)
  - → Applications are open for admission on a rolling basis until 1 September 2022
- Master in Anti-Corruption and Diplomacy (MACD) (90 ECTS)
  - → Application for scholarships are open until 30 June 2022
  - → Applications are open for admission on a rolling basis until 1 September 2022

## NEW in 2022

- Master in Anti-Corruption and Compliance Studies (MACCS) (90 ECTS) in Spanish
  - → Applications are open for admission on a rolling basis until 1 September 2022

IACA allows participation in its master's programmes based on merit, and thus wishes to empower individuals from Least Developed Countries (LDCs) by providing scholarship opportunities. Hence, IACA is looking for member states' and partners' financial contributions to be able to regularly fund qualified candidates from LDCs. #### Dedicated Scholarship Programme in Anti-Corruption and Diplomacy

This Global Programme aims to provide foreign service personnel, staff of international organisations, and NGOs from LDCs with the skills needed to operate in the diplomacy-anti-corruption nexus which will enable them to engage in anti-corruption initiatives on the international level. It will do so by providing merit-based scholarships to IACA and UNITAR's joint MACD and Executive Diploma in Anti-Corruption and Diplomacy (EDACD) programmes.

#### Empowering Women in LDCs through Education and Training

The Global Programme focuses on providing capacity-building activities and empowering women in the civil service in LDCs through anti-corruption education and training to strengthen the fight against corruption in public service delivery. Initially, the Global Programme will focus on women in the public sector and over time will be expanded to other sectors.

# **OPEN TRAININGS**

A series of open trainings designed for individual anti-corruption and compliance practitioners are offered as trainings and seminars ranging from two days to a few weeks. These trainings take place at IACA's campus in Laxenburg, Austria, in various locations worldwide, and online.

#### Summer Academy

This is an annual intensive and interdisciplinary programme that addresses trends and practices in the global anti-corruption agenda and promotes the culture of the reflective practitioner.

#### Regional Summer Academies

These regional programmes are modeled after IACA's annual Summer Academy and designed to address region-specific topics relevant to anti-corruption and compliance professionals.

## Summer School For Students And Young People

Co-organized with the UNODC, this seven-day regional programme builds ethical skills and mindsets for students and young individuals, while raising awareness toward the values and principles of integrity, ethics, and anti-corruption.

## Executive Diploma In Anti-Corruption And Diplomacy

Combining IACA's knowledge of anti-corruption and UNITAR's expertise in diplomacy, this programme offers a series of interdisciplinary modules with multicultural contexts that explore the connection between countering corruption and diplomacy. It also offers courses that provide comprehensive insight into anticorruption, a foundation of cyber-security issues for diplomats, and knowledge and skills for multilateral diplomacy.

#### "Best Of" Seminars

This programme is aimed at improving the design, management, and sustainability of efforts made by anticorruption professionals. Each seminar is delivered by a prominent specialist who shares the "best of" his or her most recent work.

#### Power Of The Pen

Journalists are on the frontline of reporting on corruption and its devastating impact on global development. The Power of the Pen Training will bring together journalists from the Sub-Saharan region that hold the common objective of investigating, addressing, and reporting on corruption.

## Promoting Ethics and Integrity Through Education Joint IACA-UNODC GRACE Initiative

IACA and the United Nations Office on Drugs and Crime (UNODC) have joined forces to expand cooperation with academia, tertiary education institutions, and other international organizations, and to promote practiceoriented and interdisciplinary anti-corruption, ethics, and integrity education. This initiative also supports a research-based fellowship for young professionals with a particular focus on female participation.

## TAILOR-MADE TRAININGS

IACA's tailor-made trainings are specially designed to respond to the unique anti-corruption and compliance challenges faced by individual organizations, such as government ministries, national anti-corruption authorities and audit institutions, and private and state-owned companies. Some of our previous tailor-made trainings include:

# ONLINE TRAININGS

IACA's online trainings include a compilation of resources on various anti-corruption and compliance topics for professionals with different levels of experience working in the public and private sectors, international organizations, non-governmental organizations, and media, as well as for academics, researchers, and students. The content is offered in various formats and languages. Besides the options offered with a fee, participants can also enroll in free-of-charge trainings.

#### Self-Paced Massive Online Open Courses (MOOCs)

These courses are designed for individuals who want to learn on their own time and schedule. They focus on topics such as conflict of interests in the public sector, asset disclosure, journalism and the fight against corruption, ethics and integrity management, anti-corruption compliance programmes, cybercrime and electronic evidence, etc.

#### Open Online Trainings (OOTs)

These are instructor-led professional courses in various topics related to anti-corruption, such as anticorruption compliance, corporate internal investigation, whistleblowing and whistleblower protection, ethics, fraud prevention, etc. They are offered in several languages: English, German, Portuguese, Russian, and Spanish.
