#### SECOND AMENDMENT TO THE SUPPLEMENTARY AGREEMENT

#### BETWEEN

# THE GENERAL SECRETARIAT OF THE ORGANIZATION OF AMERICAN STATES, THROUGH THE DEPARTMENT OF HUMAN DEVELOPMENT, EDUCATION AND EMPLOYMENT

#### AND

#### MIU CITY UNIVERSITY MIAMI

#### **FOR**

#### THE OAS-MIU PAEC SCHOLARSHIP

The Parties, the General Secretariat of the Organization of American States ("GS/OAS"), through its Department of Human Development, Education and Employment ("DHDEE"), and MIU City University Miami ("MIU"),

#### **CONSIDERING:**

That on August 20, 2020, the Parties signed the Supplementary Agreement between the GS/OAS through the DHDEE and MIU for the OAS-MIU PAEC Scholarship ("Supplementary Agreement"); and on August 06, 2021, the Parties signed the First Amendment to the Supplementary Agreement; and

That Article 7.3 of the Supplementary Agreement provides for its amendment by way of a writing signed by the duly authorized representatives of both Parties,

#### THE PARTIES HEREBY AGREE:

#### 1. Article 2.2. is hereby amended to read in its entirety as follows:

To be considered for the OAS-MIU PAEC Scholarship, the candidate must apply and be admitted to the University and apply for the OAS-MIU PAEC Scholarship through the University. The deadline to apply for the intake/term of the OAS- MIU PAEC Scholarship are the deadlines published on the Open Announcement section of OAS website https://www.oas.org/en/scholarships/.

An applicant must be able to present a University acceptance letter and meet other application requirements by the applicable deadline.

### 2. Article 3.1 is hereby amended to read in its entirety as follows:

Subject to the terms and conditions established herein, the University shall award each Scholarship Recipient a tuition waiver in the amount of twenty percent (20%) of the published tuition amounts below for the applicable official studies Program and sixty percent (60%) of the published tuition amounts below for the applicable Continuing Education Program in effect at the time the Scholarship Recipient applies to the University. The University shall provide the tuition waiver in accordance with its usual policy and procedures for awarding tuition waivers and shall have no obligation hereunder to make a financial contribution directly to any Scholarship Recipient.



# 3. Article 3.2.a) is hereby amended to read in its entirety as follows:

a. 80% of the remaining tuition cost for official degrees and 40% of the remaining tuition cost for Continuing Education Programs,

# 4. Anex I, 1.1.a) is hereby amended to read in its entirety as follows:

The Scholarship Recipient:

Shall receive a tuition waiver of twenty percent (20%) of the annual tuition cost for the duration of their Program of Study for the official degrees and a tuition waiver of sixty percent (60%) of the annual tuition cost for the duration of their Program of Study for the Continuing Education Programs.

# 5. Anex I, 2.1.a) is hereby amended to read in its entirety as follows:

- a. 80% of the remaining tuition cost for official degrees and 40% of the remaining tuition cost for Continuing Education Programs,
- **6.** All terms and conditions of the Supplementary Agreement and its First Amendment that are not inconsistent with this Second Amendment thereto shall remain in full force and effect.
- 7. This Second Amendment to the Supplementary Agreement shall enter into force on the date of the last signature of the representatives of the Parties.
- 8. This Second Amendment to the Supplementary Agreement shall be attached as an Annex to the Supplementary Agreement and shall be read as one document with the same legal effect.
