SECOND AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING

BETWEEN

**THE GENERAL SECRETARIAT OF THE ORGANIZATION OF AMERICAN
STATES THROUGH THE DEPARTMENT OF HUMAN DEVELOPMENT,
EDUCATION AND EMPLOYMENT**

AND

**INTERNATIONAL TRAINING CENTRE OF THE INTERNATIONAL LABOR
ORGANIZATION**

The Parties to this Amendment, the General Secretariat of the Organization of American States ("GS/OAS"), through its Department of Human Development, Education and Employment ("DHDEE"), and the International Training Centre of the International Labor Organization ("ITC-ILO"),

CONSIDERING:

That on April 24, 2017, the Parties signed a Memorandum of Understanding between the GS/OAS, through its DHDEE, and the ITC-ILO for the OAS-ITC-ILO Scholarship ("MOU") and the First Amendment to the MOU on May 7, 2018;

That the Parties wish to modify and amend the MOU for the OAS-ITC-ILO Scholarship during the Academic Year 2019-2020; and

That Article 10.5 of the MOU provides for amendments to the MOU by way of a writing signed by the duly authorized representatives of both Parties,

HEREBY AGREE:

I. Article 1.3 of the MOU is hereby amended and replaced with the following:

1.3. A total of ten (10) OAS-ITC-ILO Scholarships will be awarded as follows:

- a. two (2) scholarships in the Master's in World Heritage and Cultural Projects for Development in English;
- b. three (3) scholarships in the Master's in Social Innovation for Development;
- c. two (3) scholarships in the Master's in Management of Development in English; and
- d. two (2) scholarships in the Master in Applied Labour Economics for Development in English.

1.3.1. The number of OAS-ITC-ILO Scholarships per Program may be increased or decreased based on the number of qualified applications received per Program, when both Parties are in agreement. The GS/OAS and ITC-ILO will decide on the

redistribution of the OAS-ITC-ILO Scholarships per Program during the selection of Scholarship Recipients.

II. Article 1.5 of the MOU is hereby amended and replaced with the following:

1.5 To qualify for the OAS-ITC-ILO Scholarships, candidates must apply to one of the Programs and the OAS-ITC-ILO Scholarship separately. The application deadline of the OAS-ITC-ILO scholarship is June 10, 2019.

III. The table in Article 1.6 of the MOU is hereby amended and replaced with the following:

IV. Article 2.2 of the MOU is hereby amended and replaced with the following:

2.2. The GS/OAS shall cover € 2.100 (two thousand one hundred Euros) or the equivalent in Euros of no more than USD 2.700, whichever amount is lower, of the total tuition cost of each Scholarship Recipient. The ITC-ILO shall cover with its funds € 2.100 (two thousand one hundred Euros) of the total tuition costs of each Scholarship Recipient.

V. Article 3.3 of the MOU is hereby amended and replaced with the following:

3.3. The GS/OAS shall pay ITC-ILO € 2.100 (or the equivalent of no more than USD 2.700, whichever amount is lower) per Scholarship Recipient to be used towards the total tuition costs of each of the ten (10) Scholarship Recipients registered in the Programs.

VI. Article 3.4 of the MOU is hereby amended and replaced with the following:

3.4. To receive this payment, the ITC-ILO shall submit the corresponding invoice, for a one-time payment, no later than October 30, 2019, to:

VII. Article 5.1 of the MOU is hereby amended and replaced with the following:


