Dear Dr. Ochoa,

In reference to the Memorandum of Understanding dated September 12th, 2019 (MOU) between the General Secretariat of the Organization of American States (GS/OAS) and the Regents of the University of California on behalf of its Riverside campus (UCR), in which the two institutions (the Parties) agreed to collaborate in the growth of the innovation and entrepreneurship ecosystem in Latin America and the Caribbean and assist with bringing technologies out of the lab at universities and research institutions into the marketplace through capacity building, mentoring, technology assistance and training programs, the Parties shall undertake the following activities within the scope of the MOU:

1. Collaborate in the delivery of training and follow up to the program “*HUB of Innovation and Entrepreneurship for Dominica*” (the Program) to be held from October 4 to 9, 2020. UCR will provide technical and analytical support, including two presentations on business fundamentals and entrepreneurship ecosystems as well as three mentoring sessions with participants of the Program, including guidance and materials to support the implementation of the Program and feedback to continue the collaboration with the Dominica Government and stakeholders of Dominica and the Caribbean. The presentations by two UCR experts will cover key elements of starting a business and strategies to develop technology-based entrepreneurship strategies, case studies with HUB teams, tools for commercialization, transfer, licensing, marketing and spin out technologies.
2. UCR shall conduct its obligations under this Letter online through virtual platforms provided by the GS/OAS to support training and mentoring for Program participants.

3. The “HUB of Innovation and Entrepreneurship” is a training mentoring program supported by the OAS Committee on Science and Technology (COMCYT). HUB participants for the program in Dominica include 33 entrepreneurs selected by the OAS and partner institutions in Dominica.

Upon signature of this Letter by the Parties, the GS/OAS shall pay the amount of USD 10,000 (Ten thousand U.S. Dollars) to UCR to cover the cost associated with the Program activities described above.

The payment will be carried out via wire transfer to the general holding account of the UCR to further credit to the Office of Technology Partnerships as indicated below:


