TWENTY-SECOND ARTICLES OF AMENDMENT

Pursuant to Article 10.1 of the Memorandum of Understanding between the General Secretariat of the Organization of American States (GS/OAS), through the Executive Secretariat for Integral Development (SEDI), and the Young Americas Business Trust (YABT) concerning the execution of activities under the program "The OAS Private Sector Forum and the E-SME Program" (hereinafter the MOU) signed on August 10, 2010 and the subsequent amendments to the MOU, the duly authorized representatives of the Parties under the MOU agree to the following:

- 1.4. As part of the execution of the MOU, the Parties will consult and determine if further contributions are required and will provide for an additional amendment in writing to the MOU as required by Article 10.1.
- 1.5. These Articles of Amendment have been agreed upon in writing by the coordinators and authorized representatives of the Parties and transmitted by electronic mail as provided for in the MOU in Articles 8.2, 10.1 and 10.2. All other terms of the MOU remain in full force and effect.
