FIRST AMENDMENT TO THE COOPERATION AGREEMENT

BETWEEN

**THE GENERAL SECRETARIAT OF THE
ORGANIZATION OF AMERICAN STATES,

GALILEE INTERNATIONAL MANAGEMENT INSTITUTE - ISRAEL

The Parties to this First Amendment (the "Amendment"), the General Secretariat of the Organization of American States (hereinafter "GS/OAS"), a public international organization, with headquarters at 1889 F Street N.W., Washington, D.C. 20006, United States, through its Department of Human Development, Education and Employment (hereinafter "DHDEE"), represented by Kim Osborne, Executive Secretary of the Executive Secretariat for Integral Development ("SEDI");

The Pan American Health Organization (hereinafter "PAHO"), the specialized agency for health of the Inter-American system and regional office for the Americas of the World Health Organization, located at 525 Twenty-third Street, N.W., Washington, D.C., 20037, represented by Dr. Carissa F. Etienne, Director; and

The Galilee International Management Institute - Israel ("GIMI"), a non-governmental organization founded in accordance with the provisions of the laws of Israel in 1987, with its registered office at 1 Main Street, Nahalal, Israel 10600, represented by Dr. Joseph Shevel, President, who is authorized to sign this Agreement on behalf of GIMI;

Considering

That on September 20, 2019 the GS/OAS, PAHO, and GIMI signed a Cooperation Agreement ("GS/OAS-PAHO-GIMI Agreement") to jointly promote scholarship opportunities for citizens from the Organization of American States ("OAS") and PAHO Member States in programs in the field of health at GIMI;

That the Parties wish to modify the following points in the Agreement: the number and type of scholarships offered; the courses offered; the scholarship application deadline; the contribution amounts by the Parties; and to extend the expiration date of the Agreement, and

That Article 9.3 of the GS/OAS-PAHO-GIMI Agreement provides for its amendment by way of a written document signed by the duly authorized representatives of both Parties,

THE PARTIES HEREBY AGREE to modify the GS/OAS-PAHO-GIMI Agreement in the following terms:

1. Article 1.1. is hereby amended to read in its entirety as follows:

The purpose of this Agreement is to establish the terms and conditions for the co-sponsorship of twenty-five (25) scholarships (also referred to as Fellowships within the PAHO system) for certificate courses offered by GIMI, under PAEC and the PAHO Human Resources for Health Training and Fellowships program (“OAS-GIMI-PAHO Scholarship”) and forty-five (45) scholarships co-sponsored solely by the GS/OAS and GIMI for certificate courses offered by GIMI, under PAEC (“OAS-GIMI Scholarship”).

2. Article 2.1. is hereby amended to read in its entirety as follows:

The GIMI shall offer its online certificate course *Gestión en Sistemas de Salud en Tiempos de Crisis* in Spanish to those candidates from OAS and PAHO Member States selected for the OAS-GIMI-PAHO Scholarship (“OAS-GIMI-PAHO Scholarship Recipients”) from July 12, 2021, and its online certificate courses *Tourism in the Post Covid 19 Era – from Crisis to Opportunity*, in English, and *Gestión de Proyectos*, in Spanish, to those candidates from OAS Member States selected for the OAS-GIMI Scholarship (“OAS-GIMI Scholarship Recipients”) from July 12, 2021. The GIMI shall customize the courses for OAS-GIMI-PAHO recipients, which will include a project management workshop and an impact assessment (monitoring and evaluation component) for one year following the end of the course.

3. Article 2.2. is hereby amended to read in its entirety as follows:

Candidates must apply for the OAS-GIMI-PAHO Scholarship and OAS-GIMI Scholarship by submitting their application to the GS/OAS, which will be reviewed by an ad-hoc scholarship selection committee that consists of representatives of each relevant Party, in accordance with Article 4.4 of this Agreement. The deadline to apply for the OAS-GIMI-PAHO Scholarship and OAS-GIMI Scholarship is June 17, 2021. All Scholarship Recipients will be notified of the OAS-GIMI-PAHO Scholarship and OAS-GIMI Scholarship offer by the GS/OAS. All Scholarship Recipients will be able to register for the courses through GIMI after being notified of selection.

4. Article 3.1. is hereby amended to read in its entirety as follows:

The GIMI shall reduce its tuition fee for all Scholarship Recipients as follows:

- For the course *Gestión en Sistemas de Salud en Tiempos de Crisis*, tuition fees shall be reduced from USD 1,200 to USD 975 per OAS-GIMI-PAHO Scholarship Recipient for 25 OAS-GIMI-PAHO Scholarship Recipients;
- For the course *Tourism in the Post Covid 19 Era – from Crisis to Opportunity*, tuition fees shall be reduced from USD 745 to USD 550 per OAS-GIMI Scholarship Recipient for 25 OAS-GIMI Scholarship Recipients; and
- For the course *Gestión de Proyectos*, tuition shall be reduced from 655 to USD 500 per OAS-GIMI Scholarship Recipient for 20 OAS-GIMI Scholarship Recipients.

5. Article 3.2. is hereby amended to read in its entirety as follows:

The GS/OAS shall pay GIMI a total of USD 33,500, which the GIMI shall apply towards all Scholarship Recipients' tuition cost at GIMI. The tuition cost will be paid directly to GIMI, upon submission of receipt to GS/OAS listing the Scholarships Recipients' name and specific course. The GIMI shall apply the amount received from the GS/OAS to the Scholarship Recipient's GIMI system accounts upon registration at GIMI, as follows:

- For 10 OAS-GIMI-PAHO Scholarship Recipients enrolled in the course *Gestión en Sistemas de Salud en Tiempos de Crisis* and selected by the Parties, USD 975 shall be applied towards the GIMI accounts of each OAS-GIMI-PAHO Scholarship Recipient, for a total of USD 9,750.
- For 25 OAS-GIMI Scholarship Recipients enrolled in the course *Tourism in the Post Covid 19 Era – from Crisis to Opportunity*, USD 550 shall be applied towards the GIMI accounts of each OAS-GIMI Scholarship Recipient, for a total of USD 13,750.
- For 20 OAS-GIMI Scholarship Recipients enrolled in the course *Gestión de Proyectos*, USD 500 shall be applied towards the GIMI accounts of each OAS-GIMI Scholarship Recipient, for a total of USD 10,000.

The GS/OAS and GIMI may reassign the above distribution based on the number of qualified applications received for scholarship consideration per course mentioned.

6. Article 3.3. is hereby amended to read in its entirety as follows:

PAHO, through its Human Resources for Health Unit/Health Systems and Services Department, shall pay GIMI USD 975 per OAS-GIMI-PAHO Scholarship Recipient for 15 OAS-GIMI-PAHO Scholarship Recipients enrolled in the *Gestión en Sistemas de Salud en Tiempos de Crisis* course taught in Spanish, for a total amount of no more than USD 14,625, to be applied towards each OAS-GIMI-PAHO Scholarship Recipient's tuition costs at GIMI. This amount will be paid directly to GIMI, upon submission of receipt to PAHO listing the OAS-GIMI-PAHO Scholarship Recipients'

name and specific course. The GIMI shall apply the amount received from the PAHO to the OAS-GIMI-PAHO Scholarship Recipient's GIMI account upon registration at GIMI.

7. Article 3.4. is hereby amended to read in its entirety as follows:

Neither GIMI, PAHO, nor GS/OAS shall provide funds to any Scholarship Recipients for any additional costs and fees not covered under Articles 3.1, 3.2, and 3.3 of this Agreement, including but not limited to books and materials and any additional costs that are not included in the OAS-GIMI-PAHO Scholarship or the OAS-GIMI Scholarship.

8. Article 3.5. is hereby amended to read in its entirety as follows:

The OAS-GIMI-PAHO Scholarship and the OAS-GIMI Scholarship announcements shall indicate that expenses listed under Article 3.4 above are the sole and exclusive responsibility of Scholarship Recipients.

9. Article 4.2.1. is hereby amended to read in its entirety as follows:

To receive this payment, GIMI shall submit the respective invoices no later than July 30, 2021, to the GS/OAS, with electronic copies to Nichole Duncan of DHDEE at nduncan@oas.org and Yurismay Flores of the SEDI Administrative Management Section at yflores@oas.org; and to PAHO to Karen Gladbach at gladbach@paho.org.

10. Article 4.8. is hereby amended to read in its entirety as follows:

The GS/OAS, through the DHDEE, shall notify each Scholarship Recipient that he/she is subject to and is expected to comply with the GIMI policies, provisions, and general practices in accordance with the "Scholarship Acceptance Form" signed by the Scholarship Recipient as a condition imposed by GS/OAS for receiving the OAS-GIMI-PAHO Scholarship and the OAS-GIMI Scholarship.

11. Article 9.2. is hereby amended to read in its entirety as follows:


This Agreement shall enter into force on the date of the last signature by the authorized representatives of the Parties and shall remain in force until December 31, 2023, subject to Article 9.4 of the Agreement.

12. All terms and conditions of the Agreement that are not inconsistent with this Amendment shall remain in full force and effect.

13. This Amendment shall be attached as an Annex to the Agreement and shall be read as one document with the same legal effect.


