#### TERMINATION AGREEMENT

- 1.1 Pursuant to Article X of the Memorandum of Understanding (MOU) between the General Secretariat of the Organization of American States (GS/OAS), through the Executive Secretariat for Integral Development (SEDI), and the Young Americas Business Trust (YABT) concerning the execution of activities under the program "The OAS Private Sector Forum and the E-SIME Program" signed on August 10, 2010 and the subsequent amendments to the MOU, the duly authorized representatives of the Parties agree to terminate the MOU, effective January 20, 2020 given that the activities to be implemented as planned in the Twenty-Sixth Articles of Amendment will no longer take place as of January 20, 2020. They further agree to the following:
- 1.2 In the implementation of the activities under the MOU, the administrative costs including a \$2,000 dollar pending invoice, totaled \$7,375.00 (See Annex II) of the \$40,750.00 provided in the Twenty-Sixth Articles of Amendment from January 1 to January 19, 2020.
- 1.3 Within 15 days of the signing of this Termination Agreement, YABT will make available to GS/OAS the amount of \$33,375.00, which is the unspent portion of the GS/OAS contribution, as provided for in Article 10.5 of the MCU. The GS/OAS information for receiving a wire transfer is attached in Annex I.
- 1.4 This Termination Agreement has been agreed upon in writing by the authorized representatives of the Parties and transmitted by electronic mail as provided for in the MOU in Articles 8.2 and 10.1.
