WHAT IS THE SOCIAL DEVELOPMENT FUND?

A fund created to finance the activities designed by the Ministers and High Authorities of Social Development - Resolutions AG/RES. 2039 (XLIX-O/19) of June 27, 2019 and AG/RES. 2988 (LII-O/22) of October 7, 2022 the OAS General Assembly.

WHO CAN CONTRIBUTE TO THIS FUND?

OAS Member States, Permanent Observer States, and other Member States of the United Nations, as well as individuals and entities, whether public or private, national or international, that wish to contribute to the purpose of the Fund.

WHAT CAN THIS FUND FINANCE?

The activities agreed upon by the Member States through the Ministers and High Authorities of Social Development and the Work Plan of the Inter-American Commission for Social Development (CIDES, for its acronym in Spanish).

The activities in the priority areas will be carried out through:



The development of projects or programs at the national or regional level.



Capacity building:

The strengthening of capacities in the institutions in charge of social policies through seminars, courses and virtual workshops, conferences.



The strengthening of social policies through horizontal technical cooperation projects (peer to peer learning) aimed at strengthening the design, implementation, monitoring and evaluation of these policies in the Member States.

WHO MANAGES THE FUND?

The General Secretariat of the OAS through the Department of Social Inclusion, which serves as the Technical Secretariat of the Ministerial Meetings on Social Development.

HOW CAN I CONTRIBUTE TO THE FUND?

Sending a verbal note and/or letter attaching the information of the bank transfer or check. The communication must be addressed to the Secretariat for Administration and Finance of the Organization of American States with a copy to the Secretariat for Access to Rights and Equity and must contain the following information: Project name (Social Development Fund), project number (DSI-SD-FUND) and beneficiary area (Department of Social Inclusion or DIS-SADYE).
