QUESTIONNAIRE

REGARDING THE PROVISION OF THE INTER-AMERICAN CONVENTION AGAINST CORRUPTION SELECTED FOR REVIEW IN THE FOURTH ROUND AND FOR FOLLOW-UP OF THE RECOMMENDATIONS FORMULATED IN THE FIRST ROUND*

INTRODUCTION

The Report of Buenos Aires^{2/} and the Rules of Procedure and Other Provisions^{3/} of the Committee of Experts of the Mechanism for Follow-up on the Implementation of the Inter-American Convention against Corruption (hereinafter, as applicable, Report of Buenos Aires, Rules of Procedure, Committee, Mechanism, and Convention) provide that the Committee shall adopt a questionnaire on the selected provisions to be reviewed in each round.

At its Eighteenth Meeting, held on March 21 to 25, 2011, the Committee agreed on the comprehensive review of "oversight bodies, with a view to implementing modern mechanisms for preventing, detecting, punishing, and eradicating corrupt acts" (Article III, paragraph 9, of the Convention) as the topic for review during the Fourth Round. In addition, in compliance with recommendation 9(a) of the Third Meeting of the Conference of States Parties of the MESICIC⁴, it was agreed that in the Fourth Round, "with regard to the follow-up of recommendations, [the Committee will concentrate] exclusively on the follow-up of the recommendations formulated to the States Parties in their corresponding reports of the First Round and which were deemed to require additional attention in the reports of the Second and Third Rounds, including the consideration of any new and relevant information or developments that would allow the Committee to determine the continued validity of the recommendations and measures suggested in the reports of the First Round and, with regard to those deemed still valid, to assess whether the State has given them satisfactory consideration or whether additional attention is required or, when applicable, to restate or reformulate them."

Furthermore, Article 29 of the *Rules of Procedure* states that the information on the implementation of the recommendations is to be presented by each State Party using the standard format provided by the Committee as an Annex to the Questionnaire. It also establishes that "with respect to the implementation of recommendations, the State Party shall refer to any difficulties that may have arisen in the process," and that "should it deem it to be appropriate, the State Party may also identify the domestic agencies that have participated in implementing the recommendations, as well as identify specific technical assistance or other needs connected with the implementation of the recommendations."

Pursuant to the above, this document contains the questions that comprise the questionnaire adopted by the Committee.

The responses given to the questionnaire shall be reviewed in accordance with the methodology adopted by the Committee, which may be consulted on the *Anticorruption Portal of the Americas* at www.oas.org/juridico/english/mesicic_rounds.htm.

In accordance with Article 21 of the *Rules of Procedure*, the State Party shall return its response to the questionnaire through its Permanent Mission to the OAS, in an electronic format, along with the corresponding supporting documents, within the deadline established by the Committee.

SECTION I

OVERSIGHT BODIES, WITH A VIEW TO IMPLEMENTING MODERN MECHANISMS FOR PREVENTING, DETECTING, PUNISHING, AND ERADICATING CORRUPT ACTS (ARTICLE III, PARAGRAPH 9, OF THE CONVENTION)

- A) Indicate the oversight bodies in your country that would be relevant for preventing, detecting, punishing, and eradicating corrupt acts, and briefly state the assigned purpose of each.
 - Auditor General
 - Director of Public Prosecutions
 - Public Service Commission
 - Integrity Commission
- B) Then select 4 or 5 of these oversight bodies, bearing in mind their institutional importance and that the functions they are assigned should cover one or more of the objectives of preventing, detecting, punishing, and eradicating corrupt acts that trigger disciplinary; administrative; financial or civil; and criminal responsibility.

By email dated 19th April, 2012, the Department of Legal Cooperation, Organization of American States suggested that the following oversight bodies be of focus:

- Auditor General
- Director of Public Prosecutions
- Public Service Commission
- Integrity Commission
- Judicial and Legal Services Commission. (completed questionnaire outstanding)

By email dated 1st June, 2012, the Department of Legal Cooperation, Organization of American States advised that it was not required that the questions which were not applicable to the oversight bodies be answered unless the

function of the particular body requires that answers be so provided.

The Office of Auditor General of Trinidad and Tobago is responsible for the audit of financial statements of Government Ministries/Departments/Statutory Boards and Similar Bodies. Section 116 (2) of the Constitution of the Republic of Trinidad and Tobago refers. The Auditor general is also required to report on any instances of waste and extravagance. Section 9 (2) © of the Exchequer and Audit Act, Chapter 69:01 is relevant. Under section 116 (3) of the Constitution, the Auditor General is empowered to audit the accounts of enterprises that are owned or controlled, by or on behalf of the State.

The Auditor general is appointed by the President of the Country in consultation with the Prime Minister and the Leader of the Opposition. (Section 117 (1) of the Constitution refers). Section 116 (6) of the Constitution states that "In the exercise of his functions under this Constitution, the Auditor General shall not be subject to the direction or control of any other person or authority."

The Auditor General.

The Office of the Director of Public Prosecutions is fully responsible for all criminal prosecutions in the country. It is headed by the Director of Public Prosecutions.

ii. The scope of their functions, indicating whether any exceptions to it exist.

The Auditor general conducts financial audits. Value for Money/Comprehensive/ Performance audits are also conducted under section 9 (2) © of the Exchequer and Audit Act.

The Auditor General.

By virtue of section 90 (1) of the Constitution, the Director has the power to institute and undertake criminal proceedings against any person before any court other than military court martial in respect of any offence in law to take over and continue any criminal proceedings that may have been initiated by any other person or authority (e.g. customs, board of inland revenue); to discontinue at any stage before judgment is delivered any such criminal

proceedings instituted by himself or any other person or authority. The post is established by the Constitution and it is almost free from control. The exercise of the powers of the DPP is subject to the responsibility of the Attorney General, which is a political office, for the "administration of legal affairs". This refers not to the conduct of prosecutions but administrative matters, such as staffing.

iii. The manner in which they adopt their decisions, indicating whether there are various agencies with jurisdiction to do so and whether they are collegiate or single-person agencies; review remedies that can be brought against the decisions adopted, both internally and with other external agencies or authorities; and the actions needed to implement or enforce those decisions.

Generally the Auditor General is responsible for making decisions affecting the Department. In some instances, Cabinet approval is required, for example, for overseas travel. In this instance, a Note is submitted to Cabinet through the Office of the Prime Minister.

The Staff of the Auditor General's Department are public officers and their appointments and promotions are subject to the Public Service Commission. The Chief Personnel Officer is responsible for setting the terms and conditions of employment.

The Office of Auditor General is a single-person agency.

The Auditor General.

The decisions to prosecute or not to prosecute is made in accordance with the law and whether the prosecution is in the public interest. Constitutionally, the Director may delegate the exercise of his powers to certain specified persons who are usually legal officers employed in the Office of the DPP. Judicial review proceedings can be initiated by the aggrieved who wish to challenge decisions of the DPP in the exercise of his powers.

iv. The manner in which their senior officers are selected, indicating whether they serve fixed terms or are freely appointed and removable, and the agencies authorized to hold them responsible for their actions and deciding on their continued tenure in those positions.

The senior officers in the Auditor General's Department are selected based on seniority.

For auditing staff, there are two levels of recruitment. The first level is Audit Examiner Assistant I which requires five (5) Ordinary Level passes, including English and Mathematics. The other level of recruitment is Audit Senior which requires a full professional accountancy

qualification. Recruitment is conducted by one of the central agencies, the Service Commissions Department which is also responsible for promotions etc.

For clerical/administrative staff and Human Resource Officers, selection is based on seniority, whether the officer is at the time within the Auditor General's Department or in the wider Public Service.

Senior officers do not serve fixed terms. Officers can work until compulsory retirement at age 60 years or they can leave the Public Service voluntarily at 55 years or they can leave with permission at age 50 years. The retirement age for the Auditor General is 65 years.

Provisions relating to the removal of the Auditor General are contained in the Constitution at section 136 (7) to (11). The removal of public officers would be subject to the Public Service Commission Regulations.

Senior officers are usually promoted from within the ranks of the legal officers in the Office of the DPP, although there is nothing to prevent anyone in private practice from applying for a vacancy. The Judicial and Legal Services Commission advertises the vacancies; applications are invited; persons apply and are selected based on qualifications, training, experience, overall suitability. It is a merit-based appointment and while seniority is considered it is the overriding factor. Some legal officers are appointed on the basis of three-year contracts which are usually renewable. The DPP has some involvement, since he interviews shortlisted applicants and must submit remarks on legal officers applying for higher posts. Office holders can be removed for failing to fulfil their functions and misbehaviour in public office, including breaches of the Legal Profession Act.

v. The manner in which the human resources needed for their operations are identified, and how their personnel are selected, indicating whether they are freely appointed and removable, or whether they are selected by means of merit-based competition; if certain requirements have to be met told hold such positions; and whether their personnel are subject to a regime of disqualifications and incompatibilities and of responsibility for their actions.⁵

Where the Auditor General is of the view that additional resources are required, an approach is made to the Ministry of Public Administration who would conduct an exercise to determine the resources needed and submit their recommendations. These recommendations would be discussed with the Auditor General and agreement reached. The proposal for the increase

would then be submitted to the Cabinet for approval.

Auditing personnel at the initial recruitment level have been selected by a process which involves the advertisement of the post; the sorting of applications based on pre-set criteria; the holding of a written test and interviews.

Auditing personnel at the Audit Senior level are selected based on having attained a full professional qualification and through interviews.

Clerical/Administrative and Human Resources Staff are selected through responses to advertisements by the Public Service Commission and interviews.

Removal of staff would be subject to Public Service Commission Regulations on this matter.

Each position, whether unique to the Auditor General's Department or in the wider Public Service would have certain qualification requirements. Persons would be appointed based on their fulfilling the necessary qualification requirements

The Auditor General.

The non-professional staff is appointed through Service Commission which is responsible for staffing in the public service. The Office of the DPP is not in control of such appointments.

vi. The existence of manuals or other documents that describe the functions of their personnel, and also indicating whether regular training is given in connection with those functions.

There are Manuals however, these have not been updated for some time.

Staff are exposed to training, both in-house and by providers external to the Department.

The Auditor General.

The Code for Prosecutors which obtains in the UK is an important guide. A special Code for Magistrate's Court prosecutors has been drafted in-house and is in operation. An overall local Code for Prosecutors is being drafted but will resemble the UK code. Every post has a job description. Training is not on a regular basis but in-house training workshops are held and legal officers are nominated to attend overseas conferences and workshops.

vii. The existence of documented procedures for performing their tasks, or of manuals or guides dealing with those duties; institutional strengthening or quality improvement

actions implemented; and the implementation of systems or modern technologies to facilitate their work.

The auditing staff use approved programmes of work to perform their tasks.

Other staff are guided by Manuals/Guides produced by the Personnel Department and the Public Service Commission (Director of Personnel Administration) as well as various Circulars, Financial Instructions, Financial Regulations and other documented procedures.

A process is currently in train to provide institutional strengthening for the Auditor General's Department.

One of the auditing Divisions uses standard working papers for the conduct of audits.

The Auditor General.

Every member of the department has a job description. Modern technology and systems to assist in performance of duties are lacking. A re-structuring and re-tooling exercise is under way.

viii. The manner in which the general public is provided with information about their objectives and functions, is informed of the procedures established for the performance of their functions, and is given guidance about how to carry out proceedings before them.

The Auditor General does not interact with the general public.

The Auditor General.

The Ministry of the Attorney General website (www.ag.gov.tt) briefly states the function of the Office of the OPP. Such public information policies and strategies are lacking.

ix. The mechanisms for internal control and for dealing with claims, complaints, or allegations related to the pursuit of their objectives and to the performance of their personnel.

Persons would address correspondence to the Auditor General on these matters.

The Auditor General.

Legal officers are grouped under a senior prosecutor who monitors their progress and responds to specific issues and ultimately reports to the DPP.

Office of the Director of Public Prosecutions

x. The manner in which the budgetary resources needed for their operations are ensured.

Provision is made in the Estimates of Expenditure for funds to be utilized by the Department for the carrying out of the Department's operations. The Department is subject to the financial regulations and other financial directives for accessing funds and reporting on expenditure.

The Auditor General.

The budgetary resources are controlled by the Ministry of the Attorney General.

Office of the Director of Public Prosecutions

xi. As appropriate, the coordination mechanisms for harmonizing their functions with those of other oversight agencies or public authorities, and for securing the support of other authorities and the public for full compliance with their duties.

The Exchequer and Audit Act makes provision for the Auditor General to obtain legal opinions from the Attorney General.

The Auditor General.

Greater coordination is needed. Multidisciplinary teams incorporating prosecutors, police, customs, board of inland revenue hold regular meetings to discuss investigations and criminal prosecutions.

xii. Accountability mechanisms applicable to the performance of their duties; the way in which the information needed for that is gathered and processed; and the information issued for that purpose, 6/ and the way in which it is made public and how members of the public may access it.

Ministries/Departments are required to submit annual reports in accordance with section 66D of the Constitution.

Annual reports are submitted and the Chief Justice in his annual address at the opening of the Law Term summarises the achievements and challenges of the criminal justice system. The annual reports with greater details are published electronically (www.ttlawcourts.org) and include such data as number of indictments filed, matters prosecuted; manner of disposal.

Following the same structure as the First Round country report, the Secretariat shall transcribe each of the recommendations formulated for the country in question during the round that the Committee deemed to require additional attention in the Second and Third Round reports. Co-ordination among state agencies/holistic investigations: police customs, board of inland revenue, financial investigation unit, prosecution services. Topic: Investigation and prosecuting money laundering.

Various agencies such as the Customs department and Board of Inland revenue can lay their own charges but investigations should be holistic and embrace police, prosecution services, other stakeholders. Charging practice should be with a view to selecting the charge that best reflects the seriousness of the offence; that best practice indicates a reasonable prospect of obtaining a conviction.

Traditionally, there has been too fragmented an approach. Individual departments conduct own investigation and lay charges. But such may not be wide ranging enough to capture all offenders, particularly highly placed officials. Offences pertaining to Value Added Tax, for example, are summary offences and such charges would not reflect the gravity of the situation when the facts may indicate a wider money-laundering operation. Also, when drug-trafficking "mules" or couriers are held at the Airport, both Customs and police can charge but there is often disagreement about who should actually charge or prosecute the offence. The wider picture, which may involve corruption and persons of interest, may be lost.
